4. Discussion of Motions

a. Melvin Gottlieb: #08-03169-I-3 (DuPage)

Appellant originally filed with PTAB on 4-20-09. A total of 90 days has been granted for the submission of evidence. Appellant is requesting an additional 60 day extension of time to file supporting documentation.

b. Ken & Julie Cramer: #08-04018-R-1 (DuPage)

Appellant originally filed with PTAB on 4-23-09. A total of 180 days has been granted for the submission of evidence. Appellant is requesting an additional extension of time of 90 days after the decision date of appellants' 2007 pending appeal to file supporting documentation. The 2007 decision is on the December agenda.

c. Burbank Shopping Center: #08-25702-C-3 (Cook – Stickney)

Appellant originally filed with PTAB on 8-3-09. A total of 120 days has been granted for the submission of evidence. Appellant is requesting an additional extension of time to file supporting documentation.

d. Greenmount Retail Center, LLC: #08-06359-C-2 (St. Clair)

St. Clair County Board of Review was notified of the above appeal on 8-6-10. A total of 90 days has been granted for the submission of evidence. The BOR is requesting an additional extension of time as they are in the process of signing a stipulated agreement between the appellant and the taxing districts.

e. John & Rebecca Telford: #08-01569-R-1 (Macon)

Macon County Board of Review was notified of the above appeal on 8-25-10. A total of 90 days has been granted for the submission of evidence. The BOR is requesting an additional 30 days to provide evidence due to short staffing and current BOR work.

f. Home Depot Warehouse: #08-00546-C-3 (Will)

Will County Board of Review was notified of the above appeal on 6-16-10. A total of 120 days has been granted for the submission of evidence. The BOR is requesting an additional extension until the 2010 assessment for the subject property is settled between the BOR and the appellant. Once the assessment is finalized, appellant will withdraw the 2008 and 2009 filings with the PTAB. Letter from appellant confirms this.

Intervenor is requesting an additional 90 day extension of time to file evidence and/or a brief for each file. The intervenor has been in settlement discussions with the taxpayer and is in consultation with an appraiser.

Presently intervenor is in consultation with an appraiser.

bb. KMART #7289: #08-26383-C-3 (Cook – Bloom)

Intervenor, Steger S.D. #194, originally filed with PTAB on 5-27-10. A total of 90 days has been granted for the submission of evidence. Intervenor is requesting an additional 90 day extension of time to file evidence and/or a brief. Request further states that intervenor is in consultation with an appraiser as to a need for an appraisal on this matter but appraiser has not yet completed his analysis. Letter from appraiser is not included with request.

Intervenor, Village of Alsip, originally filed with PTAB on 6-8-10. A total of 90 days has been granted for the submission of evidence. Intervenor is requesting an additional 90 day extension of time. Letter from appraiser (9-17-10), states that due to unforeseen circumstances in his office, he is unable to complete the appraisal by the deadline set by PTAB.

Intervenor, Village of Alsip, originally filed with PTAB on 6-8-10. A total of 90 days has been granted for the submission of evidence. Intervenor is requesting an additional 90 day extension of time for filing of evidence and/or brief. Request further states that intervenor is in consultation with an appraiser as to the need for an appraisal but analysis is not yet completed.

ee. Lost Continent Development, LLC: #08-28591-C-2 (Cook – Bloom)

Intervenor, Sauk Village C.C.S.D. #151, originally filed with PTAB on 4-27-10. A total of 120 days has been granted for the submission of evidence. Intervenor is requesting an additional 90 days to file evidence and/or a brief. Request further states that intervenor is in consultation with an appraiser as to the need for an appraisal but analysis is not yet completed.

Intervenor, S.D. #206, originally filed with PTAB on 3-17-10. A total of 150 days has been granted for the submission of evidence. Intervenor is requesting an additional 90 days for the completion of an appraisal. Letter from appraiser (11-16-10) confirms that he has been engaged to perform a market value appraisal but due to current commitments and involvement in a number of court hearings and depositions, a 90 day extension of time is required.

ff. Target Store Corporation: #08-29290-C-1 (Cook – Thornton)

Intervenor, S.D. #157, originally filed with PTAB on 7-5-10. A total of 90 days has been granted for the submission of evidence. Intervenor is requesting an additional 90 day extension of time for the completion of an appraisal. Letter from appraiser (11-9-10) included with request. Appraiser states that due to current commitments and involvement with a number of court hearings and depositions, additional time is required to complete assignment.

gg. Tri Sons, LLC: #08-27746-I-2 (Cook – Bloom)

Intervenors, S.D. #167 and S.D. #206, originally filed with PTAB on 7-12-10. A total of 90 days has been granted for the submission of evidence. Intervenors are requesting an additional 90 day extension of time for the completion of an appraisal. Letter from appraiser (11-9-10) included with request. Appraiser states that due to current commitments and involvement with a number of court hearings and depositions, additional time is required to complete assignment.

Appraiser states that due to current commitments and involvement with a number of court hearings and depositions, additional time is required to complete assignment.

Intervenors, S.D. #227 and S.D. #159, originally filed with PTAB on 3-15-10. A total of 90 days has been granted for the submission of evidence. Appraiser states that due to current commitments and involvement with a number of court hearings and depositions, additional time is required to complete assignment.

jj. UGN, Inc.: #08-27500-I-3 (Cook – Bloom) AT&T Services, Inc.: #08-27501-C-3 (Cook – Bloom)

In each of the above appeals, intervenor, S.D. #206, originally filed with PTAB on 7-12-10. A total of 90 days has been granted for the submission of evidence. Intervenor is requesting an additional 90 day extension of time for the completion of an appraisal. Letter from appraiser (11-9-10) included with request. Appraiser states that due to current commitments and involvement with a number of court hearings and depositions, additional time is required to complete assignment.

kk. Ford Motor Company: #08-25378-I-3 (Cook – Bloom)

Intervenor, S.D. #206, originally filed with PTAB on 3-24-10. A total of 150 days has been granted for the submission of evidence. Intervenor is requesting an additional 90 day extension of time for the completion of an appraisal. Letter from appraiser (11-16-10) included with request. Appraiser states that due to current commitments and involvement with a number of court hearings and depositions, additional time is required to complete assignment.

11. Bernard Hammer: #08-23354-R-1 (Cook – N. Trier)

Appellant originally filed with PTAB on 6-1-09. A total of 120 days was granted for the submission of evidence with the latest being a Final Extension expiring on 6-12-10. Additional evidence was not received by PTAB and the file was dismissed for insufficient evidence on 11-15-10. A reinstatement request submitted by appellant per fax dated 11-16-10, states that the dismissal is a mistake by PTAB and that additional evidence in the form of a legal argument was submitted by appellant. A date when this evidence was submitted by appellant was not noted in reinstatement request. Appellant included a copy of the purported evidence with the faxed request.

mm. Charles Givines: #08-29272-R-1 (Cook – Thornton)

Appellant originally filed with PTAB on 8-29-09. A total of 90 days was granted for the submission of evidence. This extension expired 7-6-10. Appellant timely filed additional evidence within this time period. A review of the file determined that evidence submitted was not sufficient to go forward and the appeal was dismissed on 8-3-10. Appellant is requesting a reinstatement of the appeal per 10-22-10 correspondence. Appellant provided a copy of an appraisal that was not previously submitted to PTAB along with the reinstatement request.

nn. Deborah Brasic: #08-00854-R-1 (Lake)

Appellant originally filed with PTAB on 3-4-09. A total of 90 days was granted for the submission of evidence. The latest extension expired on 1-24-10 with no additional evidence provided. Appeal was dismissed on 10-22-10 for insufficient evidence. Appellant is requesting a reinstatement of the appeal per 11-8-10 correspondence. Appellant states that due to circumstances (divorce, expiration of unemployment compensation, death of son, and foreclosure) evidence was not submitted.

oo. Karen Streit: #08-00412-R-1 (Will)

Appellant originally filed with PTAB on 2-12-09. A total of 90 days was granted for the submission of evidence with the latest expiring on 12-23-09 with no additional information submitted. Appeal was dismissed on 10-25-10 for insufficient evidence. Appellant is requesting a reinstatement of the appeal per 11-10-10 correspondence. Appellant submitted evidence with reinstatement request along with a request to consolidate this 2008 appeal with appellant's pending 2007 PTAB appeal.

pp. John Zajicek: #08-03041-R-1 (Stephenson)

Appellant originally filed with PTAB on 5-29-09. A review of the appeal indicated that a copy of the required Board of Review original decision was omitted from filing. A return checklist and notification letter was mailed to appellant on 6-24-10 with a 30 day extension for the submission of this required BOR decision. This decision was not returned by appellant and appeal was dismissed on 10-27-10 for lack of jurisdiction. Appellant is requesting a reinstatement of the appeal per 11-5-10 correspondence. Request states that appellant did not receive this 6-24-10 letter and checklist. Appellant requests that PTAB reinstate appeal and send a new extension letter with checklist. Our letter dated 6-24-10 was not returned for any reason.

qq. Meijer, Inc.: #08-00230-C-3 (Will)

Appellant originally filed with PTAB on 2-20-09. A total of 90 days was granted for the submission of evidence with the latest extension expiring on 12-31-09. Evidence from the appellant was not received and the appeal was dismissed on 10-25-10 for insufficient evidence. Appellant is requesting a reinstatement of the appeal per 11-1-10 correspondence. Appellant submits an appraisal with this request and maintains that prior extension letter was not received, only the dismissal letter. Mail has not been returned for this file for any reason.

rr. Neil & Kimberly Weintraub: #08-06762-R-1 (Lake)

Appellant originally filed with PTAB on 4-15-09. A total of 90 days was granted for the submission of evidence with the latest extension expiring on 4-26-10. Evidence from the appellant was not received and the appeal was dismissed on 10-25-10 for insufficient evidence. Per correspondence dated 11-1-10, appellant has provided PTAB with two copies of an appraisal for the subject property.

ss. Trenton Village, LLC: #08-05998-C-3 (Clinton)

Appellant originally filed with PTAB on 7-14-09. A total of 90 days was granted for the submission of evidence with the latest extension expiring 8-8-10. Additional evidence was not submitted and appeal was dismissed on 10-25-10 for insufficient evidence. Appellant has filed a Motion to Reconsider dated 11-23-10 along with a corrected resubmitted petition.

tt. Richard Conner: #08-05631-R-1 (Madison)

Appellant originally filed with PTAB on 5-7-09. Appellant requested with original filing that an extension of 60 days was needed for a new appraisal. An extension of 90 days was granted for the submission of evidence. This extension expired on 6-7-10 without the receipt of any additional evidence from the appellant. Appeal was dismissed on 10-25-10 for insufficient evidence. Per 11-5-10 correspondence, appellant is requesting the appeal be reinstated. Request states that a finished appraisal was mailed to PTAB in late May or early June of 2009 for consideration. Appraisal was mailed to PTAB without a docket number indicated anywhere on mailing. PTAB mail log does not indicate the receipt of evidence for this docket number. A copy of the appraisal (completed 5-27-09) is attached to the reinstatement request. This is a multiplier appeal so PTAB has limited jurisdiction.

uu. Imperial Realty: #06-29772-C-3 (Cook – Jefferson)

Subpoenas requested for the following:

Department of Revenue compelling the attendance at the hearing of a person from the Department with full knowledge of the methodology employed in preparing the studies in order to establish the taxpayer's contention that the studies provide competent evidence of the correct ratio to employ in determining the "correct assessment" for the Subject Property.

Cook County Board of Review to establish on the record that it has an established and known policy of setting class 2 assessments at 10%.

Recommendation: Deny request for issuance of subpoenas. PTAB rules provide for the use of the ordinance level of assessment in Cook County commercial property appeals when a market value finding is made (See 86 III.Admin.Code 1910.50 (c)(3)).
