In each of the above appeals, the Appellant originally filed with PTAB on 6-22-10. A total of 90-days has been granted for the submission of evidence. Each Appellant is requesting an additional 30-day extension for the submission of additional information.

In each of the above appeals, the Appellant originally filed with PTAB on 7-1-10. A total of 120-days has been granted for the submission of evidence. Each Appellant is requesting an additional 90-day extension to submit documentation.

Appellant originally filed with PTAB on 4-12-11. A total of 90 days has been granted for the submission of evidence. Appellant is requesting an additional 90-day extension due to a heavy caseload at the Board of Review level and at PTAB.

- h. Joey Panfil: #09-31172-R-1 (Cook – West Chicago)

Appellant originally filed with PTAB on 10-1-10. A total of 90 days has been granted for the submission of evidence. Appellant is requesting an additional 75-day extension to file supporting documentation.

- i. Kohl's Department Stores, Inc.: #09-04151-C-3 (DuPage)

Intervenor, Wheaton-Warrenville CUSD #200, originally filed with PTAB on 4-25-11. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 30-day extension to continue the preparation of valuation and/or legal evidence.

- j. Sunrise Senior Living, Inc.: #09-03309-C-3 (DuPage)
Wintrust Financial Corp.: #09-04826-C-3 (DuPage)

In each of the above appeals, Intervenor, Glen Ellyn S.D. #41 and Glenbard THSD #87, originally filed with PTAB on 4-18-11. A total of 90-days has been granted for the submission of evidence. Each Intervenor is requesting an additional 30-day extension to continue the preparation of valuation and/or legal evidence.

- k. Robert Firlit: #09-21485-C-2 (Cook – Palos)
Ponds of Palos Townhouse Assoc.: #09-25824-R-3 (Cook – Palos)

In each of the above appeals, Intervenor, School District #118, originally filed with PTAB on 5-2-11. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional extension of time for the submission of an appraisal. Letter from appraiser (10-13-11) is included with each request. Appraiser states that he is unable to complete the appraisal by the deadline set by PTAB and is requesting 60-days for completion.

- l. Doyle Development, LLC: #09-03080-C-3 (DuPage)

Intervenor, Wheaton-Warrenville CUSD, originally filed with PTAB on 4-25-11. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 30-day extension to prepare valuation and/or legal evidence.

- m. Valspar: #08-02291-I-3 (Kankakee)

Intervenors, City of Kankakee and Kankakee S.D. #111, originally filed with PTAB on 11-18-10. A total of 90-days has been granted for the submission of evidence. On 9-30-11, both Intervenors were defaulted after a review of the file determined evidence and/or an extension request was not submitted. Intervenors are requesting the default be rescinded and an extension of time granted by PTAB. The request (10-11-11) states that an extension letter was timely mailed to PTAB on 5-3-11 and tracking information is included.

- n. Steve Brown: #08-29376-C-2 (Cook – Thornton)
Private Restaurant Partners, LLC: #08-28880-C-2 (Cook – Thornton)

In each of the above appeals, Intervenor, Thornton Township H.S.D. #205, originally filed with PTAB on 12-30-10. A total of 120-days has been granted for the submission of evidence with the latest being a **Final-Extension** with a due date of 8-10-11(Wednesday). Intervenor hand delivered evidence to the Des Plaines Office on 8-11-11(Thursday) for the above docket numbers. A review determined the evidence was one day late. Intervenor is requesting the default be rescinded per 10-11-11 correspondence. Intervenor acknowledges the evidence was hand delivered on 8-11-11.

- o. Val Sklarov: #08-05068-C-3 (DuPage)

The DuPage County Board of Review (BOR) was notified of the above appeal on 10-13-10. The BOR was granted 90-days to submit evidence with a due date of 1-11-11. A review of the file indicated that evidence was not submitted and the BOR was defaulted on 9-23-11. On 9-30-11, the BOR faxed a copy of Notes on Appeal for each parcel number (2) with a signed date of 7-27-11. This is over 6 months past the extension due date. There is no indication that this evidence and/or an extension request was ever mailed to PTAB. The BOR is requesting the default be rescinded.

- p. Scott Wilmouth: #09-00825-R-1 (Jackson)

The Jackson County Board of Review (BOR) was notified of the above filing on 1-13-11. The BOR was granted 90-days to submit evidence with a due date of 4-13-11. A review of the file indicated that evidence was not submitted and the BOR was defaulted on 9-27-11. On 10-11-11, the BOR submitted a request for the default to be rescinded and a copy of evidence dated 4-4-11. The request states that this evidence be taken into consideration and that it was submitted timely on 4-4-11. The submitted information includes rebuttal to the Appellant's appeal to PTAB and a copy of the Appellant's property record card. The required Notes on Appeal is not part of the submission.

- q. Kevin Fullriede: #09-05394-R-1 (LaSalle)

LaSalle County Board of Review (BOR) was notified of the above filing on 3-8-11. The BOR was granted 90-days to submit evidence with a due date of 6-6-11. A proposed stipulation was received from the BOR on 6-3-11 and was forwarded to the Appellant on 7-28-11. This proposed stipulation was rejected by the Appellant. Per hearing officer review, the BOR received a copy of the rejection and was found in default for insufficient evidence on 10-4-11. Per 10-7-11 correspondence, the BOR is requesting that the default be rescinded and have included 2 copies of an appraisal for the subject property to be accepted into the file. Request states that the BOR sent in documentation for several appeals at the same time and may have inadvertently omitted the appraisal or it was separated.

- r. Peter Niemeyer: #10-00630-R-1 (Will)

Appellant filed a 2010 Residential Appeal with PTAB on 2-14-11. The cover sheet attached to appeal indicates that the filing is from a 1-19-11 decision of the Will County BOR dismissing the 2010 appeal for failing to appear at the BOR hearing. The Appellant states that the notice of the hearing was never received by either the attorney or the owner of the property.

- s. Daniel & Sharon Serafini: #09-06179-R-1 (St. Clair)

Appellant filed with PTAB from a Final Decision of the St. Clair County Board of Review dated 7-5-11. The clearly printed postmark on the Appellant's filing is 8-5-11. The 30-day deadline to file expired on 8-4-11 (Thursday). Appellant filed one (1) day late. Appeal was dismissed on 10-5-11 for lack of jurisdiction. Per

letter dated, 10-18-11, Appellant is requesting the above appeal be reinstated and state that the appeal was mailed on 7-30-11, well within the 30-day notice period.

- t. Randy Barinholtz: #09-03621-R-1 (Lake)

Appellant originally filed with PTAB on 4-8-10 and requested an extension of time to submit evidence. The Appellant was notified by PTAB on 1-25-11 granting a 90-day extension of time. The Appellant's appeal was dismissed on 9-19-11 for lack of evidence. Appellant is requesting a reinstatement of the appeal per 10-14-11 correspondence. Request states that the Appellant was under the impression there would be a stipulation between the Lake County Board of Review (BOR) and himself. The BOR denied this and advised the Appellant to submit evidence to the PTAB. Appellant further states that he did not receive the extension letter sent by PTAB on 1-25-11 and that perhaps it was delivered to the incorrect mailbox or vandalized. A new address, including a post office box, has been forwarded to PTAB. Appellant's file indicates that the extension letter was mailed to the address on the petition and was not returned to PTAB for incorrect address.

- u. Willows of Wheaton: #09-03107-C-3 (DuPage)

Appellant originally filed with PTAB on 4-2-10. Appeal was reviewed and found to be incomplete. An incomplete checklist and notification letter was mailed to the Appellant on 1-25-11 with a 30-day extension to return the required information. This extension expired on 2-24-11 and the required evidence was not returned. On 7-14-11, five months after extension expired, Appellant returned the required information followed by a signed stipulation between the Appellant and the DuPage County Board of Review on 7-18-11. The appeal was dismissed on 10-6-11 for late filing of evidence. Per letter dated 10-18-11, Appellant is requesting the above appeal be reinstated and the evidence/stipulation be accepted into the file.

- v. Hua Liu: #09-03321-R-1 (Kane)

Appellant originally filed with PTAB on 4-5-10. The Kane County Board of Review (BOR) was notified of the above filing on 3-3-11. The BOR submitted to PTAB a possible stipulation on 5-31-11. The Appellant was notified of this possible stipulation on 7-29-11 and granted a 30-day extension to respond if the proposed assessment was not acceptable. A rejection letter was not received/mail logged within this 30-day period and a decision was rendered using the BOR's proposed amounts on 10-21-11. Per letter dated 10-24-11, the Appellant is requesting PTAB rescind this recent decision and further states that a rejection

letter was mailed (a copy of the purported letter dated August 8, 2011 is attached with request).

w. The Marvel Group, Inc.: #09-30426-I-3 (Cook – Lake)

Appellant originally filed with PTAB on 10-1-10. An initial review of the appeal indicated that the Appellant's claim for all 4 parcels was missing and an incomplete checklist and letter was generated and mailed to the Appellant on 6-10-11 along with a 30-day extension of time to return the required information. A review of the file after this deadline prompted a dismissal letter on 9-1-11 after the Appellant failed to provide PTAB with the required information. Per letter dated 10-7-11, Appellant is requesting a reinstatement of appeal. Appellant submits with this request a copy of the Addendum to Petition that should contain Appellant's claims for all 4 parcels, it does not. Request further states that this addendum was forwarded to PTAB in a timely manner and is dated 7-7-11.

x. Maria Concialdi: #09-24243-C-1 (Cook – Jefferson)

Appellant originally filed on 8-9-10. An initial review of the file indicated that this multi-parcel appeal had inconsistencies on the provided addendum. An incomplete checklist was mailed along with a notification letter to the Appellant on 3-24-11 granting a 30-day extension to return required information. On 8-29-11 a second review of the file indicated that this required information was not returned to PTAB and the appeal was dismissed. Per correspondence dated 9-9-11, Appellant is requesting PTAB reinstate the appeal and further states that the required information was returned to our office on or about 4-7-11. A U.S. Mail receipt with an unidentifiable date is attached to the request along with a corrected addendum.

y. Roberta Nesse: #09-25499-C-1 (Cook – Elk Grove)

Appellant originally filed with PTAB on 8-27-10 along with a request for an extension of time to submit evidence. An initial review of the file indicated there were inconsistencies regarding the addendum provided for multi-parcels and the parcels listed on the Board of Review Final Notice. An incomplete checklist was mailed along with a notification letter to the Appellant on 3-29-11 granting a 30-day extension to return required information. Appeal was dismissed on 8-29-11 when a review indicated that the required information was not returned. Per correspondence dated 9-9-11, Appellant requests the above file be reinstated. Request states that correspondence from PTAB was not received until the 8-29-11 dismissal letter. Mailing address provided by Appellant is correct and there are no records of the 3-29-11 correspondence being returned to PTAB for any reason.

- z. Nick Reveliotis: #09-31957-R-1 (Cook – Proviso)

Appellant originally filed with PTAB on 10-4-10. An initial review indicated that the appeal is missing the assessment requests for each parcel number being appealed. An incomplete checklist was mailed along with a notification letter to the Appellant on 4-25-11 granting a 30-day extension to return required information. Appeal was dismissed on 9-1-11 when a review indicated that the required information was not returned. Per correspondence dated 10-3-11, Appellant requests the above appeal be reinstated and has included the parcel information PTAB required for filing.

- aa. Phil Stefani: #09-31355-C-1 (Cook – West Chicago)

Appellant originally filed with PTAB on 10-4-10. An initial review indicated that the appeal was missing the assessment requests for each parcel number being appealed. An incomplete checklist was mailed along with a notification letter to the Appellant on 5-24-11 granting a 30-day extension to return required information. Appeal was dismissed on 9-1-11 when a review indicated that the required information was not returned. Per correspondence dated 10-3-11, Appellant requests the above appeal be reinstated and has included the parcel information PTAB requires for filing.

In each of the above appeals, Counsel filed appeals on either 7-5-10 or 7-15-10. An extension request accompanied the original filing. Notification letters granting a 90-day extension were generated and mailed 3-11-11 to the address provided by Counsel. Each appeal was dismissed on 8-15-11 for lack of evidence with no response to PTAB's extension letter. Per letter dated 9-14-11, Counsel is requesting the reinstatement of each of the above appeals. Request states that the 3-11-11 notification letters from PTAB were never received and may be due to the fact that he has multiple mailing addresses. Counsel believes the deadline letters were misdirected and, given the number of cases involved and the stage of the appeal process at which this matter arises, there would be no detriment to the Cook County Board of Review if Petitioners are allowed to proceed. If the appeals are reinstated, a 60-day extension is requested.

cc. Thomas Calabrese: #08-04041-R-1 (DuPage)

Appellant originally filed with PTAB on 4-30-09. The DuPage County Board of Review (BOR) was notified of the filing on 5-3-10. Appeal was dismissed after it was determined that the PTAB did not have jurisdiction because of untimely filing. The BOR notice of final decision was dated 3-24-09 (due date 4-23-09) and the postmark of the appeal forms submitted to PTAB is 4-30-09. Appellant is requesting the dismissal be rescinded and the appeal be reinstated.
