Extension letter states that a 90-day extension request is needed for the preparation of an appraisal. Letter from appraiser (12-16-11) is attached.

Appellant submitted information to PTAB on 2-10-12 for a purported 2009 appeal. Information includes page 2 of an appeal form, a settlement statement, MLS listings, and a cover sheet stating that this information was originally mailed to PTAB on 8-26-10 along with several other complaints. Appellant stated it called the PTAB and discovered that a docket number had not been assigned for the year 2009 for this property and has now re-submitted the information. Appellant is requesting that the 2009 appeal be accepted by PTAB. Appeal submission did not include a completed Residential Appeal Form nor did it include a copy of the BOR Final Decision.

aa. National Bank & Trust Co #40-527800: 2011 Commercial Appeal

Taxpayer filed a subpoena request for a 2011 appeal that has not yet been docketed. The purpose of the subpoena is to obtain the production of closing documents relating to the sale and purchase of two comparable properties referred to in the attached PTAX forms.

bb. George Fuhrman: #10-00163-R-1 (Will)

The PTAB's final administrative decision was mailed and dated on 4-20-12 regarding the above appeal. This decision was based on a proposed assessment for the subject property submitted by the BOR. The Appellant was notified of the suggested agreement and given 30-days to respond in writing if the proposed assessment was not acceptable. A response was not received from the Appellant objecting to the proposed assessment and a decision was issued. Appellant is now requesting that the decision be rescinded because the PTAB did not consider evidence he submitted in support of the appeal.
