Letter from appraiser (11-19-12) indicates an extension is needed to complete assignment due to current commitments and involvement in a number of court hearings and depositions.

bb. Coca Cola Enterprises: #10-23081-I-3 (Cook – Niles) Kraft Foods, Inc.: #10-23088-I-2 (Cook – Niles)

In each of the above listed appeals, Intervenors, S.D. #219 and S.D. #71, originally filed with PTAB on 8-28-12. A total of 90-days has been granted for the submission of evidence. Intervenors are requesting an additional 90-day extension for the completion of an appraisal. Letter from appraiser (11-27-12) indicates an extension is needed to complete assignment due to current commitments and involvement in a number of court hearings and depositions.

cc. Abraham Mulanthara: #10-04032-R-1 (DuPage)

Appellant originally filed with PTAB on 4-29-11. An initial review prompted an incomplete letter and checklist to be mailed out to Appellant on 5-8-12 with the request that Section 2C be completed and a 6-7-12 deadline. A response was not received and the appeal was dismissed on 10-31-12. On 11-30-12, a request to reinstate the appeal was received by PTAB from the Appellant. Appellant states the letter and checklist mailed by PTAB was misplaced and requests the PTAB accept the corrected appeal form. The appeal form/documentation does not satisfy the burden of going forward.

dd. Bernard Kerr: #10-04578-R-1 (St. Clair) Bernard Kerr: #10-04761-R-1 (St. Clair)

In each of the above listed appeals, Appellant originally filed with PTAB in September of 2011. An initial review prompted an incomplete letter and checklist to be mailed out to Appellant on 5-3-12 and 6-1-12, respectively, with the request that the required Board of Review decision be submitted within 30-days of the date of each letter. Appellant submitted parcel information reports pertaining to the Treasurer's Office that did not substantiate PTAB's request and the appeals were dismissed on 11-15-12 and 11-9-12, respectively. Per correspondence dated, 11-29-12, Appellant is requesting the PTAB reinstate the appeals and state the St. Clair County Board of Review was contacted for receipt of requested information. Appellant states the BOR indicated that the mailing is done by a mailing service and duplicates are not available.

ee. John Folan: #10-04890-R-1 (DuPage)

Appellant originally filed with PTAB on 6-7-12. An initial review revealed the Appellant filed off of a PTAB decision dated, 4-20-12. The Appellant supplied PTAB with a copy along with initial filing. The appeal was dismissed for untimely filing on 9-25-12 and letter mailed to the Appellant on the same day. Per correspondence dated, 10-29-12, Appellant is requesting the PTAB reinstate the appeal and grant the Rollover Appeal for the 2010 assessment year as requested with initial filing. Appellant states the PTAB decision was not received within 30-days due to lag time of mailing or the post office.

ff. Robert Juen: #10-04765-R-1 (St. Clair)

Appellant originally filed with PTAB on 8-31-11. An initial review indicated the appeal as incomplete. An incomplete letter and checklist was mailed to Appellant with a 30-day extension to return requested information. A response was not received by PTAB and the above appeal was dismissed for insufficient evidence on 10-30-12. Per correspondence received, 11-7-12, Appellant states that a phone call was made on 11-1-12 to discuss the status of appeal. Appellant discovered the dismissal at this time. Reinstatement request states the address used by PTAB is incorrect and appeal should be re-opened for required information to be submitted. Appellant indicated on appeal form that address is: 714 E D St. Belleville, IL 62220. PTAB entered address as: 714 Ed St. Belleville, IL 62220. Reinstatement request indicates actual address is: 714 East "D" St. The letter sent to the Appellant requesting additional information was not returned.

gg. Shannon Enorense: #10-02075-R-1 (Kane)

Appellant originally filed with PTAB on 4-4-11. An extension of 90-days was granted on 10-31-11 as requested in original filing. The appeal was dismissed on 10-5-12 after a hearing officer review indicated no additional evidence was submitted and insufficient evidence is contained in file. All information was mailed to attorney listed on appeal form. Per correspondence dated, 10-31-12, a Motion to Reinstate Appeal was received by PTAB and a Motion to Substitute Counsel. Reinstatement request states that a hearing was scheduled by PTAB on 10-16-12 and appeal was dismissed for failure to appear. Neither occurred. Appeal was dismissed before BOR was notified.

hh. Ron Blank: #10-00750-R-1 (Will) Ron Blank: #10-00751-R-1 (Will) Joshua Blank: #10-00752-R-1 (Will)

In each of the above listed appeals, Appellant originally filed with PTAB on 2-19-11. An initial review indicated the required BOR decision was missing from each file and a 30-day extension was granted to Appellant with an incomplete checklist due 12-4-11. All information was mailed to attorney listed on appeal. The BOR decisions were received by PTAB from same attorney on 4-11-12, untimely. The decisions submitted state the Appellant failed to appear at the BOR hearing and the appeals were dismissed. The PTAB dismissed the above listed appeals on 10-30-12 and 11-1-12. Per correspondence dated, 11-13-12, a Motion to Reinstate Appeal was received by PTAB and a Motion to Substitute Counsel. Reinstatement request states that a hearing was set to be heard by PTAB and appeals were dismissed for failure to appear. This did not occur in any of the files. Appeals were dismissed before BOR was notified.
