Letter from review appraiser (12-26-12) states he has eight subpoenas requiring testimony at depositions and trials with the Illinois Department of Transportation between January and March and requests an extension of 90 or more days to complete an appraisal review report. Letter from valuation appraiser states he has

inspected the subject power plant and expects to make progress on the appraisal in the near future but due to multiple demands on time, a 90-day extension is requested to complete the report.

o. Petersen Health Care II, Inc.: #10-01578-C-3 (Moultrie)

The Moultrie County Board of Review was notified of the above filing on 11-17-11. A total of 90-days was granted for the submission of evidence. Evidence was received on 2-15-12 and consists of an appraisal of the subject property and Notes on Appeal form.

Correspondence received 12-21-12 from the BOR consists of a Motion to Reopen Evidence. Motion states that in support of its contention of the correct assessment, the BOR submitted a narrative appraisal prepared and signed by Kent Fitzjarrald, MAI and State of Illinois Certified General Real Estate Appraiser, with an effective date of January 1, 2010 and a letter of transmittal dated January 12, 2012. The matter was scheduled for a hearing to be held on January 7, 2013.

By Motion to Continue Hearing (the hearing was postponed) and Motion to Reopen Evidence, the BOR informed the PTAB that Mr. Fitzjarrald died on October 31, 2012. The BOR, noting that PTAB rule 1910.67(i) provides that appraisal testimony may only be given by a preparer of the documented appraisal whose signature appears thereon, requests an additional 90-days to submit new evidence.

p. Sung Bhe Kim: #09-34591-C-1 (Cook – Lake)

Appellant, represented by counsel, originally filed with PTAB on 10-13-10. A total of 150-days has been granted for the submission of evidence with the latest being a Final Extension expiring on 5-14-12. Appeal was dismissed on 8-22-12 for insufficient evidence and no response to the final extension. Per evidence and request dated 11-1-12, Appellant is submitting a request for reinstatement and a commercial appraisal (1-1-10). Appellant states the Final Extension granted by PTAB nor the dismissal letter, were received (the Appellant noted that there is a 2010 appeal pending on the same property).

q. Renata Gozdiak: #09-32942-R-1 (Cook – Worth)

Appellant originally filed with PTAB on 10-12-10. A Hearing Notice was mailed to Appellant on 8-28-12 setting the appeal for a hearing date on 10-25-12. Appellant did not show for hearing and appeal was dismissed on 11-2-12. Per correspondence received 11-15-12, Appellant states she was called out of town for an urgent business matter and was unable to attend the hearing scheduled for

10-25-12. Appellant is requesting the PTAB reinstate the appeal and issue a decision based on the evidence already submitted, including an appraisal from Appellant. Document submitted with request to reinstate included a cost and billing summary indicating an airline ticket was purchased on Tuesday, October 23, 2012, for a flight leaving on 10-24-12 and returning 10-27-12.

- r. Waterfront Services Co.: #10-04850-C-2 (Alexander)

Appellant originally filed with PTAB on 9-16-11. A total of 150-days has been granted for the submission of evidence with the latest being a Final Extension. Appellant filed a Motion to Stay Proceedings or in the alternative, additional time to submit evidence and legal brief. Request asks to stay the proceedings pending the Illinois First Judicial Circuit Court's decision in Case No. 12-TX-6, as to whether the property interests at issue in this case are taxable under Illinois law.

Creative Printing Service, Inc.: #07-22255-I-1 (Cook – Maine)

- (1) In each appeal the Appellant has filed a Motion to Strike/Default/Bar/Compel the BOR's evidence.
- (2) In each appeal the Appellant requested subpoenas be issued to compel the appearance of individuals of the DOR and from the BOR to provide testimony with respect due to the level of assessments.
