Appellant originally filed with PTAB on 7-29-11. A total of 90-days has been granted for the submission of evidence. Appellant is requesting an additional 60-day extension for evidence submission.

Request states that both notices may have been sent to an old address and that neither the Final extension nor the dismissal letter was ever received. A review of both letters finds the Counsel's correct current address on both and neither letter was returned to PTAB.

In each of the appeals listed above, Appellant filed, through Counsel, in July or August of 2011. Each appeal is accompanied by a cover letter requesting an extension of time to submit a professional real estate appraisal. PTAB granted a 90-day extension in each appeal expiring in October of 2012. No response was received and each appeal was dismissed for insufficient evidence on 2-14-13. Per correspondence received 2-19-13, Counsel is requesting each appeal be reinstated stating the extension letter from PTAB was not received. Counsel questions whether extension letters were addressed to Morton A. Gordon, principal real estate tax partner, who passed away on 10-14-12. Counsel also questions as to whether the extension letters were sent to an old address. A review of the extension letter for each appeal reflects the correct current address for Counsel and are not addressed to deceased partner Morton A. Gordon. The 90-day extension notice was not returned to PTAB.

- dd. John McClain: #07-29462-C-1 (Cook – South Chicago)

The subject property is composed of two PINs. The PTAB issued a decision on 4-20-12 carrying forward the assessments as established in a prior year's (2006) appeal of the same property. The result of carrying the assessments forward was a reduction in the assessment of one PIN and an increase in the assessment of another PIN (17-31-101-016). During the interim year (2007) the BOR made a significant reduction to PIN 17-31-101-016 from \$72,482 to \$28,184. The PTAB's decision for the 2007 tax year established an assessment for PIN 17-31-101-016 of \$53,352. By letter dated February 11, 2013, the appellant is requesting some corrective action to alleviate the increase in the assessment of PIN 17-31-101-016.

- ee. Bruce Yasmeh: #09-05510-C-3 (Saline)

This appeal was set for a hearing date of 1-22-13 in Saline County. Hearing letter was addressed and mailed to Appellant name and address provided on appeal form. No attorney is listed on the appeal form or subsequently added. Appellant failed to appear at hearing and appeal was dismissed on 1-23-13. Appellant is requesting appeal be reinstated per correspondence received 2-11-13. Request states the Appellant was unable to appear due to a medical emergency and this should constitute “good cause”. Nothing accompanies the request to substantiate a medical emergency. Appellant did submit a copy of a flight itinerary scheduled for 1-20-13 from Los Angeles to Chicago.

On 2-21 13, PTAB received correspondence with Taxpayer’s Formal Request For Administrative Review typed on the front. The rest of the correspondence is same as what was received by PTAB on 2-11-13.

- ff. Douglas K. Blodgett The Nature Conservancy: #11-02177-F-2 (Fulton)

This appeal was hand-delivered to PTAB on 4-12-12 (Thursday). The Final Notice from the Fulton County BOR is dated 3-12-12. Appeal was delivered one (1) day late and dismissed on 1-23-13 after an initial review. On 1-29-13, PTAB received a stipulation signed by the Appellant and the Fulton County Board of Review followed by a reinstatement request from the Appellant received 2-4-13. Request states that the Appellant assumed the 30-day filing deadline began after receipt of the Final Notice from the BOR.
