A decision from the Kane County Board of Review was not included with the filing and Donna King from the Supervisor of Assessment office confirms this parcel number and/or Appellant did not file an appeal with their office for the year 2011.

xx. Liberty Plaza LLC: #23826-C-3 (Cook – Rich)

Intervenor, Matteson Public Library, originally filed with PTAB on 10-22-12 a Request to Intervene included a Resolution and a request for an extension of time to file evidence. A 90-day extension was granted to the Intervenor with an expiration date of 1-23-13. A response from the Intervenor was received by PTAB on 1-29-13 (6-days late) and requests the adoption of evidence submitted by the BOR and the other two Intervenors whom are part of the file. Intervenor, Matteson Public Library was defaulted on 2-26-13 for untimely filing of evidence. Per correspondence received 3-31-13, Intervenor assumed the other two Intervenors would address the adoption with their submission. Intervenor requests the default be withdrawn by PTAB.

yy. WRB Refining: #11-00025-I-3 (Madison)

Appellant originally filed with PTAB on 4-6-12. A total of 180-days has been granted for the submission of evidence with the latest being a Final Extension expiring on 5-21-13. The Appellant is requesting a third extension request of 90-days, or such other period as the PTAB deems appropriate, to file evidence. A sworn affidavit accompanies this request. Affidavit states this case involves the assessment of one of the largest petroleum refineries in the country. The 2010 assessment was approximately \$93,500,000 and the 2011 assessment was increased four-fold to \$402,176,150. In addition to the significant amounts at issue, the case presents a number of difficult legal and appraisal problems.

zz. N.J. Marino: #10-24225-C-1 (Cook – Niles)

The above file was dismissed on 2-13-13 for insufficient evidence. A 90-day extension was processed on 7-12-12 with a due date of 10-10-12. Evidence was not received. On 2-19-13 Appellant submitted a Motion to Reinstate. This Motion went before our Board on 4-10-13 and was denied. A second Motion to Reconsider and Reinstate Appeal was received via email on 4-25-13. Attorney asserts that the appeal was filed on 6-22-11 from a decision issued by the BOR on 5-23-11. At the time of filing, the information on the comparable sales was not available and an extension was requested. On 6-28-11, the sales information consisting of 20 MLS sales was received and is attached to the Motion to Reconsider. The Appellant indicates that due to the lack of a docket number the information could not be forwarded to the PTAB. As stated in the previous affidavit, no correspondence was received from the PTAB prior to the dismissal order issued on 2-13-13. The initial notification letter was not returned to PTAB. The PTAB website informs participants not to send any additional evidence or correspondence after initial filing until a letter is received from PTAB indicating the appeal has been received.

aaa. Exelon Generation Co., LLC: #09-04906-I-3 (LaSalle)

Intervenors, numerous Taxing Bodies, were granted a 90-day final extension to submit evidence expiring on 6-2-13. By correspondence dated 4-9-13, the Intervenors are requesting a 26-day extension to and including 6-28-13. Request states this is an extremely complex nuclear power station warranting the filing of many, quite voluminous, documents. Additionally, the Taxing Bodies assert various motions are currently pending with PTAB and the Board's rulings on the motions may very likely have a significant impact on the documents to be filed by the Taxing Bodies.

Pending Motions include:

- (1) Motion to Strike the written appraisal prepared by Martin A. Schmidt filed by taxing bodies. Exelon filed its Response in Opposition and the Taxing Bodies filed a reply.
- (2) Exelon filed a Motion for Leave to Supplement Evidence with Additional Appraisal. Taxing Bodies are to file a Response Objecting to the Motion. Additionally, Exelon is expected to file a reply which would be due 5-7-13.

Recommendation: In light of pending motions and complexity of property, grant Taxing Bodies final extension to Monday, 7-1-13.
