Per correspondence received 12-31-13, Appellant is requesting PTAB not to dismiss her appeal and further states she has fired her previous counsel for not keeping her abreast of the status of her appeal and not getting information to our office in a timely manner. Appellant submitted evidence along with her request.

ccc. Fred Golden: #09-35995-R-1 (Cook – New Trier)

This 2009 appeal arrived in our office with a postmark of 11-18-13 (untimely). Accompanying it is a cover letter from Appellant's counsel explaining the original appeal was believed to have been mailed with others on 10-4-10, which would make it timely. A FedEx mailing label and summary reflecting a postmark date of 10-4-10 were also sent on 11-18-13 but does not specify name or parcel number.

Per correspondence received 12-17-13, Appellant is requesting the PTAB reconsider its decision and enter a revised order consistent with the agreed upon stipulation between the Cook County Board of Review and the Appellant dated 12-10-13.

eee. Chicago Teacher's Union Tower Corp: #10-31740-R-3 (Cook – N. Chicago)

Intervenor, Board of Education of the City of Chicago, originally filed with PTAB on 6-3-13. A total of 120-days was granted for the submission of evidence with the latest extension expiring 10-24-13. Evidence was received (via facsimile) on 10-30-13, 6-days late. Intervenor was found in default on 11-1-13 and file was made ready for hearing. A Motion to Vacate Default was received 12-11-13 from the Intervenor stating counsel inadvertently entered the evidence submission deadline as 10-31-13 rather than the actual 10-24-13.

fff. Citgo Oil Refinery Lemont IL: #10-00598-I-3 (Will)

Intervenors, BOE Lockport T.H.S.D. #205 and BOE Will County S.D. #92, originally filed with PTAB on 5-30-13. A total of 120-days has been granted for the submission of evidence. Intervenors are requesting an additional 90-day extension and further request the PTAB issue an order compelling the Appellant to answer a written discovery request within 14-days on the grounds that the request has thus far been ignored by the Appellant. The Intervenors have listed 34 separate items. The Appellant responded with a letter explaining the genesis of the 2010 appeal was a school district's undervaluation complaint filed at the BOR supported by a complete appraisal of the subject property. This same appraisal was updated in a desktop format for 2011. The school district submitted a second complete appraisal in connection with the 2012 assessment complaint filed by Citgo to the Will County Board of Review. Appellant's counsel further asserts that information requested by the school district can be found in various pages of the appraisal report it has submitted to the PTAB.

ggg. Allstate Insurance Company: #11-25384-C-3 (Cook – Barrington)

Intervenor, Barrington C.U.S.D. #220 originally filed with PTAB on 8-29-13. A 90-day extension was granted for the submission of evidence with a due date of 12-3-13. On 12-10-13 (7-days late), the PTAB received a request for another extension of 30-days for the submission of evidence and legal argument. The Intervenor was defaulted the same day. Per correspondence received 12-18-13, Intervenor is requesting the PTAB Vacate Default due to a legal assistant for counsel entering an incorrect due date. Counsel explained this appeal has been part of a larger assessment group of appeals pending in the Circuit Court of Cook County for the assessment years 2004-2010. These appeals have been the subject of extensive negotiations between the taxpayer/Appellant, the County, and the School District. Counsel for the Appellant and the Cook County BOR have no objection to PTAB vacating its finding of default.

The Intervenor filed a brief citing various cases to support request to vacate default.
