Intervenor, Bloom T.H.S.D. #206, originally filed with PTAB on 11-15-13. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 90-day extension for the completion of an appraisal. Letter from appraiser is not included with the request.

- yy. Bertha Garcia: #11-02162-C-3 (Kane)

Intervenor, City of Aurora, originally filed with PTAB on 11-13-13. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting a filing deadline the same as the Kane County Board of Review (4-19-14) because they are working together in preparation of a responsive evidence filing. In the alternative, Intervenor requests a 60-day extension.

- zz. AT&T Communications: #11-26262-C-3 (Cook – W. Chicago)

Intervenor, City of Chicago, originally filed with PTAB on 10-28-13. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 60-day extension for receipt of requested documentation from the Appellant to review and analyze, with the possibility of an updated appraisal.

- aaa. Orchard Investments: #12-03158-C-3 (Lake)

Intervenor, C.H.S.D. #128, originally filed with PTAB on 11-4-13. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 60-day extension to compile evidence.

- bbb. Platt Hill Nursery: #11-01852-F-1 (Kane)
Ankit Desai United Light, LLC: #11-01853-C-3 (Kane)

In each of the appeals listed above, Intervenor, C.U.S.D. #300, originally filed with PTAB on 11-15-13. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 60-day extension to compile evidence.

- ccc. Walgreen Company: #11-28516-C-3 (Cook – Northfield)

Intervenor, Deerfield Park District, originally filed with PTAB on 10-28-13. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 60-day extension to compile evidence.

- ddd. Kraft Foods: #11-28953-C-3 (Cook – Northfield)

Intervenors, N. Trier T.H.S.D. #203 and Sunset Ridge S.D. #29, originally filed with PTAB on 11-4-13. A total of 90-days has been granted for the submission of evidence. Intervenors are requesting an additional 60-day extension to compile evidence.

- eee. Allstate Insurance Company: #12-02965-C-2 (DuPage)

Intervenor, Lemont Bromberek C.S.D. #113A, originally filed with PTAB on 10-28-13. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 60-day extension to compile evidence.

- fff. Park Ridge Office Center: #10-24473-C-3 (Cook – Maine)

Intervenors, City of Park Ridge and Park Ridge Public Library, originally filed with PTAB on 12-3-12. A 90-day extension was granted to the Intervenors for the submission of evidence with a due date of 4-15-13. On 4-15-13, a request for a second extension was received from the Intervenors and an extension of 30-days was granted with a due date of 5-18-13. On 4-17-13 and 5-17-13 a faxed extension request was received (followed by a hard copy) from the Intervenors requesting a third extension accompanied by a letter from appraiser. This request went before our Board on 5-14-13 and a 30-day Final extension was granted on 5-17-13 with a due date of 6-16-13. Evidence from the Intervenors was received on 8-22-13, two (2) months late. This evidence went before our Board at its 9-10-13 meeting and it was decided to default the Intervenors and not accept the untimely filed evidence. Per correspondence received 1-13-14, Intervenors have filed a Motion to Vacate Default. Motion states the final extension issued by the PTAB was in error as was the default and Intervenors believed the extension letter was mistakenly sent and was perhaps meant for a different Intervenor or a different PTAB matter.

- ggg. Ross Laser: #11-24351-R-2 (Cook – N. Trier)

The Cook County Board of Review was notified of the above filing on 7-9-13. A 90-day extension was granted with a due date of 10-7-13. Evidence was not received and the BOR was defaulted on 1-17-14. Per correspondence received 2-6-14, the BOR is requesting the PTAB rescind the default stating the evidence was mailed but omitted from a log sheet that accompanies all of their mailings because the process was new to staff. The PTAB does not have any record of the evidence being received through our mail log nor from the log sheets from the BOR.

hhh. Summit Labs: #11-29633-C-2 (Cook – Thornton)

Appellant originally filed with PTAB on 5-4-12 along with an extension request to submit evidence. A review of the file indicated Section 2C was not completed and a checklist was mailed to Appellant with a 30-day extension and due date of 10-25-13. Appellant returned evidence on the due date but neglected to supply the requested/required assessment breakdown of Section 2C, subsequently, the appeal was dismissed on 1-15-14. Per correspondence received 1-27-14, Appellant is requesting the appeal be reinstated and evidence accepted without the breakdown.

iii. Webb Ford: #11-03660-C-3 (DuPage)

Intervenor, Wheaton/Warrenville S.D. #200, originally filed with PTAB on 8-26-13. On 8-28-13, a stipulation signed by the Appellant and the DuPage County Board of Review was forwarded to the Intervenor with an extension due date of 9-27-13. On 9-24-13 the PTAB received a rejection of the stipulation from the Intervenor and a request for a second extension for the submission of evidence. On 9-27-13, a 60-day extension was granted to the Intervenor with a due date of 11-26-13. Evidence was not received by the due date and the Intervenor was defaulted on 12-19-13. A decision was rendered by PTAB using the stipulation signed by the BOR and the Appellant. This decision went before our Board on 1-14-14 and was approved and mailed out on 1-24-14. Per correspondence received 1-29-14, Intervenor has submitted a Motion to Reinstate and a copy of an extension request with a date of 11-25-13 asking for another 60-day extension to provide evidence and/or a brief. The PTAB does not have a record of receiving this extension request.

jjj. Leroy Carlson: #11-24536-R-1 (Cook – Evanston)

Appellant originally filed with PTAB on 1-13-12 along with an extension request to submit sufficient evidence. On 8-7-13, a notification letter was mailed to Appellant with a 90-day extension expiring on 11-5-13. Evidence was not received and the appeal was dismissed on 11-19-13. A request for reinstatement was received by PTAB on 12-2-13 accompanied by documentary evidence. The request states the notice of extension was received but the deadline for evidentiary filing was inadvertently missed. Appellant notes there are appeals (triennial assessment year) for the tax years 2010 and 2012 currently pending with PTAB.

kkk. Valero Energy Corporation: #11-05915-I-3 (Madison)

Intervenors, East Alton – Wood River H.S.D. #14, Hartford – Wood River S.D. #15, and Roxana C.U.S.D. #1, originally filed with PTAB on 12-18-13, without the required resolution authorizing intervention on behalf of the taxing body. Per Section 1910.60 (d) (2) of PTAB's Official Rules, the intervention requests were denied. Intervenors, represented by counsel, request the PTAB accept the original intervention filings and be granted an extension to obtain the required resolution. Counsel further explains they believed the resolutions filed with the previous year's (2010) filing fulfilled the requirement for the 2011 filing.

lll. White Eagle Golf Club: #11-00859-C-3 (Will)

On 2-4-14, the Taxpayer filed a Motion to Stay proceedings and Leave to Amend Appellant's Original Petition Pending the Outcome of the Owentsia Club appeal. Taxpayer has already submitted all evidence. The Will County Board of Review and the Intervenor, Indian Prairie C.U.S.D. #204, have both been notified of the appeal. The BOR and Intervenor have joined in the Motion to Stay. The BOR filed a Motion for Stay dated, 12-9-13. PTAB granted the BOR an extension until 4-22-14 to submit evidence.

mmm. Midwest Generation EME, LLC: #10-32349-I-3 (Cook – W. Chicago)

Intervenor, Chicago Board of Education, originally filed with PTAB on 5-3-13. A total of 120-days was granted for the submission of evidence with the latest expiring on 11-22-13. Intervenor was defaulted on 12-6-13 for not providing evidence and the file was made ready for hearing. Per Motion received 12-19-13, Intervenor is requesting PTAB Vacate Default. Motion states a 3rd extension request was mailed timely to the PTAB but Intervenor's counsel inadvertently omitted the docket number and name from the letter. A copy of this letter is provided and reflects a date of 11-22-13. It does not contain a name or docket number. Counsel states the error was discovered and a corrected copy was sent via facsimile to the PTAB on 12-3-13.

nnn. Ed Fielder: #11-20017-R-1 (Cook - Riverside)

Appellant originally filed with PTAB on 12-29-11. A request for an extension of time for submitting evidence was received with the filing. The PTAB granted the extension with a due date of 6-10-13. The appeal was dismissed on 10-15-13 for lack of response/evidence. A Motion to Reinstate was received by PTAB on 11-12-13 and this Motion went before our Board at its 12-10-13 meeting where the Motion was denied and the appeal remains closed. On 12-27-13, a second request to Reconsider Motion to Reinstate was received from Appellant stating the appeal was improperly dismissed with evidence for the appeal. Furthermore, the Appellant misunderstood that the dismissal was due to insufficient evidence and not for failing to file evidence which Appellant states was hand-delivered timely. The PTAB does not have a record of receiving evidence from the Appellant during the extension time period.
