Appellant originally filed with PTAB on 12-20-13. An initial review indicated appeal was untimely filed. Appellant is filing from a 2010 PTAB decision dated 10-18-13. Appeal for 2011 was received postmarked 12-20-13. Appellant was granted a 30-day extension due 2-15-14 to prove timeliness. Per correspondence received 1-28-14, Appellant claims an appeal was mailed on 11-12-13 to PTAB but with no indication of receipt, a second appeal was mailed 12-20-13. An affidavit is included with 1-28-14 mailing. Appeal was dismissed for untimely filing on 2-25-14. Appellant is requesting the PTAB reinstate the appeal and accept evidence that the appeal was originally mailed 11-12-13.

- tt. Mike Canino: #11-05743-R-1 (Will)

The Will County Board of Review was notified of the above filing on 5-30-13. A total of 90-days was granted for the submission of evidence with a due date of 8-28-13. The required Notes on Appeal form, evidence, and/or an extension request was not received and the BOR was defaulted on 11-25-13. Per correspondence received 2-21-14, the BOR is requesting the PTAB rescind the default once again. The Will County Board of Review asserts it had not received any correspondence for the above referenced appeal prior to the default. File contains letter dated, 5-30-13, addressed to the BOR notifying it of the appeal. The first request to rescind default was denied by the Board at its 1-14-14 meeting.

- uu. Geraldine Super: #10-05199-R-1 (Will)

The Will County Board of Review was notified of the above filing on 1-16-13. A total of 90-days was granted for the submission of evidence with a due date of 4-16-13. The required Notes on Appeal form, evidence, and/or an extension request was not received and the BOR was defaulted on 11-20-13. Per correspondence received 2-21-14, the BOR is requesting the PTAB rescind the default once again. The Will County Board of Review asserts it had not received any correspondence for the above referenced appeal prior to the default. File contains letter dated, 1-16-13, addressed to the BOR notifying it of the appeal. The first request to rescind default was denied by the Board at its 1-14-14 meeting.

- vv. Mickey Hornick: New Appeal (Cook – Lake View)

Legal counsel representing the Appellant contacted, via email, a PTAB employee stating a recent audit revealed this 2011 appeal was not docketed by our office. Counsel has since sent a copy of the 2011 appeal dated 2-19-12 and a certified mailing receipt requesting the PTAB issue a docket number. Cover letter also states counsel believes original appeal may have been lost in the mail because they did not receive a signed return receipt back.

- ww. Rochelle Travel Plaza, Inc.: #12-01058-C-1 (Ogle)  
Rochelle Truck Stop, Inc.: #12-01062-C-2 (Ogle)

In each of the above listed appeals, the subject property is a truck stop/travel center facility located in Rochelle, Illinois. The Appellant has filed an appraisal estimating a fair market value of \$6,120,000 as of 1-1-12. The property purportedly receives revenue from the business and improvements that include, but are not limited to, gas sales, restaurant, medical clinic, rest area, video game arcade, truck repair and truck wash.

Intervenor, Rochelle S.D. #231, has filed a Motion for Formal Discovery requesting all of Appellant's documents related to property's income and operating expenses because they contain information essential to understanding the allocation of real property and business value for a property like this.

- xx. Youssi Rentals LLC: #12-01579-R-2 (DeKalb)

Possible Intervenor, Sycamore C.S.D. #427, filed a Request to Intervene with PTAB on the above docket number dated 2-3-14. The deadline for filing with PTAB (according to the Certificate) was 2-4-14. The Request to Intervene was denied by PTAB because the required resolution did not accompany the filing. Sycamore C.S.D. #427 has filed a Motion to Reconsider Denial of Request to Intervene and Grant Taxing Body's Request to Intervene for Good Cause Shown. Motion states the Board of Education intended to approve the resolution at its 1-18-14 meeting however, due to unforeseen weather conditions, the meeting was cancelled and the next available date to meet was 2-11-14, after the 2-4-14 filing deadline with PTAB. A signed affidavit accompanying this Motion states the School Board unanimously approved the resolution of authorization at its 2-11-14 meeting.

- yy. Berwyn Rehabilitation Center, LLC: #08-20534-C-2 (Cook – Berwyn)

Appellant, represented by counsel, has submitted a Request for Subpoena Duces Tecum, received 2-28-14, upon the appraiser for Intervenor, S.D. #100. Appellant is requesting the "work file" from the Intervenor's appraiser.

zz. Dalton Gray: #11-29068-R-1 (Cook – Schaumburg)

Appellant has submitted a Motion for Subpoena and Removal of Administrative Law Judge dated, 3-26-14. Currently, Appellant is scheduled for hearing with the PTAB on 4-23-14 and requests the Clerk of the PTAB issue a subpoena to Wells Fargo Bank for the appraisal, “Broker Rice Option”, or “Broker Opinion of Value” that determined the current market value and listing price for short sale of Appellant’s home.

aaa. Citgo Oil Refinery Lemont Illinois: #10-00598-I-3 (Will)

Intervenors, Will County S.D. #92 and Lockport Township H.S.D. #205 move the PTAB to stay the proceedings in the interest of judicial economy and to avoid inconsistent results in multiple venues. Intervenors assert that Citgo filed a tax objection complaint in the Circuit Court of Will County for the tax year of 2010 (Case No. 11 TX 340). Intervenors assert Citgo necessarily asks the Court to determine the assessed value of the Lemont Refinery parcels both prior to and after the addition of “new property” as well as the amount of assessment attributable to that “new property.” The Intervenors contend in order to address the issues raised by Citgo’s tax objection complaint, the Circuit Court will necessarily be addressing the same issue that is before the PTAB in this proceeding. Therefore, this matter should be stayed in the interest of judicial economy and to avoid inconsistent results between the two venues where Citgo has chosen to assert its claims.

Citgo responded to the Motion to Stay asserting that on 2-20-14, it filed a Motion to Voluntarily Dismiss itself as a party to the tax rate objection lawsuits. On 2-25-14, the Court entered its order dismissing Citgo from the tax rate objection lawsuits. A copy of the Order was submitted by Citgo as Exhibit B.
