Appellant originally filed with PTAB on 2-4-12. A total of 90-days was granted for the submission of evidence with the latest expiring on 12-21-13. Appellant timely filed evidence on the due date. The appeal was reviewed by a hearing officer and evidence submitted was deemed insufficient. Appeal was dismissed on 3-11-14. Per correspondence received 4-10-14, Appellant is requesting the PTAB reinstate the appeal and adds she has not received a decision for her 2010 PTAB appeal. The hearing for the 2010 appeal was held 1-22-14. Taxpayer marks the basis of the appeal as comparable sales/condition of property, and declining market. As "evidence" Appellant submitted a written letter indicating that property was damaged due to freezing and flooding of the coach house. She also provided photographs depicting the poor condition of the home and estimates for repair costs; bids from 2004, 2006 and 2010.

oo. Laura Pickrel: #12-04858-R-1 (St. Clair)

Appellant originally filed with PTAB on 1-21-14 (postmark) from a PTAB decision dated 12-20-13. The Appellant's deadline for filing was 1-19-14 (Monday), which was a holiday for the State of Illinois, making 1-20-14 (Tuesday) the official deadline. Appeal was received one (1) day late and dismissed for lack of jurisdiction on 3-13-14. Per correspondence received 3-21-

14, Appellant requests the PTAB reinstate the appeal and enclosed a certified receipt from the U.S. Post Office and signed by a PTAB employee with a postmark date of 1-21-14. Appellant believes it was mailed 1-20-14.

pp. Petersen Health Care II, Inc.: #11-04293-C-3 (Moultrie)

Appellant was notified of a possible stipulation received from the Moultrie County Board of Review (BOR) on 11-26-13. Appellant was granted a 30-day extension to respond to the PTAB if the stipulation was not acceptable. A response was not received and a decision was rendered using the stipulated amount of \$1,165,000 on 3-21-14. A Motion for Reinstatement and Motion to Reconsider was received by the PTAB on 4-18-14 from the Appellant. Motion states the Appellant did not respond to the PTAB by the established deadline but is not in agreement with the proposed assessment submitted by the BOR. Appellant states the Petitioner and the Respondent have never entertained settling this matter for the amount proposed by Respondent in this stipulation.

The Moultrie County Board of Review has filed a Response to Motion for Reinstatement and Motion to Reconsider, received by the PTAB on 4-23-14. The Motion cites Section 1910.55(c) of the PTAB's rules and refers to the Appellant's failure to respond to the proposed stipulation within 30-days and furthermore stating the multiple pending tax years have probably caused confusion.

qq. Burt Gutterman: #09-29685-R-1 (Cook – New Trier)

Appellant has filed a Motion to Reconsider, received 4-3-14 by the PTAB. Appellant requests the 3-21-14 PTAB decision for the above docket number be reconsidered and corrected due to the fact that a material error of law has occurred. For tax year 2009, the Appellant states he did not request a "rollover" pursuant to Property Tax Code section 16-185 yet the 2009 PTAB decision mirrors the 2007 and 2008 assessments. Appellant's counsel asserts that effective for tax year 2009, the Cook County Board of Commissioners passed ordinance 08-0-51, commonly referred to as the 10/25 ordinance. As a result of the ordinance there was a revaluation of the County for 2009 and the taxpayer should be allowed the benefit of that reassessment. The PTAB is requested to reconsider the decision and reduce the assessment in light of the appraisal submitted by the Appellant (BOR submitted only equity comparable).

rr. MB854, LLC: #11-00208-C-3 (Will) – Motion to Dismiss

Appellant originally filed the above docket number consisting of five (5) vacant parcels with PTAB on 1/24/12. Counsel marked recent sale and recent appraisal as the basis of the appeal. A brief was submitted referencing a sale of PIN 16-05-01-301-001 for \$500,000 and referencing an appraisal by Gibbons & Sidhu, Ltd. The Appellant partially completed Section IV of the appeal form regarding the recent sale but submitted no appraisal.

2/27/13 a letter with an incomplete checklist was sent to the Appellant noting the Appellant must submit evidence supporting the claim checked on the appeal form. In the "Other" section of the incomplete checklist form a notation was made stating the sales contract was not included. No other independent reference was made due to the failure to submit the appraisal.

3/13/13 the PTAB received from the Appellant a copy of the sales contract for PIN 16-05-01-301-001. No appraisal was submitted.

10/7/13 the BOR was notified of the appeal.

11/12/13 the PTAB received the certificate from the BOR stating taxing districts were notified.

11/19/13 the PTAB received the Request to Intervene from Lockport Twp. High School Dist. #205 & Homer Community Consolidated School Dist. #33-C.

11/22/13 the PTAB acknowledged the intervention and forwarded the evidence sent by the Appellant.

12/23/13 the PTAB received the BOR evidence. Evidence included a statement from the Homer Township Assessor asserting that while Appellant's brief mentioned appraisal, no appraisal was included with the appellant's evidence for review. The BOR indicated its willingness to stipulate to an assessment of \$166,666 for PIN 16-05-01-301-001 based on the \$500,000 purchase price. The BOR provided sales to support the assessment of the other parcels.

1/27/14 the Intervenors sent a letter to the PTAB reciting the evidence it had received. It noted the evidence forwarded by the PTAB, contained no appraisal

and no listing agreement as outlined in the Appellant's brief. The Intervenors requested the PTAB ensure that a complete copy of the Appellant's evidence was provided to the Intervenors. The PTAB, through Ehron Stout, responded to the Intervenor by e-mail dated 1/29/14 that the appellant did not submit an appraisal and all evidence submitted by the Appellant was sent to the Intervenors.

2/6/14 the PTAB received from the Intervenors a Motion to Dismiss the appeals relative PINs 16-05-01-301-013 through 016-0000 due to no evidence from the Appellant with respect to these PINs. The Intervenor cites 1910.63 of the PTAB's rules asserting the contesting party must provide substantive evidence to challenge the assessment of the subject property and the failure to do so will result in the dismissal of the appeal.

3/3/14 the Appellant responded to the Motion to Dismiss with a copy of the aforementioned appraisal and an affidavit from David M. Lavin, asserting that the complaint he filed with the PTAB included copies of the Gibbons & Sidhu, Ltd. appraisal. The response asserts that the brief references the appraisal and contends it makes no sense that Lavin would send a brief referencing an appraisal but did not actually submit the appraisal in question. The Appellant contends the case should not be dismissed due to a clerical error on the part of the PTAB. (Counsel for Appellant failed to serve a copy of the response to the BOR and the Intervenors. The PTAB forward the response to the BOR and Intervenors on 4/1/14.)

4/7/14 Intervenors responded to the PTAB with a copy of the e-mail referenced above that the Appellant did not submit a copy of the appraisal as part of its evidence. The Intervenors stand by their Motion to Dismiss. Alternatively, the Intervenors ask the PTAB grant them a new filing deadline if the appraisal is accepted.

4/11/14 the BOR filed a request to dismiss the appeals due to the fact the Appellant's appraisal was not timely submitted. Alternatively, the BOR requests a 60 day extension of time to submit evidence if the appraisal is accepted.

ss. Citgo Oil Refinery Lemont IL: #10-00598-I-3 (Will)

Intervenors, BOE Lockport T.H.S.D. #205 and BOE Will Co. S.D. #92, currently have a Final extension with PTAB expiring on 5-21-14 after extensions totaling 210-days. Per correspondence received 3-17-14, Intervenors are requesting that a subpoena be issued to Appellant's appraisers, American Appraisal, pursuant to 35 ILCS 200/16-175, requiring production of the complete appraisal file(s) for all appraisals prepared by American Appraisal concerning the PDV/Citgo Midwest Lemont, Illinois Refinery, within 14-days. A previous formal discover request to the Appellant from the Intervenors was placed before the Board on February 11, 2014, and denied.

Appellant was forwarded a copy of the above subpoena request and responded to the PTAB on 3-24-14. Response notes the PTAB ruled on 2-20-13 that the Intervenors are not entitled to formal discovery and nothing has changed in the 2010 PTAB appeal since then. Appellant states Citgo has filed two (2) appraisals with PTAB and thousands of pages of documents in addition to the appraisals so there is no shortage of relevant and material fact.

tt. Advance Auto Parts: #08-21840-C-1 (Cook – Palatine)

Appellant has filed with PTAB an Emergency Motion for Reconsideration/Amended Decision, received 4-29-14.

Property consists of a two-year old one-story masonry building with 10,000 square feet located on a 32,942 square foot site. The building was constructed in 2007 and the land was reported to have been purchased in March 2005 for a price of \$1,400,000 (appraisal page 3).

4/18/14 the PTAB issued a decision increasing the assessment from \$236,297 to \$1,009,660, an increase of \$773,363 or approximately 327%. The PTAB's assessment reflects a market value of \$2,657,000 or \$265.70 per square foot of building area, land included. The assessment increase results in a tax increase in excess of \$160,000.

Appellant submitted an appraisal estimating the subject property had a market value of \$500,000 as of 1/1/08. The appraisers developed only the sales comparison approach to value. The sales identified by the appraisers were marginal in their similarity to the subject property based on age; four were constructed on 1949, 1981, 1963, and 1975, and two sold in 2004.

The BOR submitted information on 6 comparable sales. These sales were marginal in the context of their dates of sale with 5 occurring from 3/97 to 9/2001 and one sold in 2004. Also included with the BOR submission was a memo with a reference to a warranty deed pertaining to the subject property recorded in the Recorder of Deeds Office executed on 5/2/08 and reflecting a price of \$2,657,000. The warranty deed stated the grantor was InSite Palatine, LLC and the grantee was Merit Property Partners Advanced Auto, LLC. No other information was provided about the sale. The subject's total assessment of \$236,297 reflected a market value of \$621,834 or \$62.18 per square foot of building area, including land.

The PTAB found the reported sale of was the best evidence of market value and accordingly increased the assessment.

4/29/14 the Appellant filed an Emergency Motion for Reconsideration/Amended Decision citing section 1910.50(d) of the PTAB's rules which provides in part, "[the] Board may revise and/or correct a decision upon its own initiative at any time \*\*\* if a mistake in the calculation of an assessment or other clerical error is discovered. In such event the Board shall issue an amended decision."

The Appellant asserts the decision contains errors, factual inconsistencies and missing evidence that was not docketed through clerical error. The appellant asserts that rebuttal evidence was submitted on 11/4/10 which included a Costar/comps printout showing the sale of the subject property was not an arm's length transaction since it was part of a 1031 exchange on both sides of the transaction. The Appellant's counsel provided an affidavit asserting the rebuttal evidence was sent to the PTAB on 11/4/10 and also provided a copy of the rebuttal evidence which included a cover letter dated 11/4/10, a copy of the Costar printout and a copy of the PTAB's letter to Appellant dated 10/20/10 providing counsel a copy of the BOR evidence and granting the 30-day rebuttal period. The Appellant's purported rebuttal evidence is not in the file. There is no reference in PTAB 2000 that any rebuttal evidence was received.

The Appellant also asserted that factual errors include the fact that the Appellant was not the purchaser but is the tenant. The Costar sheet indicates the tenant has 15 years remaining on their double net lease. Counsel also noted the Warranty Deed had a restriction/Permitted Exception which included the lease between InSite Palatine, LLC and Advance Stores Co. A copy of Exhibit "A" attached to

the Warranty Deed supports the Appellant's assertion. The Appellant contends that the 2008 assessment increase based on a sale between two investor parties, including a leased fee estate, namely a long term lease with Advance Auto Parts that encumbered the subject property, is not warranted.

The Appellant also asserted that its agreement to have the decision written on the evidence, even though it had originally requested a hearing, was based on the fact the May 2008 sale had been rebutted.

The Appellant requests the PTAB issue an amended decision to confirm the 2008 assessment at \$236,297.

uu. BASF Corporation: #13-00384-I-3 (Kankakee)

Appellant originally filed with the PTAB on 2-12-14. Appeal was docketed and a 30-day extension was granted (expiring 4-24-14) per Appellant's request. On 4-3-14, the PTAB received a request for the Board to issue a subpoena to the Kankakee County Board of Review (BOR) pursuant to 1910.68 (a)-(f) of the PTAB administrative rules. Appellant requests the subpoena demand any recording of the hearing for their complaint that was held on 1-16-14 before the BOR for this property. Appellant also seeks any recording, whether it was an audio recording, a visual recording, or a written transcription of the hearing.

vv. Halikias Family Partnership: #08-30306-C-3 (PIN#31-07-101-002-0000)

The Appellant and the BOR drafted a stipulation for Docket No. 08-29780-C-3, PIN 31-07-101-002-0000. However, the stipulation referenced the incorrect Docket No. with the correct Docket No. being 08-30306-C-3.

On 2/24/12 the PTAB issued a decision for Docket No. 08-30304-C-3, PIN 31-07-102-002-0000, using the stipulation for PIN 31-07-101-002-0000. No stipulation was actually entered for Docket No. 08-30304-C-3.

The Appellant is requesting the decision issued by the PTAB for Docket No. 08-30304-C-3, PIN 31-07-102-002-0000 be rescinded/vacated and the PTAB issue a decision in Docket No. 08-30306-C-3, PIN 31-07-101-002-0000 in accordance with the stipulated amount totaling \$588,987.
