Recommendation: Deny request to reinstate each of the appeals listed above. Sales data submitted by Appellant was insufficient to challenge the assessment.

nnn. CLP Pekin IL Owner LLC: #13-00355-C-3 (Tazewell)

Taxing Body, Pekin Public S.D. #108, originally filed a Request to Intervene with PTAB on 5-28-14 (timely). A letter to the Board accompanied the request states the Board of Education could not reasonably approve a resolution authorizing intervention before its meeting on 6-23-14 (after PTAB due date). The request was denied by PTAB because the required Resolution was not provided. Per correspondence received 6-27-14, Pekin Public S.D. #108, has filed a Motion for Leave to Intervene. Motion states the 5-19-14 meeting of the Board of Education indicated they would be in favor of an intervention if an appraisal was performed. On 6-23-16, District #108 was advised that the resolution was approved (included

with Motion). District #108 believes that it should be allowed to intervene in this proceeding because an explanation of good cause for failure to timely submit a resolution was shown. The School District had two meetings at which time it could have approved a resolution authorizing the request to intervene, however, it did not do so

Recommendation: Deny request for Leave to Intervene.

Appellant originally filed with PTAB on 8-10-10 listing Mr. Robert Gorman as counsel and mailed by Mr. Gorman's office. An appraisal was included with filing and an extension request was not received. The Cook County Board of Review was notified of the appeal on 4-1-11. Evidence was timely received by the BOR and the file was made Ready Hearing on 8-8-11 with an oral hearing requested. On 3-12-14, a request to Withdraw as Attorney of Record, was received from Mr. Gorman. On 3-13-14, a letter was addressed from PTAB to the owner of Eagle Distributors advising them of Mr. Gorman's withdrawal and the requirement of counsel representation. Appellant originally filed with PTAB on 3-4-14. A total of 120-days has been granted for the submission of evidence with the latest extension expiring on 2-2-14. Appeal was dismissed on 6-19-14 for lack of evidence. A response was not received to the extension letters. Per correspondence received 7-22-14, Appellant has submitted a Motion to Vacate Default for Failure to Submit Evidence. Appellant claims the PTAB extension letter dated 1-3-14 with a due date of 2-2-14 was never received. PTAB did not receive the letter back and it is addressed correctly.

Recommendation: Vacate Default and grant a Final 30-day extension to Submit Evidence.

Appellant originally filed with PTAB on 2-15-13. Appeal was reviewed and deemed insufficient. A notification letter with a checklist and a 30-day extension was mailed to the Appellant's counsel on 1-23-14 with a 2-22-14 deadline. Information/evidence was not received by the deadline and the appeal was dismissed on 6-16-14. Per correspondence received 6-23-14, Appellant is requesting a Motion to Reinstate Appeal including an appraisal performed in 2013. Motion states the documentation for submission was misplaced.

Recommendation: Deny request to reinstate.

rrr. Brush College Finishers, Inc.: #12-04343-F-1 (Pike)

The Pike County Board of Review was notified of the above appeal on 2-11-14 with a deadline to file evidence/extension of 5-14-14. The BOR did not respond and was found in default on 7-1-14. Per correspondence received 6-25-14, the BOR filed a Motion for Extension of Time to Submit Evidence and for Leave to Submit Evidence *Instantly*. On 7-2-14, the BOR filed a Motion to Reconsider. Motions state the BOR believed they had timely filed their evidence but a review of the file revealed they were mistaken. Evidence has been submitted with request.

Recommendation: Deny request to Reconsider Default.

sss. Theodore Tetzlaff: #12-23150-R-3 (Cook – Lake View)

Appellant originally filed with PTAB on 2-4-13. A review of the appeal indicated several items missing and a notification letter with a checklist granting a 30-day extension was mailed to the Appellant's counsel on 12-18-13 with a 1-17-14 deadline. Evidence was not received and the appeal was dismissed on 6-3-14. Per correspondence received 6-19-14, Appellant's counsel states the 12-18-13 checklist and letter from PTAB was never received in their office, only the dismissal letter. The Appellant requests the PTAB reinstate the appeal because no party will be prejudiced. The 12-18-13 is correctly addressed and was not returned to PTAB.

Recommendation: Deny request to reinstate appeal.

Appellant originally filed with PTAB on 12-7-12. Appellant did not request an extension but did file a brief but no appraisal. A notification letter, checklist, and a 30-day extension, to specifically submit an appraisal, was granted on 12-24-13. Evidence was not received and the appeal was dismissed on 6-26-14. Per correspondence received 7-2-14, Appellant is requesting the PTAB reinstate the appeal, acknowledging that the checklist was received. Appellant asserts that their original filing was complete and included one (1) copy of a complete appraisal report.

Recommendation: Deny request to reinstate appeal.

vvv. William Olic: #12-04308-R-1 (Lake)

Appellant originally filed with PTAB on 5-23-13. A total of 210-days has been granted for the submission of evidence with the latest 2 being Final Extensions with the last expiring on 8-12-14. Per email received 7-18-14, Appellant is requesting an additional extension to submit evidence due to poor health.

Recommendation: Approve a Final 30-day extension due to Appellants extensive disability.

Recommendation: Grant a final 90-day extension after the current 8-26-14 deadline.

- xxx. Johan Joseph: #10-30535-R-1 (Cook – N. Chicago)

A no-change decision was rendered by PTAB on the above docket number 4-18-14. A Motion for Reconsideration was received by PTAB on 4-25-14. This Motion went before our Board on 6-10-14 and was denied. On 7-1-14, the Appellant filed an Emergency Motion for Further Consideration of No Change Decision due to Inconsistent Rulings on the Same Factual Bases, and cites the case of Dunkin' Donuts v. the Cook County Board of Review, PTAB docket number 10-25909-C-1. Appellant states the no-change decision was issued despite the Board of Review being defaulted and presented no evidence to either refute the Appellant's evidence or support its own estimate of value. Motion further states "The total disparate and conflicting decisions of the [Property Tax Appeal] Board, wherein a local county board of review has been found in default, represents a denial of due and fair process to this appellant. The complete lack of adherence to uniform rules relative to how this Board decides cases wherein an opposing party has been found to be in default, has created a non-uniform and inequitable review process, which has greatly and unfairly prejudiced the appellant's case."

Recommendation: Deny Emergency Motion for Further Consideration of No Change Decision.

The Motion states Reed-Custer C.U.S.D. #225-U, Exelon, and the Will County BOR are currently in negotiations to resolve all of the disputes for the 2012 and 2013 years. The Stay is for all parties to focus their attention and resources on a prompt and global resolution of this complex dispute. The resolution will require the approval of the Circuit Court of Will County. Counsel for the appeals have conferred with the Clerk of the Will County Board of Review and she agrees with this Joint Motion.

Recommendation: Grant Joint Motion for a 90-day Stay of Proceedings.
