Per correspondence received 6-24-14, Appellant's counsel is requesting the PTAB reinstate the above appeal stating the checklist with a deadline of 1-17-14 was not received, only the 6-3-14 dismissal letter. The letter, dated 12-18-13 and granting the extension, was not returned to the PTAB. This item has been carried over from the 8-13-14 Board Meeting.

eee. Terence Bradley: #13-00961-R-1 (Will)

Appellant originally filed with PTAB on 2-18-14. An initial review deemed the filing incomplete and a checklist was mailed to the Appellant with a deadline of 5-9-14. Appellant submitted information for the above appeal on 4-18-14 but the evidence was not sufficient to go forward and the appeal was dismissed on 8-1-14. Per correspondence received 8-14-14, Appellant states he is confused by the dismissal because someone from the BOR was to re-measure his property and change the property record card. Appellant indicates on appeal form that an incorrect description of the property is one basis of the appeal, however, Appellant failed to provide any evidence of how the property was incorrectly described. Appellant did include three comparables on the appeal form assessment grid but failed to provide any sales price or assessment information for comparative purposes.

fff. Kmart #4729: #11-28365-C-3 (Cook – W. Chicago)

Intervenor, Board of Education of the City of Chicago (CBOE), originally filed with PTAB on 12-6-13. A total of 120-days has been granted for the submission of evidence with the latest extension expiring on 4-25-14. Evidence was not received from the CBOE and a default letter was processed and mailed to the Intervenor's counsel on 6-27-14. Per correspondence received 7-31-14, Intervenor has submitted a Motion to Vacate Default and for Leave to File Evidence. Motion states the latest extension, expiring 4-24-14, was not received. Intervenor seeks to have the default vacated and a leave to adopt the evidence filed by the Cook County Board of Review. Letter dated, 3-26-14 and granting the extension, was not returned to the PTAB.

ggg. Truck Center Hopkins Properties: #12-00243-C-3 (Tazewell)

The Tazewell County Board of Review was notified of the above filing on 2-28-14. A total of 90-days was granted for the submission of evidence with a due date of 5-29-14. Evidence and/or the required Notes on Appeal were not received nor was an extension request so the BOR was defaulted on 7-1-14. Per correspondence received 7-29-14, the BOR has submitted a Motion to Vacate Finding of Default. Motion states the BOR inadvertently failed to calendar the deadline but the Taxpayer has a pending 2011 PTAB appeal for the same parcel with identical evidence. The BOR states its submission of evidence would be identical for the 2012 appeal as what is contained in the 2011 appeal.
