In each of the appeals listed above, Appellant originally filed with the PTAB in December of 2014. A total of 60-days has been granted for the submission of evidence. Appellant is requesting an additional 60-day extension to formulate legal arguments and compile evidence.

- e. Byron C.U.S.D. (Byron Station): #226: #13-01186-I-3 (Ogle)

Appellant originally filed with the PTAB on 3-4-14. A total of 180-days has been granted for the submission of evidence. Appellant is requesting an additional 90-day extension stating a nuclear power station requires extensive expert reports and a voluminous supportive evidence filing. The request further states that Byron C.U.S.D. #226 will be intervening in a 2013 filing with the PTAB for Exelon (Byron Station) and would like to make a single evidence filing that would cover both appeals. Exelon filed an appeal for the 2013 tax year on the same property which was assigned docket number 13-01853. The C.U.S.D. #226 has intervened in this 2013 appeal and was granted a 90-day extension expiring on 8-16-15.

The Peoria County Board of Review was notified of the above appeal on 2-6-15. A 90-day extension has been granted for the submission of evidence. The BOR is requesting an additional 90-day extension for the ongoing settlement negotiations for the current 2014 PTAB case along with any prior year and/or any subsequent year pending for this Appellant.

The BOR is requesting an additional 60-day extension to evaluate the Appellant's material and prepare a summation of value. Request further states the BOR has a small staff and a heavy workload.

(1.) Intervenor, Sunset Ridge S.D. #29, originally filed with the PTAB on 1-27-15. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 60-day extension to compile and submit evidence.

(2.) Intervenor, New Trier H.S.D. #203, originally filed with the PTAB on 1-26-15. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 60-day extension for the completion of an appraisal.

k. WSC-GSP 2400 Cabot Holdings VII, LLC: #13-04030-C-3 (DuPage)

Intervenor, College of DuPage #502, originally filed with the PTAB on 2-17-15. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 60-day extension to analyze the Appellant's evidence because, due to unforeseen circumstances, this has not been completed.

l. Our Gang Partners L.P.: #13-02537-I-2 (Lake)

Intervenors, Adlai Stevenson H.S.D. #125 and Aptakisic Tripp S.D. #102, originally filed with the PTAB on 1-27-15. A total of 90-days has been granted for the submission of evidence. Intervenors are requesting an additional 60-day extension to analyze the Appellant's evidence to determine whether or not an appraisal is needed. Due to unforeseen circumstances, this analysis has not occurred as of yet.

m. New Midwest Capital, LLC: #13-02500-C-2 (Lake)

Intervenors, Adlai Stevenson H.S.D. #125 and Kildeer Countryside C.C.S.D. #96, originally filed with the PTAB on 1-26-15. A total of 90-days has been granted for the submission of evidence. Intervenors are requesting an additional 60-day extension for the continued settlement discussions with the Appellant. Should this matter fail to settle, Intervenors require an extension to file evidence and/or a brief.

n. Fred Schwer Exelon Corporation: #11-05319-I-3 (DeWitt)

Intervenors, DeWitt County, Richland Comm. College #537, Clinton Unit S.D. #15, and Vespasian Warner Public Library, originally filed with the PTAB on 2-20-14. A total of 330-days has been granted for the submission of evidence.

Intervenors are requesting an additional 90-day extension for the completion of an appraisal. Request further states they are nearing the final stages of the evidence submission project, but due to the voluminous nature of the Appellant's evidence and the complexity and nature of the valuation problem, a 90-day extension is needed.

- o. Collinsville C.U.S.D. #10: #13-01158-C-3 (Madison)

Intervenor, Southwestern Illinois College #522, originally filed with the PTAB on 1-27-15. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 60-day extension to complete the evidence preparation.

- p. Delnor Community Health Care Foundation: #13-02523-C-3 (Kane)

Intervenor, Geneva C.U.S.D. #304, originally filed with the PTAB on 2-11-15. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 90-day extension to complete the review process of the Appellant's evidence in order to make a determination as to the need for an appraisal. The subject property is a 67,269 square foot health and fitness center.

- q. Nauvoo Inn & Suites: #13-00706-C-3 (Hancock)

Intervenor, City of Nauvoo, originally filed with the PTAB on 3-27-15. A total of 60-days has been granted for the submission of evidence. Intervenor is requesting an additional 90-day extension to allow for sufficient time to obtain an appraisal and other information on the four properties (only three separate properties have been appealed). Request further states that the appraiser initially contacted and retained has advised Intervenor that he has a conflict of interest. Secondly, Intervenor requests that a subpoena be issued to Nauvoo Inn & Suites to produce all records regarding income earned by the four properties from all sources (not just overnight stays) for the years 2007-2013 and for any and all records listing the properties for sale during the same time period.

- r. Steven Pron: #13-30008-I-2 (Cook – Leyden)

Intervenors, Addison Creek River Conservancy, City of Northlake, Northlake Fire Protection Dist., Northlake Public Library Dist., and S.D. #87, originally filed with the PTAB on 2-9-15. A total of 90-days has been granted for the submission of evidence. Intervenors are requesting an additional 60-day extension for the completion of an appraisal. Letter from appraiser (5-7-15) indicates that a 30-day extension is requested due to current work obligations.

- s. Graybar Electric Company, Inc.: #13-03347-I-2 (DuPage)

Intervenor, Marquardt S.D. #15, originally filed with the PTAB on 2-13-15. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 60-day extension for the completion of an appraisal. Letter from appraiser (5-13-15) indicates a 60-day extension is needed due to professional commitments.

- t. Marquardt School District No. 15: #13-03767-C-3 (DuPage)

Intervenor/Owner SVF Swift Center, LLC, originally filed with the PTAB on 2-11-15. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 60-day extension because evidence in support of the intervention is being prepared and is not ready at this time.

- u. Premsagar Mulkanoor: #13-30078-C-2 (Cook – Bloom)

Intervenor, City of Chicago Heights, originally filed with the PTAB on 2-3-15. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 90-day extension for the completion of an appraisal.

- v. Kmart #7289: #13-29056-C-2 (Cook – Bloom)

(1.) Intervenor, Bloom T.H.S.D. #206, originally filed with the PTAB on 1-20-15. A total of 120-days has been granted for the submission of evidence. Intervenor is requesting an additional 30-day extension to file additional written or documentary evidence.

(2.) Intervenor, Steger S.D. #194, originally filed with the PTAB on 1-26-15. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 60-day extension for the completion of an appraisal. Letter from appraiser (4-27-15) indicates appraiser is unable to meet the current evidence deadline because of professional commitments and requests a 60-day extension to complete the assignment.

- w. Patriot Courtyards Condo Assoc: #11-33072-C-3 (Cook – Northfield)

Intervenor, Glenbrook H.S.D. #225, originally filed with the PTAB on 2-23-15. A total of 90-days has been granted for the submission of evidence. Intervenor is requesting an additional 90-day extension for the completion of an appraisal. Letter from appraiser (5-19-15) explains that the property consists of 17 commercial condominiums with a total gross building area of 69,975, which is located within a larger property on a 275,493 square foot site. Appraiser further states an extension of 90-days is needed to complete this assignment.

- x. David Husman: #13-31931-C-2 (Cook – Niles)

Intervenors, Golf S.D. #67 and Niles T.H.S.D. #219, originally filed with the PTAB on 2-19-15. A total of 90-days has been granted for the submission of evidence. Intervenors are requesting an additional 90-day extension for the completion of an appraisal. Letter from appraiser (5-18-15) indicates the subject property is a 71,600 square feet, part one-story and part two-story office building on a 122,400 square foot site and that a 90-day extension is needed to complete the assignment.

- y. Jong Koo Kim: #13-31561-I-2 (Cook – Niles)

Intervenors, Niles Elementary S.D. #71 and Niles T.H.S.D. #219, originally filed with the PTAB on 2-19-15. A total of 90-days has been granted for the submission of evidence. Intervenors are requesting an additional 45-day extension for the completion of an appraisal. Letter from the appraiser (5-20-15) cites current workload as the reason for the 45-day extension request.

- z. BP America Inc.: #13-24888-C-1 (Cook – Bremen)

Appellant originally filed with the PTAB on 2-24-14. A total of 120-days has been granted for the submission of evidence with the latest being a **Final** extension (dated 12-22-14) and expired on 2-20-15. Appellant requested a 3<sup>rd</sup> extension of 60-days beyond the **Final** extension to compile evidence and formulate legal arguments. This request went before our Board at its 4-14-15 meeting and was denied. The Appellant was notified of the denial and the appeal closed for insufficient evidence on 4-21-15. Per correspondence received 5-12-15, Appellant is requesting the appeal be reinstated stating the latest extension letter from the PTAB dated 12-22-14 that they received did not indicate it was a Final extension. Letter from PTAB in file is stamped “Final”, however, letter to Appellant was not stamped “Final”.

- aa. Nancy Lazzarro: 13-01648-R-1 (Lake)

Appellant, represented by counsel, originally filed with the PTAB on 3-10-14. An initial review determined there was insufficient evidence and a checklist with a 30-day extension was mailed to counsel on 5-6-14. Counsel responded timely with an extension request for the submission of a misplaced appraisal. Evidence was not returned and the appeal was dismissed on 9-8-14. Per correspondence received from Appellant (not counsel) on 4-24-15, Appellant is requesting the PTAB reinstate the 2013 appeal and have resubmitted 3 appeal forms with evidence but no assessment amounts or Appellant requested amounts.
