Cook County Board of Review Motion to Vacate Default Judgement

The Cook County Board of Review was notified of the appeals on March 1, 2018 and was granted a 90-day extension to submit evidence with a due date of May 30, 2018. On April 30, 2018, Cook County requested the PTAB grant an additional 90-day extension of time to submit evidence. On May 30, 2018, Cook County was granted a 60-day extension to submit evidence with a due date of July 29, 2018. Cook County stated they prepared evidence in response to the Appellant's case and issued Notes on Appeal dated April 18, 2018. PTAB did not receive any evidence after September 28, 2018. On October 4, 2018, PTAB issued notice to the BOR that it was in default.

The board of review asserted that as a course of business, when the Cook County BOR receives a PTAB file it generates an electronic document that is inputted into two different databases. When the Board of Review generates a response to PTAB, it does in the form of Notes of Appeal that is electronically transmitted to PTAB through the IL Central Management System. There is no record or electronic indication that the Board did not send the evidence in response. The Board, within its own database, contains the triggering document known as the Notes on Appeal dated April 18, 2018 – during the time the response was required.

The Board of Review requests that PTAB:

1. Vacate its finding of default
2. Make the Board of Review's submission a part of the instant record
3. Amend its docket to indicate the Board of Review timely submitted evidence; or
4. In the alternative, the Board of Review would ask for a hearing on the instant Motion to Vacate Default Judgement.

PTAB's IT staff have done an exhaustive search of all the evidence that Cook County has transferred to electronically and there is no evidence that was transferred for #16-38303 or #16-38647. They have kept a log file and copies of everything that has been transmitted electronically from Cook County in the raw format that was sent. The files were not listed in any data export file transmitted to PTAB from 3/29/2018 to 10/18/2018 (the last time evidence was processed). IT did a full text search of all the PDF files that were transmitted from 3/29/2018 to 10/18/2018 to see if the file was transferred but was not included on a data export file and did not find any matches. The motion makes no mention of when the files were supposedly transmitted but does state that the Notes on Appeal were generated on 4/18/2018. The County then asked for an extension on 4/30/2018 for these two files along with many others. They were granted a final 60- day extension beginning on 5/30/2018. No evidence was received by PTAB during

that extension of time. The evidence that they included as Exhibit D with the motions has a date of 11/2/2018 at the bottom of the pages, which seems suspect. If the Notes and Evidence were transmitted before the deadline, they should have a copy with valid dates.

#### Joint Motion to Stay Proceedings

Appellant, West Suburban Bank, Respondent, the Kane County Board of Review and Intervenor, City of Aurora and West Aurora S.D. #129 jointly move the PTAB to stay appeals for certain tax years pursuant to the terms described herein, for the following reasons:

1. Appellant is the owner of certain real property located at 2000 West Galena Boulevard in Aurora, Kane County, Illinois, further identified by permanent index number 15-19-276-031 and hereinafter referred to as the "subject property."
2. Appeals for tax years 2016 and 2017 are currently pending before PTAB under dockets 16-01189 and 17-00301
3. The Parties have drafted and executed a settlement agreement which resolves all outstanding PTAB matters for the 2016 and 2017 tax years.
4. Said agreement contemplates the dismissal of all pending PTAB matters upon certification of values as agreed to in subsequent years.
5. Upon certification of the 2018 assessment of the subject property by the Kane County Board of Review, the Appellant will move to dismiss its pending PTAB case for the 2016 tax year, docket #16-01189.
6. Upon certification of the 2019 assessment of the subject property by the Kane County Board of Review, the Appellant will move to dismiss its pending PTAB case for the 2017 tax year, docket #17-00301.
7. The Kane County BOR and the Intervenor shall not object to Appellant's request for a dismissal of said appeals.
8. The Parties agree to diligently review the assessment in subsequent years and will promptly move to dismiss the pending appeals pursuant to the time frames described herein, or the Parties will promptly notify the PTAB if the stay should be removed.
9. The Parties agree that a stay of proceedings would be beneficial to the Parties and would conserve efficient use of the PTAB's resources while the Parties await certification of values in subsequent years.
10. The Parties agree that a stay of proceedings would bring accountability to the Parties pursuant to the settlement agreement, and that a stay will help secure a fair resolution of these proceedings while protecting the rights of the Parties in the event of a breach of the agreement.

The Parties respectfully request that the PTAB stay all proceedings related to the 2016 and 2017 appeals (docket #16-01189 and #17-00301), including procedural and statutory evidence filing deadlines, as of the date of execution of this joint motion.

#### Motion to Stay

The Kankakee County Board of Review (BOR) was notified of the appeals on Tuesday, August 14, 2018 and was granted a 90-day extension to submit evidence with a due date of Monday, November 12, 2018 (Veterans Day). On Wednesday, November 14, 2018, Kankakee County is requesting an 90-day extension of time after the decision of the Appellate Court for #13-00178. The BOR asserted:

1. On June 19, 2018, the PTAB issued a Final Administrative Decision finding a reduction in the assessment of the subject property for the 2013 tax year.
2. There is currently a pending Appeal of that Decision before the Appellate Court of Illinois Third Judicial District Case No. 3-18-0384, Manteno C.S.D. #5 vs. IL PTAB.
3. The Appellant in the above referenced cases have filed Direct appeals for the tax years of 2014 and 2015 based on the favorable decision.
4. The Kankakee BOR was given until November 12, 2018 to file its evidence, but due to a clerical error of recording the date as November 21, 2018, the Kankakee County Board has missed that deadline, by two days.
5. This request is not to delay the proceedings but to submit full and complete evidence on the subject matter and possible settlement based on the Appellate Court's ruling.
6. This is the Board of Review's first request for an extension in this case.

#### Lake County Board of Review Motion to Vacate PTAB's Order of Default

The Lake County Board of Review was notified of the appeal on January 18, 2018 and was granted a 90-day extension to submit evidence with a due date of April 18, 2018. On October 25, 2018, Lake County Board of Review was defaulted for failure to submit evidence. On November 4, 2018, the PTAB received a motion to vacate the default due to the filing being missed. PTAB appeals are sent to the LCBOR via email. When the email is received, a staff member of the LCBOR follows the link and then manually drags and drops each appeal PDF into the LCBOR's docket. In extraordinarily rare circumstances, like here, a filing may be missed. In this instance, the appeal for the Subject Parcels was mistakenly never added from the PTAB's system into the LCBOR system. Therefore, none of the individual LCBOR staff who handle evidence submission for PTAB cases were aware of the appeal. It was only upon receipt of PTAB's October 25, 2018, correspondence giving notice of a default that the LCBOR learned of the pending appeal. The Lake County Board of Review request that the order of default be revoked and that they be given an opportunity to submit evidence in this matter.

Lake Park H.S.D. #108, Itasca S.D. #10, Itasca Park District, Itasca Fire Protection District and Itasca Community Library. On May 18, 2018, the Intervenors requested an additional 90-day extension of time to complete their review of the taxpayer's evidence and determine the need for an appraisal. On July 12, 2018, the Intervenors were

granted a Final 90-day extension with a due date of October 10, 2018. On November 2, 2018, the PTAB received a Motion to File Evidence, Instantly. On October 10, 2018, the Intervenors complied with the PTAB's July 12, 2018, notice by submitting its evidence. On November 1, 2018, Intervenors discovered via a UPS return envelope that the October 10, 2018, evidence submission was inadvertently send to the incorrect address and was therefore not received by the PTAB. - a. Executive Order Rulemaking - 42 Ill.Reg. 2862, published 3/2/18.



At its meeting of Tuesday, November 13, 2018, the Joint Committee on Administrative Rules consider the above rulemaking

At its meeting on November 13, 2018, JCAR voted to object to the above-referenced rulemaking and prohibit its filing with the Secretary of State. JCAR found adoption of this rulemaking would constitute a serious threat to the public interest, safety or welfare. The reason for the objection was based JCAR's conclusion that the PTAB has no statutory authority to take the action embodied in the rulemaking, and the finding that the rulemaking represents a severe threat to the public interest.

In its statement of objection, JCAR stated the agency is prohibited from filing the rulemaking with the Secretary of State or from enforcing the rulemaking for any reason for as long as the Filing Prohibition remains in effect.

JCAR sent its Certification of Objection to and Prohibition Against Filing of Proposed Rulemaking on November 13, 2018.

Pursuant to Section 220.1200 of JCAR's rules ((1 Ill.Admin.Code 220.1200) the PTAB is to respond to JCAR's objection within 90-days of receipt.
