 - a. Presbyterian Homes: #22-28548.001 thru .131-R-3 (Cook) (Evanston)

Intervenor's Motion for Leave to File Evidence Instanter

Presbyterian Homes' multi-parceled appeal of 131 parcels from a Cook County Board of Review (CCBOR) Final Decision Letter was timely submitted. The appeal seeks a change in assessment from \$4,970,494 to \$3,100,000. The appellant indicated a recent appraisal as the basis.

Timeline

- 07/06/2023 - PTAB accepted the appellant's appeal and notified CCBOR.
- 07/19/2023 - the CCBOR certified that copies of the above petition were sent to all taxing districts.
- 07/23/2023 - Evanston – Skokie Community Consolidated School District 65 (the Intervenor) filed to intervene in the above appeal proceeding.
- 09/14/2023 - PTAB added the Intervenor as an interested party in the appeal with a due date of 12/13/2023, to file evidence or request an extension.
- 12/11/2023 – The Intervenor requested a 90-day extension to submit evidence.

- 12/21/2023 – PTAB granted a final 90-day extension with a due date of 03/20/2024.

On 03/26/2024, the Intervenor submitted this Motion for Leave to File Evidence Instanter. The Intervenor states as follows:

- On 03/20/2024, the Intervenor received from its appraisal expert an Appraisal Review Report with a Revised Opinion of Market Value prepared by Eric W. Dost of Dost Valuation Group, Ltd.
- 03/20/2024, counsel for the Intervenor prepared a letter addressed to PTAB and a certification under the Illinois Code of Civil Procedure Section 1-109 attesting to the service of the evidence via FedEx Express Overnight Priority with tracking number 7756 1450 6790.
- The letter to PTAB and the certification were addressed to the PTAB Springfield office. However, the envelope with the material was accidentally addressed to the law firm at 300 S. Wacker Dr., Suite 3400, Chicago, IL.
- Mary Sullivan, Legal Assistant with Franczek P.C. since 10/02/2006, worked from home on 03/20/2024 and prepared the FedEx envelope enclosing the evidence. However, Ms. Sullivan addressed the letter to the law firm instead of PTAB, which was a mistake.
- Ms. Sullivan also emailed a listing of filings made to PTAB administrative members on 03/20/2024.
- The intervenors contend that the U.S. Supreme Court and courts in Illinois have found that when a failure to comply with a filing deadline is attributed to negligence, the failure to comply may be deemed “excusable neglect.”
- The Intervenor avers the length of delay and the potential impact on the defendant and the judicial proceedings are minimal. The delay was due to a simple inadvertent clerical mistake, and the school district attempted to file the evidence in a timely manner and believed it was timely filing the evidence in good faith.

The Intervenor requests that PTAB allow the Intervenor to file its evidence in this appeal instanter.

On 03/26/2024, the CCBOR informed PTAB that it has no objection to the Intervenor's motion to file evidence instanter.

- b. Pangea Equity Partners: #19-41243.001-C-1 (Cook) (Hyde Park)

Appellant's Motion to Reconsider

Pangea Equity Partners filed this timely appeal from a Cook County Board of Review (CCBOR) Final Decision Letter seeking a change in assessment from \$165,907 to \$88,000. The appeal is based on a recent appraisal.

Timeline

- 11/05/2020 – PTAB accepted the appellant's appeal and notified CCBOR, with a due date of 02/03/2021.
- 02/27/2024 – The parties to the appeal stipulated to the assessment of the property.
- 04/16/2024 – PTAB found the agreement of the parties was proper, and the correct assessed valuation of the property is \$11,372.

On 04/17/2024, the appellant filed its Motion for PTAB to Reconsider its decision of 04/16/2024 and allow the appellant to correct a scrivener's error as follows:

- The appellant and the CCBOR entered into a settlement agreement placing a final value of \$111,372 on the property for tax year 2019.
- On 04/16/2024, the appellant noticed there was a scrivener's error in the signed stipulation signed on 02/27/2024 that incorrectly set the value at \$11,372 and the correct value should be \$111,372.
- The appellant contacted the CCBOR on 04/16/2024 and notified them of the scrivener's error and on 04/17/2024 a new stipulated settlement was signed by all parties setting the 2019 value at \$111,371.

The appellant requests PTAB reinstate the above appeal and grant an updated final administrative decision setting the 2019 value at \$111,372.

- c. Jyotirmoy Saha: #19-09648.001-R-1 (Adams)
Jyotirmoy Saha: #20-09449.001-R-1 (Adams)
Jyotirmoy Saha: #21-08132.001-R-1 (Adams)
Jyotirmoy Saha: #22-04713.001-R-1 (Adams)

Appellant's Request to Reinstate Appeals

On the postmarked date of 03/14/2024, Appellant, Jyotirmoy Saha submitted a request for an extension to file the above appeals from a favorable PTAB Decision Letter dated 01/16/2024. The deadline to file a direct appeal is 30 days after the PTAB's decision –

in this case 2/15/2024. The appellant requested an extension until 03/20/2024 to prepare and send appeals to PTAB as follows:

- The appellant avers he missed the deadline due to two factors.
- First the appellant had to travel between 01/19/2024 – 02/10/2024 to attend to his mother’s health condition in India and enclosed his flight itinerary for those dates.
- Second, the appellant found the PTAB decision letter dated 01/16/2024 in his mailbox on 02/16/2024. The letter was already open and devoid of the envelope. The appellant informed in the past such incidents have occurred albeit not common where their mail and packages were delivered to a wrong address by USPS, UPS, and FedEx, but mostly the mail is redelivered to their mailbox by residents in the locality.
- The appellant requests due to family hardship and circumstance beyond his control, PTAB honor and evaluate the above appeals. The appellant also requested that PTAB use a more secure form of mail and follow it up with an email letting the appellant know of a time frame to anticipate the mail.

On 04/04/2024, PTAB found the appellant’s appeal was untimely and the appeal was dismissed.

On 04/15/2024, the appellant submitted a Motion to Reinstate the above appeals and claims he did not receive the PTAB Decision Letter dated 01/16/2024 until 02/16/2024. The appellant contends he filed the above appeals on 03/14/2024, well within the 30-day period of appeal, as the appellant calculates it. The appellant also included copies of their travel information.

The appellant requests PTAB reinstate the above appeals as the appellant avers, he responded within 29 days of *receipt* of the favorable decision letter from PTAB.

- d. Sheldon Hoffman: #20-36162.001-C-1 (Cook) (Hanover)

Motion to Vacate Decision

The timely appeal of Sheldon Hoffman from a Cook County Board of Review (CCBOR) Final Decision Letter sought a change in assessment from \$85,000 to \$75,000, with a basis of recent appraisal.

Timeline

- 08/05/2021 - PTAB accepted the appellant's appeal and notified CCBOR, with a due date of 11/03/2021.
- 03/13/2024 – The parties of the appeal stipulated to the assessment of the property.
- 04/16/2024 – PTAB found the agreement of the parties was proper and the correct assessed valuation of the property is \$88,500.

On 04/18/2024, the appellant filed its Motion to Vacate Decision as the assessor's office provided an automatic COVID-19 reduction in 2020 causing the assessed valuation (\$85,000) to be lower than the stipulation / PTAB decision.

- e. Sheldon Hoffman: #21-46326.001-C-1 (Cook) (Hanover)

Motion to Vacate Decision

The timely appeal of Sheldon Hoffman from a Cook County Board of Review (CCBOR) Final Decision Letter sought a change in assessment from \$85,000 to \$75,000, with a basis of recent appraisal.

Timeline

- 03/02/2023 - PTAB accepted the appellant's appeal and notified CCBOR, with a due date of 05/31/2023.
- 03/13/2024 – The parties of the appeal stipulated to the assessment of the property.
- 04/16/2024 – PTAB found the agreement of the parties was proper and the correct assessed valuation of the property is \$88,500.

On 04/18/2024, the appellant filed its Motion to Vacate Decision as the assessor's office provided an automatic COVID-19 reduction in 2020 causing the assessed valuation (\$85,000) to be lower than the stipulation / PTAB decision.

- f. Gregory Pape Revocable Trust: #23-04169.001 (Will)

Appellant's Motion to Reinstate Appeal

The untimely appeal of Gregory Pape Revocable Trust from a Will County Board of Review (WCBOR) Notice of Final Decision Letter sought a change in assessment from \$911,795 to \$491,667. The basis of the appeal is a recent appraisal.

On 04/04/2023, PTAB found the appellant's petition was untimely and dismissed the appeal for lack of jurisdiction.

On 04/17/2024, the appellant filed a Motion to Reinstate as follows:


- The appellant avers WCBOR failed to provide proper notice to the appellant and the appellant had no way of filing an appeal with PTAB within 30 days of the written notice of the decision by the Board of Review.
- The appellant appealed to the PTAB within 30 calendar days of *receiving* a copy of the written notice of the decision by WCBOR via USPS mail.
- Pursuant to Section C-18 of the WCBOR Rules and Procedures, "upon completion of the Board of Review cycle, the official findings for each case will be posted on the Board of Review website at www.willcountysoa.com and mailed to all complainants." The written notice of the decision by the Board of Review is dated 01/24/2024. However, notice of the decision was never posted to the Board of Review website. And as of 04/17/2024, there remains no notice of any decision related to this appeal on the Board of Review website despite the notice requirement pursuant to the Will County Board of Review Rules and Procedures.
- The attorney of record for the above appeal has never received any notice of any decision related to the above appeal via mail or otherwise.
- The attorney of record contends their office was made aware that a decision was rendered through a notice received by the property owner. However, the notice arrived in the appellant's mailbox on 02/26/2024, more than 30 days after the date stated in the notice. And the appellant has enclosed a signed affidavit attesting thereto. Therefore, the appellant had no way of appealing to PTAB within 30 days of the date stated in the notice.
- In a good faith effort to comply with the rules of PTAB, counsel for the appellant submitted an appeal to PTAB within 30 calendar days of the client receiving the notice via USPS mail.
- In addition to the above reference enclosure, a screenshot of the online docket, which shows no evidence of any decision having yet been rendered for the 2023 appeal of the assessment for the subject property, is enclosed.

In the interest of fairness and equity, the appellant requests PTAB reinstate the above appeal and render a decision based on the evidence provided.

g. St. Clair Square SPE, LLC: #22-03199.001 thru .005-C-3 (St. Clair)

Joint Motion to Amend Decision

The timely multi-parceled appeal of St. Clair Square SPE, LLC from a St. Clair County Board of Review (SCCBOR) Final Decision sought a change in assessment from \$29,362,920 to \$21,289,737, with a basis of recent appraisal.

Timeline

- 07/27/2023 - PTAB accepted the appellant's appeal and notified SCCBOR, with a due date of 10/25/2023.
- 03/20/2024 – The parties of the appeal stipulated to the assessment of the property of two parcels (03-27.0-100-079 and 03-27.0-100-088) and agreed to the withdrawal of the remaining three parcels.
- 04/16/2024 – PTAB found the agreement of the parties was proper.

On 04/29/2024, St. Clair SPE, LLC and SCCBOR jointly filed a Motion to Amend Decision as follows:

- The appellant and respondent request that the decision issued on the above docket be amended.
- The appellant prepared and sent to the SCCBOR a stipulation for signature with the correct total assessed value agreed upon by the parties; however, the stipulation mistakenly indicated an increase in the assessed value on parcel 03-27.0-100-079.
- The parties would like to correct the breakdown of the assessments between the two parcels as follows:
 - 03-27.0-100-079, Land \$1,737, 240, Improvement \$767,869, and total \$2,505,109.
 - 03-27.0-100-088, Land \$5,471,180, Improvement \$14,023,711, and total \$19,494,891.

The appellant requests that PTAB reissue an amended decision on the above docket per the amended stipulation and agreement of the parties.
