Relevant Fact to Appellants' Motion for Stay of Proceedings

- 03/28/2024 - PTAB granted the appellants an extension to 06/26/2024 to submit evidence.
- 04/9/2024 – April Board Meeting

- Attorney Michael Andre appeared at the board meeting and represented that he was the attorney for the taxpayer, GE-Hitachi.
- Based on the staff's recommendation, the Board continued this matter, requesting that the appellants appear before the board to present their motion.

Appellants' Motion

On 03/28/2024, the appellants submitted a Motion for Stay of Proceedings as follows:

- The appellants claim that the GE-Hitachi Morris Operations is an NRC-licensed independent spent fuel storage installation (ISFSI) that provides wet storage of spent nuclear fuel assemblies from nuclear power stations in Connecticut, California, Minnesota, Nebraska, and Illinois. It is the only away-from-reactor commercial ISFSI in the entire country.
- There are currently two appeals pending before the PTAB regarding the GE-Hitachi Morris Operations for 2021 and 2022 assessment years. There are several first impressions presented for the PTAB's determination in the 2021 or 2022 assessment appeals that may be subject to further review by the Appellate and Supreme Courts. Resolution of these issues in the 2021 and 2022 appeals could significantly limit the magnitude, complexity, and costs of the evidentiary filings for the tax year 2023 and subsequent years.
- A stay in the 2023 and subsequent appeals pending final resolution of the 2021 and 2022 appeals and determined issues would streamline the evidence and trial of the 2023 and subsequent appeals, thereby allowing the parties and PTAB to avoid considerable expense without detriment to any party.

The appellant requests that PTAB issue a stay of proceedings.

Relevant Timeline

- 03/14/2024 - PTAB found the appellant's petition was incomplete and requested additional information with a due date of 04/13/2024. The appellant was informed that his sales data from 2015 through 2017 was not relevant to the tax year under appeal.
- 03/21/2024 - The appellant responded to the incomplete checklist. The appellant changed the basis of his appeal to assessment equity.
- 04/04/2024 - PTAB found the appellant's appeal was incomplete a second time and requested corrections with a due date of 05/04/2024.
- 04/09/2024 - The appellant responded to the incomplete checklist. He changed the basis of appeal to comparable sales and assessment equity but did not cure all defects with his petition.
- 04/18/2024 - The appellant's appeal was dismissed for failure to comply with the incomplete checklist.
- 4/25/2024 - The appellant called PTAB's office and spoke with a staff member.

Appellant's Motion

On 05/04/2024, the appellant submitted a corrected appeal form and a Motion to Reinstate as follows:

- The appellant admits to the mistakes in his appeal because he was confused between the terms market and assessment value.
- The appellant did not understand the word “assessment” in the PTAB application until it was explained by administrative staff in the PTAB office, as English is not the appellant’s native language.
- The appellant claims the data collected for Section V was initially obtained from stcharlestownship.org, which only has the market values. The appellant thought this number was the same as the assessment value. However, the appellant recorded the correct assessment value listed in Section II, 2c because he obtained the information from the Kane County Board of Review Notice of Findings.
- The appellant received the two incomplete letters from PTAB, and after calling the PTAB office for assistance, he did not immediately determine his mistake.
- The appellant now understands the difference between assessment value and market value and has obtained the correct assessment value from the Kane County Property Tax Inquiry.

The appellant is requesting that PTAB accept his apology and reinstate his appeal.

- 03/28/2024 - PTAB scheduled the above appeal to be heard upon its merits on 06/24/2024 at 1 p.m.

Appellants' Motion

On 05/03/2024, the appellants submitted their Motion to Stay and Motions for issuance of subpoenas as follows:

- This 2020 appeal follows a previous appeal to PTAB for the 2019 tax year (19-24215). There are also PTAB appeals concerning the subject property for tax years 2021 through 2023 (21-21945, 22-25725, & 23-22538).
- The Historic Residence Assessment Freeze Law (35ILCS 200/10-40 et seq.) ("Freeze Law") is at issue in each of the PTAB appeals. The primary issue for each tax year is the fair cash value of the subject property during the 2016 "base year valuation."
- PTAB conducted a hearing on 10/17/2023 for the 2019 appeal and issued a "No Change" after holding that the appellants had not proven by a preponderance of the evidence that the subject property was overvalued during the 2016 base year.

- The PTAB 2019 decision is currently pending an Administrative Review in the Circuit Court of Cook County due to errors the appellants contend were made by PTAB.
- A status hearing on the Complaint for Administrative Review is scheduled for 07/19/2024, and the court is expected to set the matter for oral arguments.
- The ruling on the 2019 Administrative Review Complaint will have a substantial and direct impact on the 2020 appeal and the other appeals for this subject property.
- The judicial economy mandates that the 2020 appeal be stayed until the 2019 Administrative Review is resolved.
- The appellants also request a subpoena to compel Darius Bryjka, Reviewer for the State Historic Preservation Office of the Illinois Department of Natural Resources, to attend and testify at the hearing for the 2020 PTAB appeal. The appellant contends PTAB ruled during the 2019 hearing of the above subject property, that Mr. Bryka's Declaration should be given no weight, since he was not present at the hearing to offer testimony or to be cross-examined.
- Additionally, the appellants request a second subpoena to compel the Office of the Independent Inspector General to produce official records in the Inspector General's possession. The Inspector General issued a report that recommended the Cook County Assessor improve the Assessor's administration for properties qualifying under the Freeze Law. The appellant avers PTAB declined to consider this report during the 2019 hearing of the above subject property.

The appellant requests that PTAB stay the 2020 appeal hearing and issue the requested subpoenas.

- 05/09/2024 – PTAB dismissed the above petition due to a lack of jurisdiction. The appellant filed on 04/10/2024 from a McHenry County Board of Review Notice of Final Decision dated 03/08/2024 - two days late.

Appellants' Motion

The appellants submitted their request for reinstatement as follows:

- At the time of completing the above appeal, the appellants' son, who is a doctoral student at Bradley University, was experiencing dire health issues. The appellants contacted staff in the PTAB office to determine the latest postmark date by which they were required to send the petition, and the appellants were informed that the appeal was due 30 days from the date the appeal was *received*. The appellants informed us that the Notice of Final Decision was dated 03/08/2024 and received on 03/11/2024. The appellants contend they were told the due date was 04/10/2024.
- The appellants contend they sent their appeal by USPS on the date they were informed it had to be postmarked, but the postmaster had issues with his bar

code scanner, even though the appellant wrote the address in big ink on the front of the envelope.

- The appellants' petition was mistakenly sent to Bonneau, SC. After many calls to the Springfield USPS Customer Service Support, it was intercepted and finally made its way to PTAB.
- The appellants have spent many hours preparing their appeal amidst trauma and tragedy. They would appreciate PTAB reinstating their appeal as they have suffered a 28% increase in assessed equalized value over last year's assessment.
