Relevant Fact to Appellant's Motion to Reinstate

- 02/29/2024 - PTAB accepted the above appeal and notified the Kane County Board of Review (CBOR) of the appeal with a due date of 05/29/2024.
- 03/25/2024 – Kane CBOR submitted a Motion to Dismiss appeal with proof of service to the appellant as follows:
 - The taxpayer appealed to PTAB before exhausting the administrative remedy of filing an assessment complaint with Kane CBOR for the 2023 tax year as required under 35 ILCS200/16-160.
 - The appellant did not file an appeal with Kane CBOR for the 2023 year.
 - Additionally, the taxpayer did not receive a decision lowering the assessment of the parcel in a prior year within the same general assessment period as the 2023 tax year.
 - Therefore, PTAB does not have jurisdiction to hear the direct appeal.

- 05/01/2024 – After thirty-seven (37) days had lapsed from the date of notice from the County to the appellant, the PTAB dismissed the appeal due to the appellant's failure to respond to the County's motion.

Appellant's Motion

On 05/13/2024, the appellant submitted this Motion for Reinstatement as follows:

- The appellant filed a residential appeal with PTAB on or about 02/15/2024 in a timely manner.
- 05/01/2024, PTAB sent the appellant notice that a Motion to Dismiss had been filed by the respondent, and the instant appeal had been dismissed for lack of response to the dismissal motion.
- Pursuant to PTAB procedural rule Section 1910.40(b) (86 Ill. Admin. Code Sec. 1910.40(b)):
 - If the board of review objects to the Board's jurisdiction it must submit a written request for dismissal of the petition prior to the submission of the Board of Review Notes on Appeal and accompanying documentation. The request for dismissal must set forth the basis of the board of review's objections to the PTAB's jurisdiction over the appeal. In these cases, the PTAB shall transmit a copy of the request for dismissal to the contesting party and secure a written response to the request for dismissal from the contesting party within 30 days after the date of the notice of the filing of the motion to dismiss.
- The appellant's counsel did not receive a copy of the Motion to Dismiss from the respondent or PTAB, and PTAB did not order a briefing schedule.
- As such, the appellant requests that the instant appeal be reinstated, that the appellant be served with the Motion to Dismiss, and that a reasonable amount of time be allowed to respond to the Motion.
- The motion is made in good faith, and no party will be prejudiced.

The appellant requests that PTAB enter an order reinstating the above appeal.

County's Response to Motion

On 05/31/2024, Kane CBOR responded to the Appellant's Motion to Reinstate as follows:

- Kane CBOR provided a copy of the USPS Certified Mail Receipt that was stamped by the US Postal Service as "received" on 03/25/2024. The receipt shows the County mailed a copy of the Motion to Dismiss to Attorney Jessica Hill-Magiera at 790 Harvest Dr., Lake Zurich, IL 60047.

- The USPS tracking results show a notice was left, with no authorized recipient available on 03/27/2024 at 12:11 p.m. The item then went unclaimed.
- Kane COB avers it has shown they sent a copy of the Motion to Dismiss to the appellant's counsel. The attorney did not respond to the USPS's notice that a delivery attempt was made and never retrieved the package.
- Therefore, Kane CBOR asks PTAB to uphold the dismissal of this appeal.

Relevant Fact to Appellant's Motion to Reinstate

- 11/30/2023 - PTAB accepted the above two appeals and notified Kane County Board of Review (CBOR) of the appeals with a due date of 02/28/2024 for each appeal.
- 01/11/2024 – Kane CBOR submitted a Motion to Dismiss appeal with proof of service to the appellants as follows:
 - The taxpayers filed appeals to PTAB before exhausting the administrative remedy of filing an assessment complaint with Kane CBOR for the 2023 tax year as required under 35 ILCS200/16-160.
 - The appellants did not file appeals with Kane CBOR for the 2023 year.
 - Additionally, the taxpayers did not receive a decision lowering the assessment of the parcel in a prior year within the same general assessment period as the 2023 year.
 - Therefore, PTAB does not have jurisdiction to hear the direct appeals.
- 02/29/2024 – By an email from ALJ Kirbach to counsel for the appellants, PTAB provided notice and copies of the individual Motion to Dismiss based on jurisdictional grounds for Docket Nos. 23-00024, 23-00043, and 23-00044.
- 03/04/2024 – By email to PTAB, Counsel for the appellants confirmed receipt of the Motion to Dismiss from Kane County for Docket Nos. 23-00024 and 23-00044, but not Docket No. 23-00043.
- 03/04/2024 – By email, ALJ Kirbach instructed the Kane BOR to send the appellant's attorney a copy of the Motion to Dismiss. ALJ Kirbach copied the appellant's attorney on that email.
- 3/5/2024 - By email, Kane CBOR provided a copy of the Motion to Dismiss for Docket No. 23-00043.
- 04/24/2024 – The PTAB dismissed the above appeal because the appellant failed to respond to the motion. The dismissal stated that the case was dismissed because the appellant did not respond within 21 days of notice of the motion. The case was dismissed on 4/24/2024, which is 55 days from the date of notice from PTAB on 02/29/2024.

Appellants' Motions

On 05/24/2024, the Appellants submitted a Motion to Reinstatement as follows:

- PTAB did not issue an order setting forth a briefing schedule for the Motion to Dismiss.

- 04/24/2024, PTAB sent the appellants notice their appeals had been dismissed. The letters did not discuss the merits of the BOR's Motion to Dismiss or whether PTAB had jurisdiction to hear the instant appeals, but instead, PTAB dismissed the appeals for lack of response to the pending Motion to Dismiss.
- PTAB cited 86 Ill. Admin. Code Section 1910.64(d), Motion Practice – Service of Papers, which states within 21 days after service of a motion a party may file a response to the motion. If no response is filed, the party shall be presumed to have waived objection.
- However, section 1910.40(b) addresses a board of review's response to a petition and objections to jurisdiction. Section 1910.40(b) of 86 Ill. Admin. Code states:
 - If the board of review objects to the Board's jurisdiction it must submit a written request for dismissal of the petition prior to the submission of the Board of Review Notes on Appeal and accompanying documentation. The request for dismissal must set forth the basis of the board of review's objections to the PTAB's jurisdiction over the appeal. In these cases, the PTAB shall transmit a copy of the request for dismissal to the contesting party and secure a written response to the request for dismissal from the contesting party within 30 days after the date of the notice of the filing of the motion to dismiss.
- The appellants' counsel avers in the past PTAB has sent the counsel a copy of all filings by the Board of Review, Intervenors, or any official correspondence from PTAB, accompanied by an order setting forth the date by which the appellant must respond if required.
- While Section 1910.64(d) provides for waiver of objection if no response to a motion is made; section 1910.40(b) does not mention a waiver or dismissing an appeal without a decision on the merits of a motion based on jurisdiction. Furthermore, the two sections of PTAB's procedural rules discussed herein are in conflict regarding the manner of serving the appellant and the amount of time given in a briefing schedule.
- Based on a reading of and in reliance upon the applicable rules and past practices, the appellants' counsel waited for PTAB to set a briefing schedule on the Motion to Dismiss instead of submitting the appellants' responses to the motion.

The appellants request that PTAB reinstate the above appeals and allow a short and reasonable time to respond to the Motion.

- 05/23/2024 – PTAB found the appellant's appeals were not filed in a timely manner; therefore, PTAB lacked jurisdiction and dismissed the appeals.

Appellants' Motions

On 05/31/2024, the appellants' counsel submitted a Motion to Reinstate and Vacate Dismissal Orders as follows:

- Cook County Board of Review (CCBOR) updated its Re-Review /Decision Dates Form between transmittals, and the CCBOR changed the transmittal dates for approximately 15 townships. Counsel avers as of the date of this motion, the CCBOR's website contained incorrect transmittal dates for many townships, and in many cases, the correct transmittal date is mistakenly listed as the CCAO Certification Date.
- Counsel used the last column of the CCBOR Re-Review / Decision Dates Form as the transmittal date, as the last column contained the correct transmittal dates for Oak Park, Berwyn, and River Forest townships.

Counsel filed the majority of his PTAB cases from these townships. In doing so, counsel also filed cases using the last column of this form on 05/13/2024, which was within 30 days of 4/15/2024, the date listed as the CCAO Certification Dates, which counsel assumed was the transmittal date. Upon receipt of the dismissal letters, the attorney discovered the discrepancies in the transmittal and brought the issue to the CCBOR. Counsel states that the CCBOR understands the problem and would not object to reinstatement of these cases. Counsel was encouraged to file this motion to reinstate.

- PTAB published guidance on its website regarding the issues with the transmittal dates, and it noted that attorneys should include a brief explanation of their reliance on the previously published schedule if they found themselves outside of the jurisdictional timeframe. At the time of filing, counsel did not believe he was outside of the timeframe and did not include a brief.
- Counsel states this is the first year CCBOR included the CCAO Certification Date on the Re-Review / Decision Dates form, and this is the main reason for counsel's confusion surrounding the correct transmittal dates and corresponding filing periods.
- PTAB also stated that any motion challenging PTAB's jurisdiction would be handled on a case-by-case basis. Counsel contends given his reliance on the CCBOR schedule that mixed up the transmittal dates with CCAO certification dates, CCBOR not objecting to reinstatement, and the fact the appeals were only a few days delinquent, counsel prays PTAB will vacate the motions to dismiss on each case. Further, if PTAB does not believe reinstatement of all appeals is appropriate, counsel requests additional consideration to cases marked with an asterisk.

The appellants request that PTAB reinstate the above appeals and vacate the dismissal orders.

- 06/06/2024 – PTAB found the above appellants' appeals were not filed in a timely manner; therefore, PTAB lacked jurisdiction and dismissed the appeals.

Appellant's Motion

On 06/06/2024, the appellant's attorney submitted a Motion to Reinstate and Vacate Dismissal Orders as follows:

- Counsel for the appellants avers the cases were untimely by a matter of hours, assuming the deadline for these appeals was 04/22/2024 [sic].
- Cook County Board of Review (CCBOR) makes several updates throughout the year to its Re-Review / Decision Date Transmittal. This year, between transmittals, the CCBOR changed the transmittal dates for approximately 15 townships. As of the date of this motion, the CCBOR's website contained incorrect transmittal dates for many townships. In many cases, the correct transmittal date is mistakenly listed as the CCAO Certification date.
- When calendaring the dates for Jefferson, South, and Rich townships, counsel used the date in the last column of the CCBOR Re-Review / Decision Date Transmittal as that column contained the correct transmittal date for Oak Park, Berwyn, and River Forest townships, where counsel filed the majority of his PTAB cases. In doing so, counsel filed the above cases on 05/23/2024, which was within 30 days of 04/30/2024, but around eight hours beyond 04/22/2024, which counsel believes is the correct transmittal date. Counsel also relied on the dates in the last column when filing West, Lakeview, and Bremen townships that were dismissed for untimely filing.

- PTAB published guidance on its website regarding the issues with the transmittal dates, and it noted that attorneys should include a brief explanation of their reliance on the previously published schedule if they found themselves outside of the jurisdictional timeframe. At the time of filing, counsel did not believe he was outside of the timeframe and did not include a brief.
- Counsel avers this is the first year CCBOR included the CCAO Certification Date on the Re-Review / Decision Dates form, and this is the main reason for counsel's confusion surrounding the correct transmittal dates and corresponding filing periods.
- PTAB also stated that any motion challenging PTAB's jurisdiction would be handled on a case-by-case basis.

Counsel contends given his reliance on the CCBOR schedule that mixed up the transmittal dates with CCAO certification dates, CCBOR not objecting to reinstatement, and the fact the appeals were only a few hours delinquent, if any, counsel prays PTAB will vacate the motion to dismiss on each case.

- 03/25/2024 – PTAB issued Notices of Rejection of Filing for Noncompliance with 86 Ill. Admin. Code §1910.30(b)(1)(A) for the above appeals for failure to file appeals via the e-filing portal.
- 03/25/2024 – Counsel for the appellants submitted the appeals via the e-filing portal.
- 04/11/2024 – The appellants received incomplete letters due to lack of evidence and legal argument with due dates of 05/11/2024.
- 05/23/2024 – The appellants responded to the letters of incomplete, 12 days late.
- 06/06/2024 – PTAB issued letters of dismissal for the above appeals for untimely responses to the letters of incomplete.

Appellants' Motion

On 06/11/2024, counsel for the appellants submitted a Motion to Reinstate pursuant to 86 Ill. Admin. Code §1910.64 allowing reinstatement of the above appeals as follows:

- Counsel for the appellants simultaneously prepared three different appeals for property with PIN 11-31-200-005 for tax years 2019 (19-09649), 2021 (21-08142), and 2022 (22-04721). Counsel received communication via email dated 4/04/2024 granting an extension of time to 06/03/2024 for the 2019 appeal. The communication was sent to counsel on a day he was traveling, and counsel incorrectly assumed the extension was the same for all 3 tax year cases.
- Counsel submitted an appraisal and resubmitted all three appeals before the 06/03/2024 deadline. Upon submission, counsel received notices that the 2021 and 2022 appeals were due earlier and were being treated as incomplete appeals.

Therefore, the appellants request the appeals be reinstated and the filing submitted be allowed for 2021 and 2022. There is no prejudice to the County, and it is expeditious to address all three appeals simultaneously in determining whether a stipulation would be submitted or contested. The appellants expect that a stipulation will be submitted for all three years.

- 02/29/2024 – PTAB granted the appellant an extension to submit evidence with a due date of 04/29/2024.

- 04/29/2024 – The Appellant submitted evidence, which consisted only of an appraisal valuing the property at \$625,000, which equates to an assessment of \$208,313.
- 05/09/2024 – PTAB issued an incomplete checklist with a due date of 06/08/2024. The incomplete checklist stated, “request does not comport or reflect [appraised] value. Counsel [may] not thwart possible notice to taxing districts by manipulating [the assessment request]. Appraisal is \$625,000 or an assessment of \$208,313.”
- 05/10/2024 – The Appellant submitted a revised appeal form requesting an assessment of \$225,000, contending the appellant’s request need not comport to the value established in the appraisal. The taxpayer as the contesting party, contends it met the burden of proof with the submittal of a full narrative appraisal in support of a valuation significantly different from Board of Review’s valuation. The Board timely received this evidence on 04/29/2024, which completed the filing.
- 86 Ill. Admin Code §1910.63(b) Compliance with Property Tax Appeal Board Rules or Specific Requests
In response to the Board’s Incomplete Checklist and 30-day extension, the taxpayer received on 05/09/2024, the taxpayer submitted a letter on 05/10/2024 averring the 04/29/2024 appeal was not incomplete because there is no requirement for the requested value comport with the value of the appraisal evidence.
- The 05/10/2024 letter requested the PTAB clarify if there is any rule the petitioner was not aware of, and the petitioner still had 29 days remaining on the 05/09/2024 30-day extension.
- The PTAB requested that the taxpayer comply with a rule that does not exist, which was improper and cannot be utilized by the PTAB to create new rules.
- Rather than presenting a rule that the appeal violated and allowing the taxpayer to respond adequately, the PTAB improperly dismissed the appeal on 05/23/2024, 14 days into the open 30-day extension.

The petitioner requests the appeal be reinstated based on the PTAB's receipt of a complete appeal on 04/29/2024, which the appellant contends meets the burden of proof to challenge the Board of Review's valuation.
