Relevant Fact to Appellant's Motion to Reinstate

- 08/05/2021 - PTAB accepted the above appeal and notified the Cook County Board of Review (CBOR) of the appeal with a due date of 11/03/2021.
- 08/17/2021 – Cook CBOR submitted evidence.
- 11/29/2023 – The parties of the appeal stipulated to a total assessed value of \$747,836.
- 02/20/2024 - PTAB found the agreement of the parties proper.

Appellant's Motion

On 07/03/2024, the appellant submitted a Motion to Vacate under PTAB Rule 1910.50(d) as follows:

- The appellants retained Elliott & Associates Attorneys, PLLC, to file 2020 assessment appeals for all unit owners except units 1036 and 1047. The appeal was docketed in case number 20-33985.
- The docket was set for hearing on 12/06/2023, but the appellant reached a settlement agreement with the Cook CBOR and submitted a stipulation reflecting that agreement.
- On 02/20/2024, PTAB issued a decision reflecting the stipulation reached by the parties.
- During the refund application process, the Cook County Treasurer's Office (CTO) informed that Certificates of Error were issued on four parcels:
 - 09-15-307-202-1013
 - 09-15-307-202-1053
 - 09-15-307-202-1064
 - 09-15-307-202-1065
- The Cook CTO intends to issue open item bills to each unit owner based on the increase caused by the PTAB decision but is delaying sending these bills pending this motion.
- The four affected taxpayers request that the PTAB vacate the decision, allow for the dismissal of these four parcels from the docket, and reinstate the decision for the remaining PINs and assessments as reflected in the original decision.
- Alternatively, the appellant requests the decision be amended, and the assessment of the following four parcels be revised to reflect the final assessment granted by the Assessor as reflected in the Certificate of Error Final Assessment:
 - 09-15-307-202-1013 - \$0
 - 09-15-307-202-1053 - \$4,952
 - 09-15-307-202-1064 - \$1,888
 - 09-15-307-202-1065 - \$4,793

Relevant Fact to Appellant's Motion to Reinstate

- 09/07/2023 - PTAB accepted the above appeal and notified the Cook County Board of Review (CBOR) of the appeal with a due date of 12/06/2023.
- 09/26/2023 – Cook CBOR certified that copies of the petition for the above docket were mailed to all taxing districts.
- 10/27/2023 – The Village of Lansing submitted its Request to Intervene, and on 11/30/2023, PTAB added the intervenor as an interested party in the appeal with a due date of 02/28/2024 to submit evidence.

- 06/11/2024 - PTAB found The Village of Lansing in default for failure to submit evidence.

Intervenor's Motion

On 07/03/2024, the intervenor submitted a Motion to Vacate Order and Reinstate as follows:

- The intervenor contends a letter dated 02/02/2024 was sent to PTAB through its counsel, which stated, "The Intervenor's Brief in Opposition to the Appeal is enclosed." The letter indicated the intervenor will not file any evidence in this matter and adopts any evidence or brief filed by Cook CBOR or any other intervenor. The letter also referenced a certified mail tracking number 7021 0950 0000 2420 4154.
- The brief of the intervenor in opposition to the appeal was also enclosed with the letter dated 02/02/2024, which stated:
 - The subject is an 11-store retail center, assessed at a 25% level for 2022. The assessed value was \$375,628, which corresponds to a market value of \$1,502,512.
 - The appellant's evidence is a closing statement showing the owner purchased the property on 03/21/2022 for \$800,000.
 - The owner also submitted a brief supporting their 2022 real estate valuation complaint. Pages 2 and 3 of the brief state the property's assessed value for 2022 should be \$200,000; the property was 69% vacant in 2022 and requests a 31% occupancy factor be applied to the \$200,000 assessed value based on the \$800,000 purchase price. The property was initially listed for \$1,228,000 and was negotiated down to \$800,000, a 39% reduction.
 - The appellant provided an affidavit of Marshall Weisman, an agent of the subject property. Mr. Weisman states in his affidavit that the 2022 purchase price allocates spaces that are physically vacant.
 - The subject property consists of rental properties; its potential rental income affects the amount a buyer will pay for it, and the possible income affects the price for which it was sold. By using the \$800,000 sale price to calculate the assessed value instead of the \$1,502,512 market value established by the Board of Review, the owner has already received credit for the property's vacancies. Applying a vacancy factor to the assessed value based on the sales price would be redundant.
 - In the alternative, if an occupancy factor was applied to the assessed value, 31% is not the correct factor.

- Mr. Weisman's affidavit also states that the property was 65.5% physically leased. If an occupancy factor were to be applied to the property's assessed value, the correct factor would be 65.5%.
- The intervenor requests that a vacancy factor not be applied to the property's 2022 assessed value based on the 03/31/2022 sale for \$800,000.
- The intervenor requests that PTAB vacate its dismissal order and reinstate the Village of Lansing as an intervenor in the above matter.

According to the tracking information, the package would have been delivered one year and 45 days before the date of the letter.

Appellants' Motion

On 07/22/2024, the appellants submitted their Motion to Stay and Motions for issuance of subpoenas as follows:

- This 2021 appeal follows previous appeals to PTAB for the 2019 and 2020 tax years (19-24215 and 20-21487). There are also PTAB appeals concerning the subject property for tax years 2022 and 2023 (22-25725 and 23-22538).
- The Historic Residence Assessment Freeze Law (35ILCS 200/10-40 et seq.) ("Freeze Law") is at issue in each of the PTAB appeals. The primary issue for each tax year is the fair cash value of the subject property during the 2016 "base year valuation."
- PTAB conducted a hearing on 10/17/2023 for the 2019 appeal and issued a "No Change" after holding that the appellants had not proven by a preponderance of the evidence that the subject property was overvalued during the 2016 base year.
- The PTAB 2019 decision is currently pending an Administrative Review in the Circuit Court of Cook County due to errors the appellants contend were made by PTAB.
- A status hearing on the Complaint for Administrative Review is scheduled for 08/12/2024, and the court is expected to set the matter for oral arguments.
- The ruling on the 2019 Administrative Review Complaint will substantially and directly impact the 2020 through 2023 appeals.
- The appellants request a subpoena to compel Darius Bryjka, Reviewer for the State Historic Preservation Office of the Illinois Department of Natural Resources, to attend and testify at the hearing for the 2020 PTAB appeal. The appellant contends that PTAB ruled during the 2019 hearing of the above subject property that Mr. Bryka's Declaration should be given no weight since he was not present at the hearing to offer testimony or to be cross-examined.
- Additionally, the appellants request a second subpoena to compel the Office of the Independent Inspector General to produce official records in the Inspector General's possession. The Inspector General issued a report recommending the

Cook County Assessor improve the Assessor's administration for properties qualifying under the Freeze Law. The appellant avers PTAB declined to consider this report during the 2019 hearing of the above subject property.

The appellant requests that PTAB issue the requested subpoenas.

f. Martin Siegel Appraisal Cases

Motion: PTAB's *Sua Sponte* Motion for Sanctions

Common Facts for Items f(1) through f(5): The appeals listed in items f(1) through f(5) were timely filed with the Property Tax Appeal Board (the Board). A law firm represents the appellant, and the basis of the appeal is or includes a recent appraisal. When the appeals were filed, the PTAB reviewed the evidence submitted by the appellant to determine if the appellant met its burden to challenge the correctness of the assessment with substantive, documentary evidence. The Cook County Board of Review v. The Property Tax Appeal Board, 334 Ill. App. 3d 56, 59, 777 N.E.2d 622, 267 Ill. Dec. 819 (2002), quoting 86 Ill. Adm. Code §1910.63(b). Documentary evidence includes an appraisal of the subject property. 86 Ill. Admin. Code §1910.65(c)(1). The appellant's evidence included, wholly or in part, an appraisal completed by Martin S. Siegel of Siegel and Associates, Inc. When conducting the Section 1910.63 review, PTAB relied upon Siegel's appraisal, which indicated that Siegel was a Certified General Real Estate Appraiser. Based on the appraisal, the PTAB determined that the appellant met its Section 1910.63 burden. The Board then notified the respective country board of review.

In or about June 2024, the Illinois Department of Financial and Professional Regulation (the Department) contacted PTAB regarding Siegel's appraisal license. The Department is responsible for the licensing of general real estate appraisers. 225 ILCS 458/1 et seq. According to the Department, Siegel's general real estate appraiser license had expired on September 30, 2021. A PTAB staff member then reviewed Siegel's appraisal license on the Department's website to verify its status. The results confirmed that Siegel's license had indeed expired. See the Image #1 below. The PTAB identified dozens of cases in which Siegel signed off on an appraisal after the expiration date of his license. In the appraisals, Siegel indicated that his license was still active and expired on September 30, 2023. See Image #2, taken from the appraisal submitted in docket 21-52896. There are a couple of dockets, as identified below, where the Siegel appraisals were completed while his license was still active.

After learning that Seigel's appraisals were submitted fraudulently, indicating that he had an active license, the PTAB issued an order setting these matters for a hearing on sanctions. The order stated that the PTAB intended to take judicial notice that the Department's website showed that Seigel's license expired on September 30, 2021, and that any party wishing to object or produce evidence to the contrary was free to do so. The parties were also given leave to file any pleadings for or against the imposition of sanctions.

The bulk of cases involving Seigel were voluntarily dismissed.

No party objected to the PTAB taking judicial notice of the Department's website showing that Seigel's license expired on 9/30/2021. No party filed or presented any evidence contradicting this fact. Therefore, the PTAB takes judicial notice that Seigel's license expired on 9/30/2021, as shown on the Department's website.

The circumstances unique to each case are explained below. And, Images 1 and 2 are located at the end of this section.

- The Seigel Appraisal was signed on 4/12/2022.
Appraisal indicated Seigel's license was active until 09/30/2023.
The appraisal indicated an FMV of \$9,500,000.
- When filing, the appellant submitted a second appraisal completed by Kelly Appraisal Consultants, which valued the property at an FMV of \$12,000,000 as of 1/1/2022.

- After being notified of the instant sanctions hearing, the appellant filed a pleading in which it argues and requests the following:
 - Request a 30 to 60-day extension to file a new 2021 appraisal for case 21-52896.
 - Strike the Seigel appeal in the 2022 matter and let the appellant proceed on the Kelly appraisal.
 - The appellant could enter a stipulation with the BOR on the 2021 and 2022 matters if the extension was granted.
 - The taxpayer did not know Seigel's license status and should not be punished for Seigel's actions.
 - The appellant cites an appellate court case concerning an inactive attorney who filed a complaint on behalf of a client.
 - The appellant asks that PTAB use the raw data in the Seigel appraisal and cite a previous PTAB matter for this proposition.
- The Cook County BOR:
 - Objected to any extension to submit additional evidence.
 - Requests that the 2021 matter be dismissed.
 - Has no objection to filing striking the Seigel appraisal in the 2022 case and allowing the appellant to proceed on the Kelly appraisal.

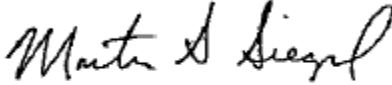
