Appellant's Motion d(1)

On 07/31/2024, the appellant submitted its Request to Stay Pending PTAB Proceedings for the above dockets as follows:

- The parties are engaged in good faith settlement negotiations to reach a comprehensive, global settlement of all pending litigation, including the above-listed appeals and future tax years.
- Due to the extraordinarily complex nature of these appeals and in the interest of judicial efficiency, the appellant requests that PTAB stay these appeals, including any evidence deadlines, and defer setting any of these appeals for hearing to allow the parties time to complete their settlement negotiations.
- The parties have conferred, and all agree to this request.
- Upon reaching a global settlement or exhaustion of the parties' negotiations, the parties will apprise PTAB of the outcome. If PTAB requests an update, the parties shall provide such status update within 30 days of said request.

On 08/01/2024, Jackson CBOR and intervenor, Shawnee CUSD #84, informed us that they do not object to the request to stay.

b(2)Motion: Intervenor's Motion to Substitute Expert & Property Appraisal, Instant

On 01/30/2024, the intervenor, Shawnee CUSD #84, submitted its Motion to Substitute Expert and Property Appraisal, Instant as follows:

- The intervenor submitted its principal evidentiary submission for Docket No. 16-01296 on 09/17/2018, over five (5) years ago, which consisted of the “Retrospective Appraisal Summary Report, Grand Tower Station,” prepared over 6.5 years ago, on 07/12/2017, by Lagassa Appraisal. The Lagassa Appraisal designated Dr. George K. Lagassa as the intervenor’s expert appraiser and offered his appraisal of Grand Tower Station as its principal appraisal of the subject property.
- Dr. Lagassa is now an unlicensed former appraiser. He is a 75-year-old retiree and has neither drafted nor worked on an appraisal in any capacity in over thirty months. He has not prepared an appraisal since before the COVID-19 pandemic and has not offered expert testimony since 2018. As Dr. Lagassa is retired, he is not available to offer expert testimony on this matter and no longer actively monitors the energy industry.
- Dr. Lagassa is retired from the practice of appraisal, and professional, legal, and personal reasons render Dr. Lagassa unavailable to serve as an expert in these procedures. Dr. Lagassa has no plan to practice appraisal or testify as an expert witness ever again. Additionally, all of Dr. Lagassa’s licenses have lapsed. The federal Appraisal Subcommittee has designated Dr. Lagassa’s accreditation status as inactive, and he is no longer recorded as a practicing appraiser by the American Society of Appraisers.
- The Illinois Real Estate Appraiser Licensing Act of 2002 prohibits Dr. Lagassa from performing an act offering services or advertising services as a state-certified general real estate appraiser, state-certified residential real estate appraiser, or associate real estate trainee appraiser according to 225 ILCS 458/5-5(a)(West 2024).
- Dr. Lagassa is no longer available to testify under the standards set forth by the Uniform Standards of Professional Appraisal Practice (USPAP). USPAP requirements have been incorporated into Illinois law, 68 Ill. Adm. Code 1455.24(A) and 225 ILCS 45810-10 (West 2024).
- Additionally, Dr. Lagassa is unavailable to testify because he is devoted to the caretaking responsibilities of his spouse, who has a severe health issue and requires regular attention. Dr. Lagassa has attested to his unavailability.
- The intervenor has engaged Michael Lane, ASA appraiser and Partner at NewGen Strategies and Solutions, to prepare an appraisal of the subject property as of 01/01/2016, and was attached to the Motion.
- The appellant is familiar with Mr. Lane and NewGen as Mr. Lane and NewGen have appraised this property for all subsequent filings in these proceedings that have been filed with PTAB for all tax years since 2016.

- PTAB rule 1910.67(l) states, “appraisal testimony offered to prove the valuation asserted may only be given by a preparer of the documented appraisal whose signature appears on the document.” 86 Ill. Admin. Code § 1910.7(l).
- PTAB Rules 1910.50(c) and 1910.92(a) required that hearings be conducted “in a manner best calculated to conform to substantial justice” and that appeals be decided on “equity and the weight of the evidence.” 86 Ill. Admin. Code §§ 1910.50(c), 1910.92(a).
- As Dr. Lagassa is no longer available to testify, a designation of a substitute appraiser and submission of a substitute appraisal of the subject property are necessary to comply with PTAB rules and regulations and to comply with substantial justice. Which cannot be achieved without expert testimony from an available appraiser offered by the intervenor. 86 Ill. Admin. Code § 1910.92(a)
- The designation of a substitute appraiser and submission of a substitute appraisal will not result in substantial prejudice to the appellant because the appellant is familiar with NewGen valuation techniques that are present in the intervenor’s 2017– 2021 evidence and because the effect of the Motion will allow the appellant the opportunity to review and prepare its position in advance of a hearing for a matter where there has been no activity since 12/19/2018.
- Failure to allow would cause substantial harm and prejudice to the intervenor. The intervenor would be deprived of the opportunity to present an appraisal and testimony of a licensed appraiser.
- Additionally, because proceedings before PTAB are considered de novo, new appraisals may be submitted to PTAB that were not submitted to the Board of Review without prejudicing the appellant. 86 Ill. Admin. Code § 1910.50(a).
- PTAB rules authorize PTAB to accept this evidence and testimony into record. 86 Ill. Admin. Code § 1910.67(h). And PTAB Rule 1910.67(k) permits PTAB to waive filing requirements and order the submission of documentary evidence into the record.
- Granting the intervenor’s Motion would not risk any disruption to existing proceedings as a hearing has not been scheduled, and PTAB has otherwise taken no action on the evidence submitted by the parties of this appeal.
- Mr. Lane is available to offer expert testimony on the NewGen appraisal on behalf of the intervenor.
- The intervenor moves that for this 2016 appeal, PTAB grants this Motion to Substitute Expert and Property Appraisal, Instantly, and enter an Order substituting the Lagassa Appraisal with the NewGen Appraisal.

Respondent's Motion

On 08/05/2024, Tazewell CBOR submitted its request to vacate default for the above appeals as follows:

- The reason for this motion is due to Tazewell CBOR not being able to use their computers from the week of Thanksgiving in November until the end of December 2024 [sic].
- Also due to construction in the office from April 10 to July 1.

The Board held this matter over from the August meeting for the intervenor to address the USPS tracking number showing delivery before the appellant filed this appeal.

Relevant Facts to Intervenor's Motion to Vacate Order and Reinstate

- 09/07/2023 - PTAB accepted the above appeal and notified the Cook County Board of Review (CBOR) of the appeal with a due date of 12/06/2023.
- 09/26/2023 - Cook CBOR certified that copies of the petition for the above docket were mailed to all taxing districts.
- 10/27/2023 - The Village of Lansing submitted its Request to Intervene, and on 11/30/2023, PTAB added the intervenor as an interested party in the appeal with a due date of 02/28/2024 to submit evidence.
- 06/11/2024 - PTAB found The Village of Lansing in default for failure to submit evidence.

Intervenor's Motion

On 07/03/2024, the intervenor submitted a Motion to Vacate Order and Reinstate as follows:

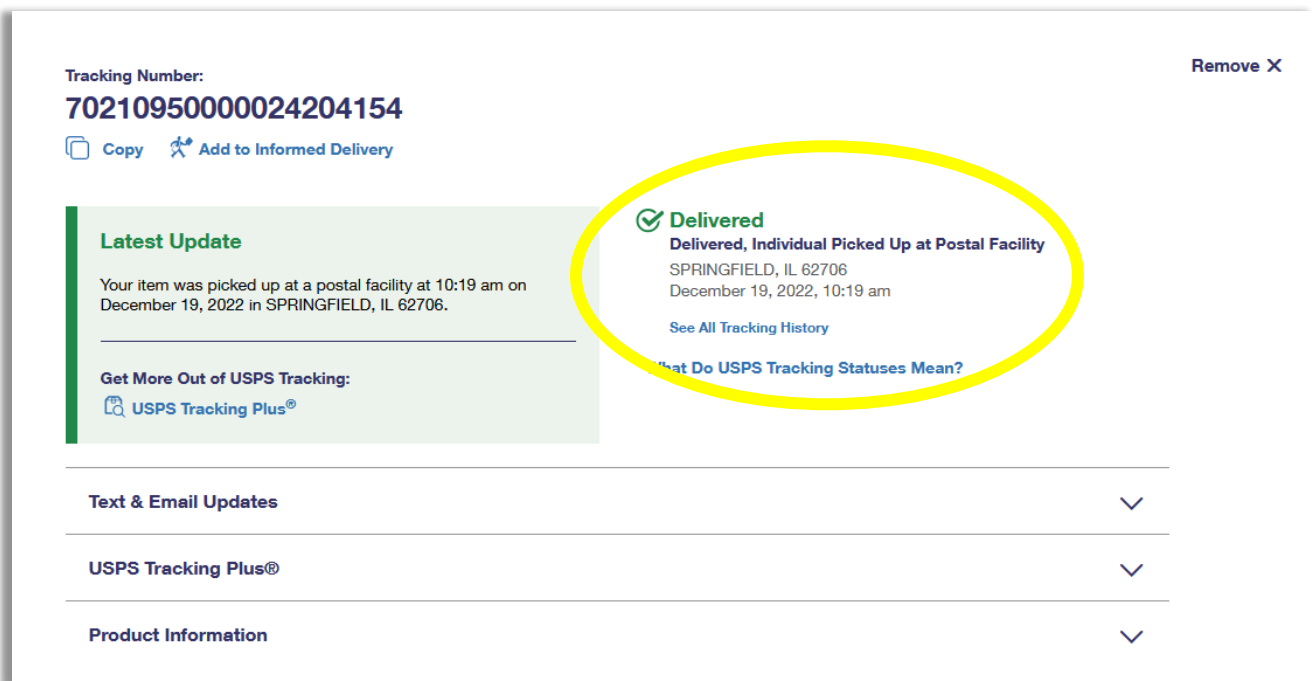
- The intervenor contends a letter dated 02/02/2024 was sent to PTAB through its counsel, which stated, "The Intervenor's Brief in Opposition to the Appeal is enclosed." The letter indicated the intervenor will not file any evidence in

this matter and adopts any evidence or brief filed by Cook CBOR or any other intervenor. The letter also references a certified mail tracking number 7021 0950 0000 2420 4154.

- The brief of the intervenor in opposition to the appeal was also enclosed with the letter dated 02/02/2024, which stated:
 - The subject is an 11-store retail center, assessed at a 25% level for 2022. The assessed value was \$375,628 which corresponds to a market value of \$1,502,512.
 - The appellant's evidence is a closing statement showing the owner purchased the property on 03/21/2022 for \$800,000.
 - The owner also submitted a brief supporting their 2022 real estate valuation complaint. Page 2 and 3 of the brief states the property's assessed value for 2022 should be \$200,000, the property was 69% vacant in 2022, and requests a 31% occupancy factor be applied to the \$200,000 assessed value based on the \$800,000 purchase price. The property was originally listed for \$1,228,000 and was negotiated down to \$800,000, a 39% reduction.
 - The appellant provided an affidavit of Marshall Weisman, an agent of the subject property. Mr. Weisman states in his affidavit that the 2022 purchase price allocates spaces that are physically vacant.
 - The subject property consists of rental properties, its potential rental income affects the amount a buyer will pay for it and the potential income affected the price for which it was sold. By using the \$800,000 sale price to calculate the assessed value instead of the \$1,502,512 market value established by the Board of Review, the owner has already received credit for the property's vacancies. Applying a vacancy factor to the assessed value based on the sales price would be redundant.
 - In the alternative, if an occupancy factor was applied to the assessed value, 31% is not the correct factor.
 - Mr. Weisman's affidavit also states the property was 65.5% physically leased. If an occupancy factor were to be applied to the property's assessed value, the correct factor would be 65.5%.
 - The intervenor requests that a vacancy factor not be applied to the property's 2022 assessed value based on the 03/31/2022 sale for \$800,000.

A USPS Search of the tracking number listed on the 02/02/2024, Intervenor's Brief in Opposition to the Appeal letter (70210950000024204154) shows that a package arrived at the USPS Regional Facility on 12/15/2022, at the Carol Stream, IL Distribution Center. Then, on 12/16/2022, the package arrived at the USPS Springfield, IL

Distribution Center, arrived at the post office in Springfield, IL on 12/19/2022, and was delivered on 12/19/2022. According to the tracking information, the package would have been delivered one year and 45 days prior to the date of the letter.



On 08/28/2024, the appellant responded to the intervenor's Motion and requested that PTAB deny the relief sought by the intervenor as follows:

- The appellant received an email from PTAB on 08/09/2024, stating the Motion to Vacate Default will be heard at the August 13th meeting. On 08/13/2024, PTAB sent a copy of the intervenor's motion to the appellant and requested a copy of the motion be served to all parties pursuant to PTAB Rule 1910.64, which the intervenor failed to do at the time of filing and as of 08/28/2024, the appellant has not received notice of the original motion from the intervenor.
- PTAB Rule 1910.64 states, "A written motion shall be served at the same time upon all parties and filed with the Board's Springfield office. Motions shall be accompanied by proof of service upon all those required to be served, including the Board."

- The appellant contends they were not served with a copy of the motion by the intervenor as of 08/28/2024; therefore, the motion is incorrect and should be denied.
- Alternatively, the motion states that the intervenor's evidence was timely filed on 02/02/2024 and sent via certified mail number 7021 0950 0000 4154. The certified mail number listed on the motion corresponds with a package delivered in Springfield, IL, on 12/19/2022. At that time, the appellant's 2022 PTAB complaint had not been filed. Therefore, the certified mail number does not adequately provide proof that the evidence was filed in a timely manner in accordance with PTAB's request. The intervenor has not submitted any other evidence that would support their claim that the 02/28/2024 deadline set by PTAB timely filed evidence. Therefore, the appellant requests that the Motion be denied as the intervenor has not proven that they timely filed evidence for Docket No. 22-29907.

Relevant Fact to Appellants' Request to Reinstate

- 05/02/2024 – PTAB found the appellants' petition incomplete and requested additional information with a due date of 06/01/2024.

- 05/13/2024 - PTAB received the incomplete letter addressed to the appellant, dated 05/02/2024, as returned mail. The U. S. Postal Service could not forward the letter, as the forward time had expired, so they returned the letter to PTAB. PTAB contacted the appellants, emailed the checklist, and mailed a second incomplete letter with an adjusted due date of 06/12/2024 to an updated mailing address.
- 07/05/2024 – The appellant responded to the incomplete checklist via the e-filing portal.
- 07/25/2024 – PTAB dismisses the above appeal due to an untimely response, 23 days late.

Appellants' Motion

On 08/05/2024, the appellants submitted their request to reinstate and stated that due to circumstances beyond their control, the process encountered several issues that they believe warrant reconsideration of their case as follows:

- On 05/13/2024, the appellants were in Colorado for work and had their mail forwarded to Colorado to avoid their mail piling up at their house. Consequently, the letter from PTAB was returned to the sender by the post office. PTAB contacted the appellants after receiving the returned letter and explained the situation to the appellants.
- The appellants requested that the letter be forwarded to Romeo Tadeja's family's house so he could retrieve it and they could address the incompleteness. Unfortunately, the letter never arrived at the address. The local post office has had ongoing issues with mail delivery, including instances of lost mail.
- The appellants contend to resolve the issue, appellant Christina Tadeja accessed the PTAB website, located the case information and resubmitted the appeal on 07/05/2024. Despite these efforts, the appellant received a notice at the in-law's house dated 07/25/2024, stating that the appeal was denied because it was submitted late. The original submission was timely, and the delays and complications were due to postal service issues beyond the appellants' control.
- The appellants respectfully request that PTAB reconsider their appeal and reopen the case. The appellants also request their mailing address be updated back to the home address of 5047 N. Hamlin Ave., Chicago, IL 60625, as the forwarding service is now terminated.

- 05/23/2024 - PTAB sent the appellant a letter informing them the petition is incomplete and requested a copy of the Cook CBOR original decision letter for the subject property with a due date of 06/22/2024.
- 07/25/2024 – PTAB dismissed the petition for failure to provide substantive documentary evidence sufficient to challenge the correctness of the assessment of the subject property.

Appellant's Motion

On 08/06/2024, the appellant submitted a Motion to Reinstate as follows:

- The subject of this appeal is one residential condominium unit, plus three related parking units, all of which were acquired by the appellant in the same transaction on 10/31/22 for \$1,350,000. The appeal was timely filed on 05/06/24.
- The appellant's counsel received a letter dated 05/23/2024, from PTAB informing the Board of Review Decision Letter included in the appeal pertained

to a different property than the subject, and PTAB granted an extension to submit the correct letter on or before 06/22/2024.

- Unfortunately, the notification from PTAB was inadvertently misplaced, and the submission deadline was missed.
- The appellant's counsel received notification by letter dated 07/25/2024 that the case was dismissed.
- The correct Board of Review Decision Letter is attached to this motion, and the appellant requests it be added to PTAB's file instant. No parties would be prejudiced by PTAB's acceptance of the correct documentation, as there are no other parties of record at this time.

- 04/04/2024 – PTAB grants the appellant a 60-day extension with a due date of 06/03/2024.

- 06/13/2024 – PTAB grants the appellant a final 60-day extension with a due date of 08/12/2024.

Appellant's Motion

On 07/25/2024, the appellant submitted its Motion for Stay of Proceedings Pending the outcome of 2022 PTAB Appeal Docket No. 22-03052, currently pending on the same property as follows:

- 03/22/2024, the appellant filed this 2023 Farmland Appeal on time, which involved the classification of more than 100 seasonal-use portable cabins situated on the land of the subject property.
- There is currently an appeal pending before PTAB regarding the same property for the 2022 assessment year, Docket No. 2022-03052.
- 07/03/2024, the appellant received PTAB's "Evidence Closure Letter" in the 2022 appeal. The appellant was provided with the evidence submitted by the Fulton County Board of Review (CBOR) and intervenor, Canton Union School District No. 66. The appellant was granted until 08/02/2024, to submit rebuttal evidence.
- The 2022 appeal is based solely on a contention of law, specifically, the appellant's contention that the subject cabins should be classified as personal property under Illinois law and not assessed. The appellant raises no other issues on appeal and does not challenge any element of valuation.
- Neither the respondent nor the intervenor's evidentiary filings expand the issues on appeal. Both parties contend the cabins are properly classified as real property under Illinois law, and the 2022 assessment should be maintained.
- PTAB's determination of the subject cabins' classification will not only dispose of the issues in the 2022 appeal but will also significantly narrow, if not dispose, of the appellant's contentions in the 2023 appeal. Once PTAB issues its decision in the 2022 appeal, there will be no genuine contention of law in the 2023 appeal regarding the subject cabins' legal classification.
- Accordingly, a stay in the 2023 appeal and any subsequent appeals pending the outcome of the 2022 appeal, is in the best interests of the parties and PTAB.
- PTAB's rule 1910.3 (g) provides the PTAB shall grant evidentiary extensions for "good cause" which may include, but is not limited to, "the pendency of a court action affecting the assessment of the property." The pendency of the 2022 appeal is "good cause" for a stay of proceedings in the 2023 appeal.
- All parties to the appeal have submitted their evidence, and the subject cabins' legal classification is the sole issue in the 2022 appeal. It is evident that a stay of proceedings in the 2023 appeal is in the best interest of the parties and PTAB.

- If a ruling on this motion is not made prior to the appellant's final extension of time to submit evidence, 08/12/2024, the appellant intends to submit a letter to PTAB requesting an additional extension of time pending PTAB's ruling on the motion.
- On 08/09/2024, the Appellant submitted its request for an additional extension of time to submit evidence pending PTAB's ruling on the appellant's motion for a stay of proceedings. The appellant also wishes to point out that at the time the appellant first requested a final evidentiary extension (05/29/2024), the appellant had not received intervenor or respondents' evidence in the 2022 appeal and, therefore, could not finally determine that the cabin's legal classification would remain the sole issue on appeal.
- The appellant requests that PTAB stay the proceedings in the above case pending the outcome of PTAB Docket No. 22-03052 and requests an extension of time to submit evidence for the 23-04208 docket pending PTAB's ruling on the motion for a stay of proceedings.
