Relevant Facts to Appellant's Motion to Reopen Evidence Filing Period

- 05/11/2023 – PTAB finds the appeal incomplete and provides a 30-day extension with a due date of June 10, 2023.
- 06/09/2023 - The appellant requests an additional 30-day extension, and PTAB grants a final 60-day extension with a due date of 10/09/2023. On 10/09/2023, the appellant submits its appeal and evidence.
- 12/07/2023 - PTAB accepts the above appeal and notifies the Cook County Board of Review (CBOR) of the appeal with a due date of March 6, 2024.

- 09/19/2024 – PTAB notifies all parties of the appeal that the filing period for submission of evidence regarding this case is closed and provides 30 days to submit rebuttal evidence solely addressing any new evidence enclosed.

Appellant's Motion

On 10/18/2024, the appellant submitted a Motion to Reopen Evidence Filing Period as follows:

- On 10/09/2023, the appellant submitted via the PTAB's Electronic Filing Portal (EFP) an amended appeal stating the basis of the appeal as assessment equity and recent appraisal. The appellant also submitted a supporting brief and evidence.

Relevant Fact to Appellant's Motion to Reinstate

- 05/09/2024 – PTAB accepts the appeal as sufficient, notifies Stephenson County Board of Review (SCBOR), and provides them with a due date of 08/07/2024.
- 07/30/2024 – SCBOR requests a 60-day extension due to the complex and voluminous nature of this case.
- 08/08/2024 - PTAB grants an extension with a due date of 10/07/2024.

Board of Review's Motion

On 10/01/2024, SCBOR submits its evidence and a Motion to Dismiss Appeal. SCBOR argues the appellant has failed to offer the PTAB evidence to justify the relief requested and that the appellant bears the burden of proving his claims by clear and convincing evidence in accordance with 89 IL ADC 1910.63(e). Additionally, if the appellant fails to provide substantive, documentary evidence, his appeal must be dismissed, per 89 Ill. Admin. Code 1910.63(b). SCBOR further states there are restrictive rules relating to the submission of evidence at hearings, per 89 Ill. Admin. Code 1916.67(k), and the appellant has failed to meet his burden as follows:

- The appellant's first contention is his property is not assessed in the same manner as other condominium parcels, which have been set at \$1. The appellant fails to include any authority on why any such parcels should be assessed at \$1. And fails to note important distinguishing information.
- The appellant claims his property should be assessed at \$1 because this is the practice in Freeport for dealing with as-yet unconstructed condominium units. The appellant offers, as evidence, the assessment for eight parcels related to the Edge of the Meadows Condominium plat. The appellant claims that the assessment for these parcels is not anomalous. SCBOR contends the property assessment is anomalous and the properties are materially dissimilar.
- SCBOR asserts that understanding how these parcels were ultimately assessed at \$1 requires some review of the development's history. In 2005, this property was assessed as farmland with a valuation of \$1280. A condominium plat was filed, dividing the parent parcel into 47 child parcels. The parcels were assessed at \$27 per parcel. The next year, the assessment increased to \$150 per parcel and remained at this level until 2012.
- From the beginning and after a few of the condominiums were built, flooding, financial difficulties, and litigation grounded the forward momentum of the development to a permanent halt.
- The property was mortgaged by FDI Inc. through Amcore Bank. The FDIC took over for Amcore Bank on 04/23/2010, and its assets were transferred to Harris Bank (later BMO Harris). In 2012, Amcore Bank dba BMO Harris and the Edge of the Meadows Association sued FDI Inc. for failure to live up to its financial obligations concerning the subject properties. On 06/04/2012, a judgment was entered against FDI, Inc on behalf of Amcore Bank dba BMO Harris and Edge of the Meadows Condominium Association, awarding them a judgment in the amounts of \$1,613,587.10 and \$110,257.46, respectively.
- The plats the appellant offers as a model of the common practice in Freeport were additionally encumbered by liens. These liens substantially eclipsed the estimated value of these properties, so in 2013, their assessments were lowered to \$1, under the theory of economic obsolescence.

- Before the assessments being lowered for these plats, they were assessed exactly as the appellant's parcels are currently assessed.
- The appellant's property is assessed in accordance with Illinois Department of Revenue Publication 134. There are some small distinctions to be made because the Edge of the Meadows Condominium plat was converted from farmland to residential vacant land and the appealed parcel remained residential vacant land and have received the same treatment at the same points in their development.
- The reduction in the assessment of the parcels on the Edge of the Meadows was based on circumstances that are in no way similar to that of the appellant's and cannot contribute to a quantum of proof that the appellant's land had been inequitably assessed.
- The appellant's ninth comparable property is a common area owned by a condo association and as such is taxed at \$1 and its value has been added to the assessments of the buildings within the condo association as provided by law, 765 ILCS 605/10(a). A condominium association does not exist for the appellant's parcel and this statute cannot apply to them.
- The appellee contends the appellant's tenth through twelfth comparable properties are not a part of a condominium plat and they are not in a comparable location.
- The SCBOR asserts the appellant also claims that he has a garage on his property that he plans to demolish and cannot use because it does not meet current zoning requirements. However, the SCBOR has photographic evidence that it is currently in use for the storage of gardening and lawn care equipment, which is a legal nonconforming use.
- Therefore, the SCBOR prays this matter be dismissed.

Appellant's Motion

On 10/21/2024, the appellant submitted a Request for Extension of Time to File Response to the Appellee's Motion to Dismiss as follows:

- The appellant's counsel of record has been required to withdraw due to an asserted conflict of interest by the Board of Review.
- Substitute counsel could not assist as originally expected, leaving the appellant unrepresented.
- SCBOR requested and was granted a 60-day extension to file its response and evidence. SCBOR has filed a Motion to Dismiss, which is atypical. The appellant was advised he has only 21 days to object or file a response to the Motion to Dismiss.

- The appellant objects to granting the Motion to Dismiss as it is primarily factual in nature and deprives the appellant of an opportunity for the requested hearing.
- The appellant avers he has a valid defense to the Motion to Dismiss and has diligently sought alternative counsel and continues to do so but has yet to retain counsel in time to meet the filing due date.
- The appellant contends that due to the timing of SCBOR's filing and their extension, the appellant's response is due at the same time tax practitioners are preparing 2024 assessment objections, making it challenging to retain qualified counsel.
- Therefore, the appellant requests a 60-day extension to file a response to the Motion to Dismiss.
