- 04/06/2023 – PTAB accepts the above appeal and notifies the Cook County Board of Review (CCBOR) of the appeal with a due date of July 5, 2023.
- 07/31/2024 – The appellant and appellee stipulate on the assessment of the above property.
- 10/15/2024 – PTAB finds that the parties' agreement is proper, and the correct assessed valuation of the property is \$125,000.

Appellant's Motions

On 11/14/2024, the appellant submitted Motions to Reinstate the above Complaints and to Vacate the PTAB Final Decisions for Dockets No. 20-32894 and 21-34743. The appellant also submitted Motions to Withdraw the Complaints as follows:

- The appellant avers during negotiations with a representative of the CCBOR to resolve the issue of the 2019 PTAB complaint, the 2020 and 2021 PTAB complaints (20-32894 & 21-34743) were inadvertently included in the discussion.
- The appellant mistakenly thought the final assessments for the 2020 and 2021 PTAB complaints were the same as the 2019 first year of the triennial assessment of \$140,186. However, the assessments for 2020 and 2021 were already reduced to \$121,998 due to the Assessor's automatic COVID reduction in 2020.
- Based on this erroneous assumption, the appellant requested that the 2019-2021 PTAB complaints be reduced to \$125,000. The CCBOR agreed to the disposition of all three cases with the understanding that the appellant was asking for the assessments from 2019 to 2021 to be reduced.
- It was subsequently discovered that the 2020 and 2021 assessments were \$121,998, and the requested assessment of \$125,000 would raise the assessments.
- As there was no intent on either party to increase the 2020 and 2021 assessments and the CCBOR has agreed to allow the appellant to withdraw the cases, the

appellant requests that PTAB vacate the 2020 and 2021 PTAB decisions and withdraw the complaints.
