Relevant Facts

- 10/24/2023 – The parties of the above appeal stipulate to an agreed assessment of \$540,000.
- 12/17/2024 – PTAB finds the agreement of the parties is proper and the correct assessed valuation of the property is \$540,000.

Motions to Vacate Decision & Withdraw Appeals

On 12/19/2024, the appellant through counsel submitted a motion to vacate, withdraw, and reinstate the above appeal as follows:

- Prior to the PTAB decision date, the Cook County Assessor reduced the valuation of the property, and the decision of the Assessor should control over the later settlement, which was made without knowledge of the Assessor's reduction.
- Therefore, the appellant requests PTAB to enter an order to allow the vacation of the order, withdrawal of the 2021 Docket in the above matter, and to reinstate the \$520,793 assessed value pursuant to the decision of the Assessor's Office.

County's Response to Appellant's Motion to Vacate, Withdraw, & Reinstate

On 01/07/2025, Cook County Board of Review objects to the appellant's motion.

Intervenor's Response to Appellant's Motion to Vacate, Withdraw, & Reinstate

On 01/09/2025, intervenor, New Trier High School District No. 203, pursuant to Section 1910.64 of the PTAB's rules of practice and procedures file their response as follows:

- On 10/24/2024, the taxpayer entered a stipulation with the parties agreeing to an assessed valuation of \$540,000 for the subject property for the tax year 2021. The stipulation was adopted by PTAB in its final administrative decision dated 12/17/2024. The taxpayer has now filed a motion seeking to vacate the PTAB's decision, withdraw the stipulation, and reinstate the appeal, citing a reduction issued by the Cook County Assessor after the stipulation was signed and the taxpayer's motion should be denied.
- PTAB's 12/17/2024 decision is final and beyond reconsideration under Illinois law a final administrative decision can only be vacated under limited circumstances such as fraud, mistake, or other extraordinary grounds. The taxpayer fails to articulate any valid legal basis for vacating the decision. The issuance of an unexplained unsupported reduction by Cook County Assessor does not constitute a material change in circumstances sufficient to justify setting aside a final decision. Moreover, the Cook County Assessor's change was made after the stipulation was executed and was unrelated to the evidence or arguments presented during the PTAB appeal process. The PTAB's jurisdiction is limited to the record before it and does not extend to reconsidering final decisions based on post hoc actions by third parties.

- Upholding stipulated settlements is essential to preserve the integrity of the appeals process. PTAB's acceptance of stipulated settlements is a cornerstone of the administrative appeal process, fostering judicial efficiency and encouraging parties to resolve disputes without protracted litigation. Ill. Admin. Code tit. 86 § 1910.55. If parties are permitted to vacate settlements at their convenience or based on subsequent events, the incentive to settle will be undermined. Allowing the taxpayer to withdraw from its stipulation would set a dangerous precedent discouraging parties from entering into future agreements. Stipulations represent the considered judgment of the parties after weighing the costs, risks, and benefits of litigation. The sanctity of these agreement must be upheld to ensure fairness and predictability in the PTAB process.
- The Assessor's change is unsupported and outside of the scope of the PTAB's jurisdiction. The taxpayer's reliance on the Cook County Assessor's unexplained reduction to \$520,793 lacks evidentiary support. The assessor's changed was issued without explanation or documentation and appears procedurally improper, given the pendency of the PTAB appeal. The assessor does not have the authority to unilaterally revise the 2021 assessment while the PTAB maintains jurisdiction over the matter.
- The PTAB cannot give any weight or deference to the assessor's reduction without further information. The taxpayer has failed to provide any evidence explaining or justifying the revised valuation. Speculation regarding the Assessor's motives or methodology is insufficient to support the extraordinary relief requested.
- Therefore, the intervenor requests the taxpayer's Motion to Vacate, Withdraw, and Reinstate be denied.

Relevant Facts

- The Appellant filed a petition seeking a rollover for tax year 2021 from a tax year 2020 PTAB decision. The appellant failed to file a copy of the 2020 PTAB decision. Instead, the appellant filed a letter stating that the property is in Lakeview Township, Chicago, and that tax years 2020 and 2021 were in the same general assessment period.
- Lakeview Township is in the Chicago triennial assessment period. Tax year 2021 is a new assessment period.

Lake View Township

Triennial Cycle: City of Chicago

Reassessed in: 2021, 2024, 2027, and every 3 years after.

- 10/24/2023 – PTAB finds the appellant's rollover petition incomplete and requests additional documentation, with a due date of 11/23/2024. The appellant failed to provide the PTAB decision letter lowering the assessment of a parcel on a residence occupied by the owner, within the same general assessment period.
- 01/02/2025 – PTAB finds the information submitted by the appellant did not satisfy the burden of going forward and dismisses the appeal for failure to fully comply with PTAB's rules.
- The subject property is located within the township of Lake View and tax year 2021 is the start of a new assessment period.

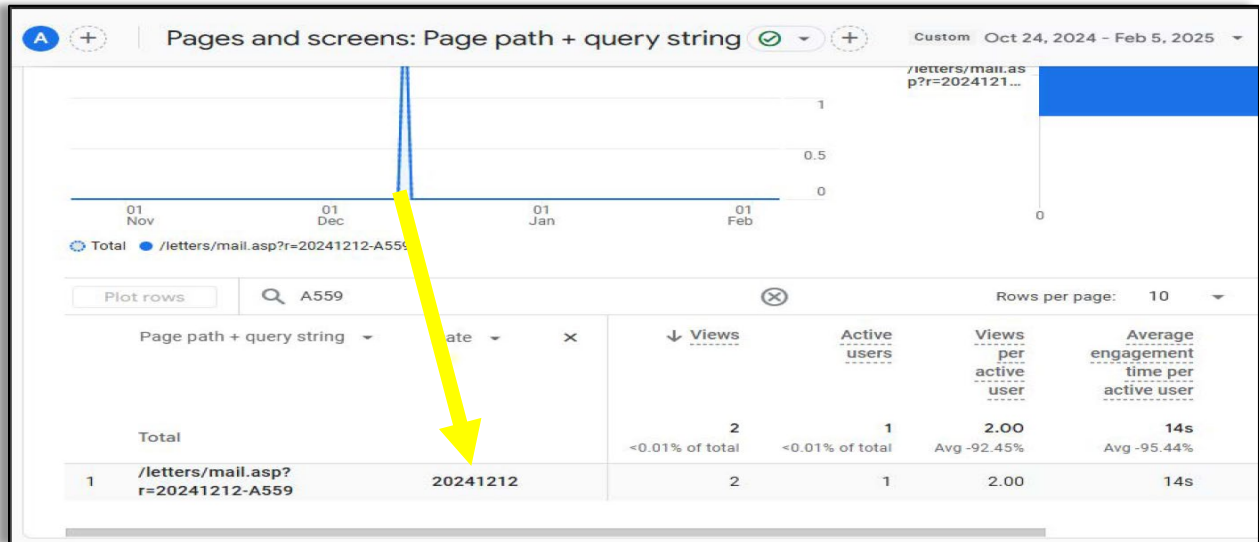
Request for an Extension to File Evidence

On 12/17/2024, the appellant through counsel submitted a request for an extension to submit the appellant's 2020 PTAB Decision as follows:

- Counsel contends PTAB's letter showed up in their mailbox on 12/17/2024.
- Counsel believes PTAB's letter was misdelivered to the neighbor who shares a duplex with counsel. Counsel's address is 9213 Burlington Brookfield and the neighbor's address is 9211.
- Counsel informs this is a common problem from the post office.
- The appellant waited 3 years for a result on his 2020 appeal and would be unfairly punished for this response being a few weeks late.

Relevant Facts as to Notice of the Incomplete Checklist

- On 10/9/2024, at 3:49 PM, the PTAB received an email from Wayne C. Borawski, the attorney for the appellant, which stated, "I forgot to add the 2020 PTAB decision to a 2021 direct rollover appeal before I submitted it how do I add it to the file? Thank you[.]"
- On 10/10/2024, at 12:15 PM, the PTAB responded to Mr. Borawski's email at the Yahoo email address on record with PTAB for Mr. Borawski, which also matches the email address that was sent to PTAB on October 9th, and the email address on the appellant's petition for appeal. The email stated, "You will be issued an incomplete appeal notice providing 30 days to submit the prior 2020 PTAB decision to establish jurisdiction. The response must be filed through the e-filing portal."
- On 10/24/2024, the incomplete checklist was emailed to the appellant's attorney at the Yahoo email address of record, per Rule 1910.30(i). The incomplete checklist was attached to the email, and the PTAB used Google Analytics to determine whether the appellant's attorney accessed the attachments.
- Google Analytics indicates that no one accessed the documents contained in the email until after the November 23rd, 2024, deadline.
