This matter was held over from the January 2025 board meeting to give the appellant time to hire an attorney. On March 4, 2025, James Tuneberg and Kenneth Benz of Guyer & Enichen, P.C., informed the PTAB that they would be appearing on behalf of the appellant.

Relevant Fact to Appellant's Motion

- 05/09/2024 – PTAB accepts the appeal as sufficient, notifies Stephenson County Board of Review (SCBOR), and provides them with a due date of 08/07/2024.
- 07/30/2024 – SCBOR requests a 60-day extension due to this case's complex and voluminous nature.
- 08/08/2024 - PTAB grants an extension with a due date of 10/07/2024.
- 01/14/2025 – PTAB votes to continue this matter to the March 2025 board meeting.

Board of Review's Motion

On 10/01/2024, SCBOR submits its evidence and a Motion to Dismiss Appeal. SCBOR argues that the appellant has failed to offer the PTAB evidence to justify the relief requested and that the appellant bears the burden of proving his claims by clear and convincing evidence in accordance with 89 IL ADC 1910.63(e). Additionally, if the appellant fails to provide substantive, documentary evidence, his appeal must be dismissed, per 89 Ill. Admin. Code 1910.63(b). SCBOR further states there are restrictive rules relating to the submission of evidence at hearings, per 89 Ill. Admin. Code 1916.67(k), and the appellant has failed to meet his burden as follows:

- The appellant's first contention is that his property is not assessed in the same manner as other condominium parcels, which have been set at \$1. The appellant fails to include any authority on why any such parcels should be assessed at \$1. And fails to note important distinguishing information.
- The appellant claims his property should be assessed at \$1 because this is the practice in Freeport for dealing with as-yet unconstructed condominium units. The appellant offers, as evidence, the assessment for eight parcels related to the Edge of the Meadows Condominium plat. The appellant claims that the assessment for these parcels is not anomalous. SCBOR contends that the property assessment is anomalous and the properties are materially dissimilar.
- SCBOR asserts that understanding how these parcels were ultimately assessed at \$1 requires some review of the development's history. In 2005, this property was assessed as farmland with a valuation of \$1280. A condominium plat was filed, dividing the parent parcel into 47 child parcels. The parcels were assessed at \$27 per parcel. The following year, the assessment increased to \$150 per parcel and remained at this level until 2012.
- From the beginning and after a few of the condominiums were built, flooding, financial difficulties, and litigation grounded the development's forward momentum to a permanent halt.
- The property was mortgaged by FDI Inc. through Amcore Bank. The FDIC took over for Amcore Bank on 04/23/2010, and its assets were transferred to Harris Bank (later BMO Harris). In 2012, Amcore Bank dba BMO Harris and the Edge of the Meadows Association sued FDI Inc. for failure to live up to its financial obligations concerning the subject properties. On 06/04/2012, a judgment was entered against FDI, Inc on behalf of Amcore Bank dba BMO Harris and Edge of the Meadows Condominium Association, awarding them a judgment in the amounts of \$1,613,587.10 and \$110,257.46, respectively.
- The plats the appellant offers as a model of the common practice in Freeport were additionally encumbered by liens. These liens substantially eclipsed the estimated value of these properties, so in 2013, their assessments were lowered to \$1 under the theory of economic obsolescence.

- Before the assessments being lowered for these plats, they were assessed exactly as the appellant's parcels are currently assessed.
- The appellant's property is assessed in accordance with Illinois Department of Revenue Publication 134. There are some small distinctions to be made because the Edge of the Meadows Condominium plat was converted from farmland to residential vacant land and the appealed parcel remained residential vacant land and have received the same treatment at the same points in their development.
- The reduction in the assessment of the parcels on the Edge of the Meadows was based on circumstances that are in no way similar to that of the appellant's property and cannot contribute to a quantum of proof that the appellant's land had been inequitably assessed.
- The appellant's ninth comparable property is a common area owned by a condo association and as such is taxed at \$1 and its value has been added to the assessments of the buildings within the condo association as provided by law, 765 ILCS 605/10(a). A condominium association does not exist for the appellant's parcel and this statute cannot apply to them.
- The appellee contends the appellant's tenth through twelfth comparable properties are not part of a condominium plat, and they are not in a comparable location.
- The SCBOR asserts the appellant also claims that he has a garage on his property that he plans to demolish and cannot use because it does not meet current zoning requirements. However, the SCBOR has photographic evidence that it is currently in use for the storage of gardening and lawn care equipment, which is a legal nonconforming use.
- Therefore, the SCBOR prays this matter be dismissed.

Appellant's Motion

On 10/21/2024, the appellant submitted a Request for Extension of Time to File Response to the Appellee's Motion to Dismiss as follows:

- The appellant's counsel of record has been required to withdraw due to an asserted conflict of interest by the Board of Review.
- Substitute counsel could not assist as originally expected, leaving the appellant unrepresented.
- SCBOR requested and was granted a 60-day extension to file its response and evidence. SCBOR has filed a Motion to Dismiss, which is atypical. The appellant was advised that he has only 21 days to object or file a response to the Motion to Dismiss.

- The appellant objects to granting the Motion to Dismiss as it is primarily factual in nature and deprives the appellant of an opportunity for the requested hearing.
- The appellant avers that he has a valid defense to the Motion to Dismiss and has diligently sought alternative counsel. He continues to do so but has yet to retain counsel to meet the filing due date.
- The appellant contends that due to the timing of SCBOR's filing and their extension, the appellant's response is due at the same time tax practitioners are preparing 2024 assessment objections, making it challenging to retain qualified counsel.
- Therefore, the appellant requests a 60-day extension to file a response to the Motion to Dismiss

- 06/06/2024 – PTAB accepts the above appeal, notifies the Cook County Board of Review (CBOR), and provides a due date of 9/04/2024 to submit evidence or a written request for an extension.
- 07/09/2024 – PTAB grants Cook CBOR a final extension with a due date of 12/03/2024. On 11/22/2024, Cook CBOR submits its evidence.
- 07/01/2024 – Lansing School District No. 158 and T-F High School District No. 215 submit their requests to intervene; on 08/01/2024, PTAB adds them as intervenors, with a due date of 10/30/2024 to submit their evidence and on 10/22/2024, the intervenors submit their evidence by adopting the BOR's evidence.
- 12/19/2024, all parties of the appeal are notified that the filing period for submission of evidence regarding this case is now closed and the appellant was granted a 30-day period to submit its rebuttal evidence.

Motion for Leave to File Appraisal

On 01/09/2024, the appellant, through counsel, submitted a motion for leave to file the correct appraisal dated 01/01/2023 as follows:

- On 03/25/2024, the appellant filed this 2023 appeal for the first year of the triennial, which included an appraisal, property operating data, and a supporting brief.
- The appellant's brief referenced an appraisal prepared by Chicago Commercial Appraisal Group valuing the property at \$1,130,000 as of 01/01/2023. The brief included a summary of the appraiser's income and sales approaches to value. The 2023 appraisal is attached to this motion. The appellant's PTAB complaint requests relief in the form of an assessed value of \$282,500, which equates to a market value of \$1,130,000, the appraisal value.
- On 12/19/2024, the appellant received evidence from all parties to the appeal and determined that, first, the other parties to the appeal did not object to or

reference the appellant's evidence, and second, the appellant discovered the wrong appraisal was submitted with its initial filing. An earlier appraisal of the same property was attached to the appellant's filing.

- The appellant requests leave to file the 2023 appraisal instanter. Granting the appellant's request will not prejudice the other parties to the appeal. The appellant contends that the county and intervenors did not address the appraisal, waiving any objection. Giving the county and intervenors an opportunity to review and address the 2023 appraisal will not unnecessarily delay the case.
- The appellant expects to file appeals with PTAB in 2024 and 2025, which will include the 2023 appraisal. Judicial economy supports having a complete record for all three years of the triennial.
- The appellant requests PTAB enter an order granting the appellant's motion and allowing the appellant to file the 2023 appraisal instanter.

- 04/04/2024 – PTAB accepts the above appeal, notifies the Coles CBOR, and provides a due date of 07/03/2024 to submit evidence or a written request for an extension.
- 07/01/2024 – Coles CBOR submits its evidence using the e-filing portal.
- 07/02/2024 – Coles CBOR submits additional evidence by mail.
- 11/12/2024 – PTAB administratively closes the appeal.
- 11/12/2024 – Coles CBOR submits via US Mail a signed stipulation for a total assessment of \$89,991, which is received by PTAB on 11/14/2024.
- 11/19/2024 – PTAB finds, based on the facts and exhibits presented in the matter, that no change in the assessment of the property as established by the Coles CBOR is warranted, and the correct total assessed valuation of the property is \$125,750.

Motion for Amended Decision

On 01/28/2025, the appellant, through counsel, submitted a motion for an amended decision as follows:

- On or about 03/25/24, the appellant filed an appeal, the subject property was sold by appellant in an arm's length sale for a purchase price of \$270,000 on or about 10/11/2024.
- Soon thereafter, Coles CBOR contacted counsel for the appellant and offered to resolve the pending appeal by stipulating an assessed value based on the actual sales price of the subject property.
- The appellant agreed to this compromise and on 11/06/2024, entered a stipulation of assessment by the parties, which was received by PTAB on 11/14/2024.
- At or about the same time the stipulation was received, PTAB issued a decision finding "no change."
- On 01/27/2025, counsel for the appellant contacted Coles CBOR to inquire why the appellant had not yet received a refund based on the stipulation described above. Coles CBOR advised that no refund was issued due to the PTAB decision finding "no change."
- The appellant and Coles CBOR continue to agree the assessed value of the subject property for 2023 should be reduced to that reflected in the stipulation between the parties of the appeal dated 11/06/2024, based upon an actual arm's length sale of the subject property.
- The appellant prays PTAB will issue an Amended Decision based upon the stipulation of the assessment of the parties entered on 11/06/2024 and grant such other and further relief as PTAB deems equitable and just.

- 01/16/2025 – PTAB finds the above appeal was not timely filed and dismisses the appeal due to a lack of jurisdiction.

Motion for Reinstatement

On 01/29/2025, the appellant submitted a motion for reinstatement as follows:

- According to the Cook County Board of Review's (BOR) website, 2024 results for Oak Park Township were transmitted on 11/27/2024, state law requires appeals to PTAB be filed within 30 days of the transmittal date, 12/27/2024. The appellant's appeal was filed 01/05/2025.
- The appellant avers the 11/27/2024 transmittal date is illusory and as of 01/26/2025, neither the BOR nor the Cook County Assessor show the board's Oak Park decisions for 2024 on their websites (see attached printouts).
- The lack of transparency regarding the Board of Review's 2024 decisions undermines the point of the law, giving taxpayers 30 days after the transmittal date to file an appeal with PTAB. The appellant contends most residential appeals are based on comparing a subject's property's assessed value with the assessments of similar comparable properties. To do this, it is necessary to

know the final 2024 decisions made by the BOR for Oak Park properties. But this is not possible when those decisions have not been made public.

- In accordance with Section 16-125 of the Illinois Property Tax Code, in relevant part states:
 - An order for correction shall be made in open session and entered in the records of the board. When an assessment is ordered corrected, the board shall transmit a computer printout of the results...and shall deliver a copy of the statement to the county assessor. 35ILCS 20/16-125.
- Reference to an open session contemplates that citizens would be able to see the BOR's corrections. Since this was not the case as of November 27th, the BOR has not transmitted its data within the meaning of the statute. Accordingly, PTAB shall have jurisdiction to hear the above appeal.
- The appellant assumed based on prior years that there was time to file an appeal and was shocked to find the BOR had apparently transmitted its data so quickly. In looking into why the time for filing was shorter than in prior years the appellant noticed a key change in the BOR form.
- Prior to tax year 2024, there was usually a delay of a few weeks between the final decisions made by the BOR and the date of transmittal. In addition, prior to 2024, the decision date form issued by the BOR had five columns ending with "Transmittal Date."
- In 2024, however, Oak Park's transmittal date was the same as the date the final decisions for Oak Park were made and the 2024 Decision Date form added a sixth column, CCAO Certification, that had not been there before.
- The appellant contends that the addition of the new CCAO Certification column gives a clue as to what is going on. As of 01/26/2025, the BOR Decision Date form indicated that nothing has been certified by the Cook County Assessor's Office for Oak Park Township. Essentially, the BOR is blaming the county assessor's office for the lack of public notice of its 2024 decisions.
- The appellant avers that this is not new. The Cook County Assessor and Cook County BOR have been blaming one another for years for problems in data transmission. This dispute is unfortunate in that it has led to long delays in Cook County releasing second installment tax bills in recent years.
- The appellant does not desire to take sides in the ongoing data dispute between the taxing agencies in Cook County, but desires to have the above appeal reinstated in order to exercise their right to file an appeal and a dispute among elected officials should not undermine that right.

Relevant Facts

- 12/05/2024 – PTAB finds the above appeal incomplete and requests additional information with a due date of 01/06/2025.
- 01/30/2025 – The appellant inquired by email about the above docket and informed the PTAB that the requested total assessed value information was accurate. PTAB responded by email, informing the appellant did not respond to the incomplete notice dated 12/05/2024, which was due 01/06/2025, and informed the appeal would be dismissed.
- 02/13/2025 – PTAB dismisses the above appeal for failure to provide substantive, documentary evidence or legal argument sufficient to challenge the correctness of the assessment of the subject property.
- The PTAB sent the 12/05/2024 incomplete notice by email to the attorney of record. The PTAB uses Google Analytics to monitor if recipients open PTAB emails. PTAB's IT staff determined that the 12/05/2024 email was opened by counsel on 12/5/2024. The email contained 41 letters in this mailing: hearing

notices, acknowledgment letters, an intervenor filing and two incomplete notices.

Motion to Reinstate

On 02/13/2025, the appellant submitted a motion to reinstate as follows:

- On 11/12/2024, the petitioner's attorney and the Board of Review stipulated a Total Assessed Value (TAV) of \$147,000 to cover all three PINs of this appeal.
- On 11/22/2024, the petitioner's attorney submitted a rollover appeal to PTAB with erroneous values for the 3 PINs.
- On 12/05/2024, the appellant was granted a 30-day extension to return corrected documents, which were submitted on 01/30/2024.
- Having submitted the corrected documents to PTAB after the deadline, the case was dismissed on 02/13/2025.
- The delay in submitting the corrected values was the product of clerical error. It was the assumption of counsel that the corrected values had been submitted within the 30-day extension window.
- The appellant through counsel requests equitable relief from PTAB and asks it to enter an order to allow the reinstatement of the 2020 docket in the above case and to reinstate the \$147,000 assessed value pursuant to the attached stipulation and corrected addendum.
