On 02/27/2025, the appellant, through counsel, submitted a motion to amend decisions as follows:

- In processing the PTAB 02/18/2025 decisions, counsel discovered a clerical error.
- The subject property is comprised of three PINs.
- The total assessed value, as stipulated by the parties, is correct and identical for all tax years at issue. However, the allocation of the total assessed value among the three PINs causes two of the PIN values to increase. This will result in the Treasurer's Office having to issue Open Item Tax Bills.

Motion to Reinstate

On 02/27/2025, the appellant, through counsel, submitted a motion to reinstate as follows:

- On 12/04/2024, the appellant filed an appeal from an 11/19/2024 decision of the Cook County Board of Review (CBOR). The Cook CBOR had not yet published the certified Board of Review (BOR) assessed values at that time. The appellant was uncertain as to the assessor's certified values for comparable properties the appellant intended to submit as evidence in an assessment equity brief, and therefore inserted \$0 values for land, building, and total assessed values in the appellant assessment request on the residential appeal form as placeholders until such time as the assessor certified assessed values became available.
- The appellant requested a 90-day extension of time to allow the county assessor to publish certified BOR-assessed values for the current tax year. The appellant was uncertain of how her two improvements' assessed values compared to the values of comparable properties to support her uniformity of assessment argument.
- The appellant received PTAB's incomplete checklist on 12/19/2024.
- On 01/13/2025, the appellant submitted a second request for a 90-day extension of time, as the county assessor had still not certified and published 2024 assessed values for Oak Park Township, rendering the appellant unable to assemble her evidence. As a result, the appellant continued to request \$0 values for land, buildings, and total values on the submitted residential appeal form.
- On 01/30/2025, the appellant's petition was dismissed.
- The appellant asks PTAB to reinstate this appeal, allow the opportunity to amend the appellant's assessment request, and submit evidence supporting the appeal.
- The assessor's certified BOR assessed values for 2024 Oak Park Township are now published. A revised, fully completed 2024 residential appeal form with the appellant assessment request, supporting taxpayer's brief, and documentation are attached to this motion.
- The appellant requests that PTAB issue an order reinstating the above appeal and grant the appellant an opportunity to present evidence in support of the appeal to meet the burden of going forward.

Relevant Facts

- Appeals from a tax objection decision are pending in the appellate court for tax years 2020 and 2021.
- 12/22/2022–The Village of Vernon Hills filed the instant undervaluation appeal with PTAB for the tax year 2022 based on the subject's recent sale and an appraisal.
- 9/1/2023–The property owner filed a tax objection complaint in Lake County Circuit Court for tax year 2022, in which the property owner argued that the Board of Review's revaluation of the property in a non-quadrennial year was improper.

- 4/8/2024—On a motion by the property owner, PTAB allowed the property owner to argue why he should be allowed to expand the basis of the appeal beyond the appellant's market value claim.
- 2/19/2025—PTAB scheduled and notified the parties that a hearing for the 2022 and 2023 PTAB appeals would be held on May 21 and 22, 2025.

Motion to Stay

On 02/24/2025, the property owner, through counsel, submitted this Motion to Stay and Bifurcate Appeals as follows:

- The subject property consists of a 260-unit apartment building constructed in 2018.
- The tax year 2019 was the start of a new quadrennial assessment period.
- The assessment was increased in tax years 2020 and 2021.
- The property owner filed a consolidated tax objection complaint in circuit court for tax years 2020 and 2021, with the circuit court finding in the property owner's favor.
- The Village of Vernon Hills appealed the circuit court's decision to the appellate court, which is currently pending.
- The property owner argues further that consolidation of the 2022 and 2023 PTAB appeals is not permitted under PTAB Rule 1910.78, as the two appeals do not involve a common issue of law or fact and the owner would therefore be prejudiced if the two appeals are consolidated.
- The property owner requests that PTAB hold separate hearings in the 2022 and 2023 appeals and seeks a stay of the 2022 tax year appeal pending the appellate court's ruling.
