- 04/03/2025 – PTAB finds the evidence/response was not filed in a timely manner and dismisses the appeals.

PTAB Rule 1910.30(m) states:

If the petition for appeal is filed by an interested taxing body, rather than by the owner or taxpayer whose assessment is in question, the taxing body must furnish the name and address of the owner and/or taxpayer of the property in question, if different from the owner, the name and address of the registered agent of the corporate owner or taxpayer, or the name and address of any partner or registered agent of a partnership owner or taxpayer. A copy of the completed petition shall then be sent to the owner

and/or taxpayer of the property by the Clerk of the Property Tax Appeal Board. Any petition filed by an interested taxing body on property owned by a corporation or partnership must be served upon the registered agent of the corporation or upon any partner or registered agent of the partnership by mail, with proof of service filed with the Board. Any petition filed by an interested taxing body without the name and address of the owner and/or taxpayer of the property in question shall be treated as an incomplete petition in accordance with subsection (k).

Appellant's Motion

On 04/25/2025, the Appellant submitted a motion to vacate docket 21-57893 pursuant to PTAB rule 1910.50 (d) and states as follows:

- The Appellant retained counsel to file the 2021 assessment appeal on behalf of all unit owners with PTAB. Counsel reached a settlement agreement with Cook CBOR and submitted a stipulation reflecting that agreement.
- PTAB issued a decision reflecting the stipulation reached by the parties.
- During the refund application process, the Cook County Treasurer's Office informed counsel that Certificates of Error were issued on four units for parcels 09-15-307-202-1054 and -1055.
- The Treasurer intends to issue open item bills to each unit owner based on the increase caused by the PTAB decision.
- Counsel on behalf of the taxpayers' request PTAB vacate the PTAB decision and allow for dismissal of these two parcels from Docket No. 2021-57893. Counsel further requests that the PTAB reinstate the decision for the remaining PINs and assessments as reflected on the original decision.
- Granting this motion will avoid an unjust result for the taxpayers and will not prejudice the respondent.
