Relevant Facts to BoR’s Dismissal Motion

- Kane County's most recent quadrennial (general assessment) cycle begins with tax year 2023.
- 01/06/2025 – Appellants postmarked a "direct appeal" for the tax year 2023 based on the PTAB favorable decision in Docket No. 22-02551 issued on 12/17/2024, which was docketed as 23-06110 [pending for rebuttal filing notification].
- 01/06/2025 – Appellants also postmarked a "direct appeal" for the tax year 2024 based on PTAB's favorable decision in Docket No. 22-02551 issued on 12/17/2024, which was docketed as 24-00154.
- 01/30/2025 – Kane CBOR was notified of the 2024 appeal and given 90 days to respond.
- 02/18/2025 – Kane CBOR seeks dismissal of the 2024 appeal based on Section 16-185 of the Property Tax Code.

- 02/28/2025 – PTAB forwards a copy of the 2024 dismissal motion to the appellant and grants 30 days for a response.
- 04/14/2025 – Appellant Roberta Boston made a telephone inquiry to SPO about the above letter and motion served while she was overseas. Staff advised that the 2024 tax year appeal would be dismissed; however, if a favorable decision is rendered in the pending 2023 tax year appeal [23-06110], appellants could then appeal the 2024 tax year within 30 days of the 2023 decision issuance date.

BoR's Dismissal Motion

On 02/18/2025, the BOR submitted its Motion to Dismiss the Appeal. Kane CBOR argues that the Property Tax Code allows a taxpayer to file an appeal “[I]f the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the board of review or board of appeals or after adjournment of the session of the board of review or board of appeals at which assessments **for the subsequent year or years of the same general assessment period**, . . . , are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board’s decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board.” 35 ILCS 200/16-185 [emphasis added].

- This 2024 appeal was filed from a “non-immediately” ‘preceding’ tax year 2022 decision of the PTAB.
- [The taxpayers have an assessment complaint before PTAB for the "subsequent [tax] year" of 2023, which has not yet been decided.]
- No complaint was filed with the Kane CBOR for the 2024 year.
- No decision has been issued on the 2023 pending appeal before the PTAB.
- Therefore, in accordance with Section 16-185, the Board has no jurisdiction to hear a 2024 appeal and requests it be dismissed.
- Taxpayers did not timely respond to the pending dismissal motion but, based on a telephone inquiry, have been informed of impending dismissal for lack of jurisdiction.

Relevant Facts

- 02/20/2025–PTAB accepts the above appeal, notifies the Kane County Board of Review (CBOR), and provides a due date of 5/21/2025 to submit evidence or a written request for an extension.
- The assessment year 2023 marks the start of a new assessment period for Kane County.

Motion to Dismiss

On 03/04/2025, Kane CBOR submitted its motion to dismiss as follows:

- The Illinois property tax code provides that a taxpayer dissatisfied with the decision of a board of review may, within 30 days after the date of the written notice of the board of review's decision, appeal the decision to the Property Tax Appeal Board (PTAB). 35 ILCS 200/16-160.
- Generally, based on section 16-160 of the property tax code, as a prerequisite for the PTAB to acquire jurisdiction, there must be a decision from the board of review pertaining to the assessment of the property in question. The taxpayer must then file an appeal with PTAB within 30 days of the board of review decision. *Spiel v. Property Tax Appeal Board*, 309 Ill.App.3d 373, 722 N.E. 2d 306 (2nd Dist. 1999). Or, if the Board of Review is no longer accepting appeals for the year being appealed, they may file directly to the PTAB.
- The lone statutory exception to the prerequisite of a decision from the board of review is "[I]f PTAB renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the board of review or after adjournment of the session of the board of review or board of appeals at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-215 through 9-225, after being considered, the

taxpayer may, within 30 days after the date of written notice of the PTAB's decision, appeal the assessment for such subsequent year or years directly to the PTAB. 35 ILCS 200/16-185.

- The general assessment period starts in 2023.
- The taxpayer filed an appeal to PTAB regarding the assessed valuation of the property for the 2024 year docketed as 2024-00388.
- The appellant filed this 2024 tax year appeal from a “non-immediately succeeding” favorable tax year 2022 decision of the PTAB.
- The appellant did not exhaust the administrative remedy of filing an assessment complaint with the Kane CBOR for the 2024 year as required under 35 ILCS 200/16-160 and has not filed an assessment complaint based on a favorable “subsequent year” PTAB decision as required under 35 ILCS 200/16-185.
- There was no complaint filed with the Kane CBOR for the year 2024, and no decision was issued; therefore, the appellee contends PTAB has no jurisdiction to hear an appeal since there was no decision to appeal.
- Additionally, the appellee contends as the taxpayer has not received a decision lowering the assessment of the parcel in an immediately succeeding prior year to the 2024 year, the PTAB has no jurisdiction to hear a direct appeal.
- Kane CBOR requests PTAB dismiss the above appeal.

Relevant Facts

- 02/20/2025 – PTAB grants the appellant a 90-day extension and provides a due date of 05/21/2025 to submit their evidence or a request indicating good cause why the Board should grant an additional extension.

Appellants' Motion

On 04/29/2025, the appellants submitted their motion to stay proceedings pursuant to 86 IAC 1910.30, requesting that PTAB issue an indefinite extension/stay of the petitioner's deadline to file evidence as follows:

- PTAB rules give PTAB the discretion to grant further extensions of time to submit evidence "for good cause shown," and the rules direct PTAB to conduct each hearing "in a manner best calculated to conform to substantial justice."
- This property is currently under appeal for tax years 2022 (22-02863) and 2023 (23-03721).
- In the 2022 appeal, all evidence filings have been completed, and the case has been scheduled for a pre-hearing conference on 05/06/25, with an anticipated trial date later this year.
- On 04/10/2025, PTAB informed the petitioner for the 2023 appeal that all evidence had been filed by intervenors and provided the petitioner thirty days, or until 05/12/2025, to file rebuttal evidence.
- The petitioner is in the process of gathering rebuttal evidence. The petitioner is in the process of gathering rebuttal evidence to complete the evidence filing for the 2023 appeal. The petitioner and intervenors in the 2022 and 2023 appeals have agreed to request that PTAB consolidate the appeals into a single trial.
- The outcome of the consolidated appeals will impact the 2024 appeal as issues to be resolved in the consolidated appeals will almost certainly impact the evidence gathered for future years. Additionally, agency efficiency will increase by allowing the consolidated appeals to reach finality before requiring the parties to submit affirmative evidence in the 2024 appeal. Accordingly, good cause exists to extend indefinitely or stay, the evidence filing deadlines in the 2024 appeal until the resolution of the consolidated appeals.
- The petitioner has contacted counsel for the county and the intervenors of the 2022 and 2023 appeals, and they have indicated they do not object to the petitioner's request.

- The petitioner requests PTAB grant this motion and stay the above appeal until the 2022 and 2023 consolidated appeals are resolved.

- 11/04/2021–PTAB accepts the above appeal, notifies the Cook County Board of Review (CBOR), and provides a due date of 02/02/2022 to submit evidence or a written request for an extension.
- 12/06/2021-Cook CBOR requests an additional 90-day extension, PTAB grants a final 90-day extension, and on 04/06/2022 Cook CBOR submits its evidence.
- 02/17/2025-The parties of the appeal agree to the stipulated land assessment of 95,290, improvement assessment of 29,710, and total assessment of 125,000.
- 04/15/2025-PTAB finds the agreement of the parties is proper.

Motion to Vacate PTAB Final Decision & Reinstate Complaint

On 05/08/2025, the appellant submitted their Motion to Vacate PTAB Final Decision & Reinstate Complaint as follows:

- During negotiations with Cook CBOR to resolve the issue of the 2019 PTAB complaint for the same property, the appellant mistakenly thought that the final assessment for PIN 03-30-116-015 for the tax year 2020 was the same as the 2019 final assessment. However, the 2020 Assessor's certified assessment was already lower at an assessment of \$54,998 due to the assessor's automatic COVID reduction in 2020.
- Based on the erroneous assumption, the appellant requested that for 2020, the assessment be corrected to \$57,482. The Cook CBOR agreed to the disposition of this additional case with the understanding that the appellant was asking for the total combined assessment for 2019 and 2020 to be reduced to \$125,000.
- The appellant subsequently discovered that the 2020 assessment for PIN 03-30-116-015 was \$54,998, and the requested assessment of \$57,482 would raise the assessment for 2020.
- There was no intent on either party to increase the 2020 assessment for PIN 03-30-116-015, and the resulting refund would be the same, but procedurally, the appellant would need to pay for the increase for PIN 03-30-116-015.
- The Cook CBOR has agreed to allow the appellant to withdraw the case without raising the assessment and has agreed to the correction of the stipulation.
- The appellant prays PTAB will allow, in this instance, to vacate the final decision and reinstate the complaint for the purpose of correcting the assessment without raising the assessment to the below values:
