- 04/17/2025-The appellants filed their appeal from McHenry County Board of Review (CBOR) Notices of Final Decision dated 03/17/2025.
- 05/15/2025-PTAB finds the appellants' petition requests were not timely filed, and therefore, PTAB lacks jurisdiction and dismisses the appeal.

Appellant's Motion to Reinstate

On 05/28/2025, the appellants submit their motions to reinstate as follows:

- Counsel for the appellants believes that, upon reviewing the files, there was a simple scrivener's error in docketing the dates from written notices of decision by the McHenry CBOR, and that the justice of their clients should not be barred from review by PTAB.
- The Administrative Code allows for requests and extensions of time for good cause shown. The above instances are good cause as the actions were not done maliciously and were, in fact, docketing errors of one day. Further, if the petitions were incomplete or filed in error, the petitioners would have the opportunity to refile within 30 days of notice.

- Simply dismissing the actions with no ability to rectify the errors fails to allow the taxpayers the review of an erroneous assessment of their properties.
- The Illinois Supreme Court has made clear the intent to allow for extensions of time to file if an appellant can demonstrate a “reasonable excuse” for the delay. Courts have interpreted this standard leniently, covering a wide range of reasons, including honest mistakes by counsel, such as inadvertent docketing errors.
- Upon receipt of the 05/15/2025 correspondence, counsel promptly undertook legal research and procedures to respond to the Board in a timely manner.
- Counsel and the appellant ask for consideration of the requests to reinstate these appeals.

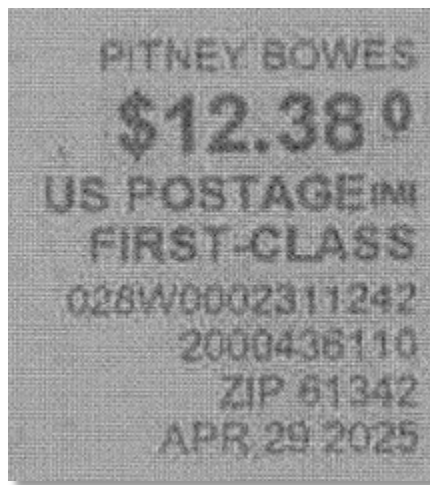

Relevant Facts

- 10/26/2023 – PTAB grants the appellant an extension with a due date of 01/24/2024.
- 01/19/2024 – The appellant submits a Motion to Stay Proceedings to Implement Certificate of Error (CoE) for one year as follows.
 - The final 2022 assessment for the subject equates to a 100% increase over the prior year, 2021. Therefore, the appellant filed an appeal to PTAB.
 - In preparation for the appeal, the appellant secured the notes and workup files from the Cook County Assessor (CCA) and Cook CBOR that were used to establish the 2022 assessments. In reviewing those records, two errors were discovered: one factual and one legal.
 - A factual error occurred when the CCA inadvertently used the incorrect square footage for the subject in its calculations. The improvement contains 171,947 square feet; however, CCA applied an incorrect footage, which resulted in the CCA's final 2022 value being more than double what it would have been if the correct square footage was used.
 - In the Cook CBOR workup notes, a legal error occurred when the Board failed to consider the environmental remediation that is required at the subject property at the conclusion of GE's business operations. Cook CBOR referred to the remediation as an "extraordinary assumption."
 - The appellant contends the remediation is a legal and statutory obligation required pursuant to GE's Radioactive Material License and the Illinois Administrative Code (32 Ill. Adm. Code 330).

- The subject property operates under a Radioactive Material License issued by the State of Illinois Emergency Management Agency, Division of Nuclear Safety, and is governed by Part 330 of the Illinois Administrative Code relating to Licensing of Radioactive Material. (32 Ill. Adm. Code 330).
 - Therefore, when GE ceases operations at the subject, the licensee must meet the requirements of Section 330.325, which include requirements for obtaining termination of a specific license and removal of a site or location of use from a specific license.
 - Before GE can terminate its license at the subject property, the cyclotrons and their surrounding vaults would have to be fully decommissioned, and all the radiological areas would need extensive environmental remediation.
 - The current cost estimate to complete this work is more than \$30 million. Therefore, those costs must be considered in valuing the subject property.
 - The appellant has had extensive discussions with the CCA, and they have now acknowledged the errors and the need to correct the assessment.
 - The appellant and CCA have agreed to a revised 2022 assessment, which will obviate the need to further proceed with the appeal at PTAB.
 - The 2022 assessments have already been certified, therefore, the CCA will need to issue a CoE to revise the 2022 assessment and is currently in the process of preparing the CoE.
 - By statute, since the appellant filed a 2022 appeal with the Cook CBOR the CoE must be endorsed by the Cook CBOR, certified by CCA, and then presented in Circuit Court for adjudication. (35 ILCS 200/14-15 (a). The timing of the CoE is controlled by statute and cannot be presented to the court until the 2022 annual tax sale. It is anticipated the 2022 tax sale began in the first part of 2025. Upon entry of the CoE in the Circuit Court of Cook County, the appellant will promptly withdraw its 2022 PTAB appeal. The CoE will resolve the factual and legal issues and there would be no other issues for PTAB to consider.
 - Therefore, the appellant requests PTAB to Stay Proceedings in the appeal for one year and the appellant will provide an update on the status of the CoE.
- 02/08/2024 – PTAB grants the appellant an extension until 02/07/2025.
 - 01/10/2025 – The appellant requests a continuance of the Stay of Proceedings and/or extension of time to file evidence for 180 days after 02/07/2025, as the subject property is awaiting the 2022 CoE to be entered in the Circuit Court of

Cook County and upon entry of the CoE, the appellant will withdraw the 2022 appeal.

- 01/23/2025, PTAB grants the appellant a final extension with a due date of 07/22/2025 to submit evidence.

Appellants' Motion

On 07/17/2025, the appellant requests an additional extension of time to file evidence as the CoE has yet to be adjudicated as follows:

- The 2022 tax sale began on 12/10/2024, and the appellant has followed up with the CCA numerous times to check on the status of the CoE.
- They were initially informed the CCA's Office sent them to the State's Attorney's Office in February, only to later learn they were not submitted until 04/18/2025.
- The CoE's must be endorsed by the Cook CBOR and the State's Attorney's Office and then returned to the CCA for certification before they are presented to the Court.
- The process of certification has been temporarily halted due to a technology related issue with Cook County and an anticipated timeline was not provided on when the process will resume.
- Due to circumstances beyond the appellant's control the appellant is requesting a Motion to Stay Proceedings until the CoE is issued and the appellant will then immediately withdraw the appeal.

- 05/22/2025 – PTAB finds the above appeals were not timely filed. Therefore, PTAB lacks jurisdiction and dismisses the appeals.
- Tax year 2022 is the start of a new triannual assessment period for Northfield Township in Cook County.

Appellants' Request

On 06/17/2025, the appellant submits his Request to Reinstate the above appeals as follows:

- The appellant avers he contacted the Treasurer's Office to determine when he could expect the refund check due to his favorable PTAB Decision for Docket No. 22-52408.
- The appellant contends he had PTAB appeal forms completed for tax years 2023 and 2024, and that he was planning to submit them to PTAB. However, the person at the Treasurer's Office advised the appellant that the Treasurer would issue his check for 2022, but their office did not yet receive the PTAB final decision.
- The appellant was advised that the Treasurer's Office would issue the refund check within six weeks of receiving the administrative decision.
- The appellant contends he told the person in the Treasurer's Office he would be submitting the refunds forms for 2023 and 2024 and at that time he was advised that the process had been changed and the Treasurer's Office will process the 2023 and 2024 automatically, and there was no need to submit his application.
- The appellant informed that he unfortunately followed this direction.
- The appellant recontacted the Treasurer's Office after receiving his refund check for 2022 to inquire about the status of the 2023 and 2024 checks. At that time a different person advised the appellant he needed to go through the Board of Appeal.
- The appellant contacted the Board of Appeal, and they advised the appellant that nothing could be done and that he would need to file an appeal with PTAB for 2023 and 2024.
- The appellant respectfully requests that PTAB accept his appeals for the remaining years within the triannual period. The subject was ready to follow the PTAB procedure; he completed the appeal forms, but due to incorrect advice, he missed the deadline.

- 05/29/2025 – PTAB finds the appeal request was not timely filed with the agency, therefore PTAB lacks jurisdiction and dismisses the appeal.

Request to Reinstate

On 06/11/2025, the appellant submits their Request to Reinstate as follows:

- The appellant avers that his DocuSign Signature was created on May 8, 2025, and therefore, his appeal filing date is within the 30 days after the date the Board of Review transmits its final action regarding Northfield Township to the Cook County Assessor.
- Additionally, the appellant's DocuSign Signature and Appeal form Sections I, II, III, and V were completed on May 8, 2025.
- However, in the evidence upload process, a file attachment was identified as too large. During the process of splitting the attachment into multiple files with fewer pages per file to upload, which took time, but not 60 minutes of inactivity, the session abruptly terminated. The appellant did not have a link to access the envelope again that evening to finish uploading evidence within the 30-day filing deadline.
- 60 minutes of inactivity did not occur; therefore, the appellant does not know why the session was terminated.
- The appellant did not request the option to "finish later" when the attachment file was identified as too large, which in hindsight would have provided a link to access the envelope again that evening, as the appellant intended to finish the form with evidence in a single session and did not anticipate that the session would later be terminated.
- Once the session was terminated, the subject's hands were tied. PTAB IT assistance was not available as their business hours had ended for the day, and PTAB's directions state that an appellant should not create more than one envelope for an appeal.

- Section II, Item 2d enables the appellant to request an extension of time to submit evidence. In this instance, if that box had been checked the extension request would have been timely submitted.
- The appellant requests the above docket be reinstated, with evidence attached on 05/13/2025 with the envelope link provided by PTAB's IT.

Relevant Rule: 1910.33(h): If a petition for appeal or supporting evidence is not successfully transmitted, or is materially delayed in being transmitted, to the Board via the EFP due to a "technical failure", the filer may file a motion with the Board showing good cause for the transmission failure. Upon receipt of such a motion, the Board may order that the petition for appeal or supporting evidence be considered transmitted as of the date and time of the failed or delayed transmission. For purposes of this subsection, a "technical failure" shall be defined as an unanticipated outage of the EFP, or a malfunction of the EFP's hardware, software, or telecommunication equipment. The malfunction of any of the filer's equipment which results in a failed or delayed transmission shall not be considered a "technical failure"
