On 06/18/2025, the Appellant submits their request that PTAB issue a subpoena to the Adams County Supervisor of Assessments to appear and testify at the hearings for the above matters as follows:

- The taxpayer's appeals are based on a lack of uniformity in the basis for the assessment as well as the resulting assessment of similarly situated properties.

- The appeals included documentation confirming the subject properties were not owner-occupied, and therefore not subject to the rollover provisions applicable to owner-occupied residences.
- The dismissals were based on clerical errors that resulted in the omission of specific evidence from the submission packets by the checklist deadline.
- Upon discovery of the errors, the appellants are prepared to correct the deficiencies. They are prepared to submit the complete evidence, including:
 - Lists of documents, e.g., certified assessment values, taxpayer briefs, and comparable property analysis.

- The error was procedural, not substantive, and the appellants have acted in good faith and with diligence to rectify the issues.
- Reinstating the appeals would allow PTAB to consider the merits of the case and ensure equitable review.
- The appellants request that the PTAB vacate the dismissal orders, reinstate, and accept the corrected and complete evidence packets for consideration of the above appeals.
