Relevant Facts

- 04/08/2025–The appellant files the appeal requesting an extension of time to file its evidence.
- 05/08/2025–PTAB grants the appellant a 90-day extension until 08/06/2025 to submit evidence or request an additional extension.
- 08/04/2025–The appellant submits its evidence.
- 08/14/2025–PTAB notifies Grundy County Board of Review (CBOR) of the appeal and provides a due date of 11/12/2025 to submit evidence or a written request for an extension of time.
- 11/18/2025–PTAB finds Grundy CBOR in default for not submitting any evidence in the appeal. Grundy CBOR contacts PTAB to inquire how to rescind the default.

- 11/24/2025–Grundy CBOR notifies taxing districts of the appeal.
- 12/01/2025–Grundy CBOR submits a request to rescind the default, together with a copy of the evidence sought to be filed and the certificate of service on taxing districts.

County's Motion

On 12/01/2025, Grundy CBOR submits a request to rescind the default as follows:

- Grundy CBOR contends it discovered a file for this appeal on 11/18/2025, after the deadline to submit evidence or seek an extension had already expired on 11/12/2025. Grundy CBOR confirms receipt of the notice of default dated 11/18/2025.
- Grundy CBOR explained that the Supervisor of Assessments resigned in August with only two weeks' notice and left no one trained to do the work. Grundy CBOR further explained that one new employee started in August, a consultant began in September, and the Deputy Supervisor of Assessments is still seeking the necessary certification to assume the Supervisor of Assessments role.
- Grundy CBOR requests that PTAB rescind the default and allow it to submit the evidence enclosed with the request, consisting of the Board of Review Notes on Appeal, assessment printouts, a brief, and CoStar sheets and information for four comparable sales.
