Relevant Facts

- 05/14/2025 – The intervenor files its Request to Intervene, identifying Joel R. DeTella, of Petrarca, Gleason, Boyle & Izzo, LLC, as its counsel. The intervenor’s filing includes a copy of a Resolution Authorizing Participation in

Tax Proceedings adopted on November 15, 2021, which authorizes the law firm, Petrarca, Gleason, Boyle & Izzo, LLC, to file intervention petitions with PTAB upon the direction of the intervenor's board or its administration for the 2017 tax year and succeeding years. Section 5 of the resolution provides: "This Resolution shall be in full force and effect upon its adoption and shall remain in effect through December 31, 2023, with regard to initiating any new actions or interventions and until action by this Board to modify or rescind it with regard to all other matters."

- 05/29/2025 – PTAB adds the intervenor as an interested party to the appeal.
- 05/29/2025 – The intervenor submits its evidence.

Appellant's Motion

On 10/17/2025, the appellant submits a Motion to Dismiss intervenor, seeking to dismiss the intervenor as a party to this appeal on the basis that the intervenor's counsel lacked valid authority to file the Request to Intervene on the intervenor's behalf, and contending as follows:

- Section 1910.60(d)(2) of the PTAB's rules requires a taxing district to submit a valid resolution from its governing body authorizing its counsel to file the Request to Intervene on its behalf.
- The resolution filed by the intervenor with its Request to Intervene did not satisfy the requirements of Section 1910.60(d)(2). The resolution was effective only until December 31, 2023, and was not effective on the date the Request to Intervene was filed (05/14/2025).
- The intervenor's counsel filed the Request to Intervene more than 16 months after the resolution's authority expired and did not submit any documentation to show that the resolution's authority was modified or extended.
- The intervenor's counsel lacked authority under the resolution to file an intervention after December 31, 2023, and consequently, the intervenor has not complied with the requirements of Section 1910.60(d)(2).
- Accordingly, the appellant requests that the intervenor be dismissed as a party and that any arguments, filings, and evidence submitted by the intervenor be stricken.
- Alternatively, if the motion is denied, the appellant requests an extension of time to file a rebuttal.

Intervenor's Response

On 10/31/2025, the intervenor submits its Intervenor's Response to Coral Equity's Motion to Dismiss Intervenor, contending as follows:

- Its governing board duly and lawfully passed the intervenor's resolution and authorized its counsel to file interventions on its behalf for the tax year 2017 and succeeding tax years.
- To eliminate any doubt regarding counsel's authority to file this intervention, the intervenor adopted an updated resolution on August 25, 2025, containing the same authorization for tax year 2023 and succeeding tax years.
- The updated resolution was attached as Exhibit 1 to the Response. Section 5 of the updated resolution provides: "This Resolution shall be in full force and effect upon its adoption and shall remain in effect until action by this Board to modify or rescind it."
- Section 1910.60(d)(2) does not have any requirements regarding the date of adoption of a resolution.
- The intervenor's counsel has represented the intervenor in PTAB appeals for many years.
- Section 4 of the originally submitted resolution includes a savings clause that provides that if any provision is held invalid, the invalidity of that provision shall not affect the other provisions of the resolution. The intervenor argues that Section 4 permits counsel to file interventions under the resolution without giving effect to the expiration clause.
- A technicality should not bar this intervention in accordance with the principles of informal procedures before the PTAB under Section 16-180 of the Property Tax Code and Section 1910.92 of the PTAB's rules.
- The intervenor requests that the motion be denied based on the submitted resolution and its updated resolution attached as Exhibit 1.

The Doctrine of Nondelegability and 105 ILCS 5/10-2

On December 9, 2025, the PTAB asked the parties to brief an additional issue. The question presented was, "May a taxing district issue a blanket resolution delegating its authority to intervene in PTAB matters to a law firm, or must a school board approve each intervention by case-specific resolution?" The PTAB highlighted relevant authority as a starting point. The parties were given a deadline of January 23, 2026, to submit briefs. The appellant and intervenor availed themselves of this opportunity and each submitted a brief.

Appellant's Brief:

- The intervenor did not satisfy the requirements of Section 1910.60(d)(2) & (e)(1) of the PTAB's rules.

- Under the plain language of Section 1910.60(e)(1), “the” means an authorization of the specific document precluding the use of a pre-existing resolution, and “properly adopted” means substantive validity under applicable law, including the nondelegability doctrine and Section 10-2 of the School Code.
 - A valid, current resolution authorizing each intervention is required.
- A resolution that has expired by its own terms is void and cannot authorize litigation or be retroactively applied to an already filed Request to Intervene.
 - An expired resolution is no longer in effect.
 - The resolution requirement serves the purposes of accountability, deliberation, and administrative clarity. A blanket resolution defeats these purposes.
 - This requirement is not burdensome, as many taxing districts regularly authorize intervention, allowing multiple appeals to be considered together or authorizing intervention for certain appeals for the entire general assessment cycle.
- The resolution is facially deficient because it purports to delegate open-ended intervention authority to counsel instead of reflecting a case-specific decision of its board.
 - Under the nondelegability doctrine, a school board may not delegate its discretionary duties and responsibilities to others, citing *Stroh* and *Prairie State Coll.* Litigation authority belongs to the board alone, citing to *Boiko* (an unpublished case).
 - The nondelegability doctrine ensures decisions affecting public policy, public funds, and public education are made by the elected governing board.
- A generic or blanket delegation does not constitute a “properly adopted” resolution under the PTAB’s rules and undermines both the nondelegability doctrine and the PTAB’s procedural rules.
 - The record does not show who made the decision to file the intervention, resulting in a lack of transparency.
 - Section 10-2 of the School Code vests in the board the authority to sue and be sued and does not vest this authority in its administrators, employees, or counsel.
 - A power that is exclusively vested in the board cannot be delegated. Unauthorized acts of government entities cannot be rendered valid by repetition or acquiescence (citing Illinois municipal law cases).
- Section 1910.60(e)(1) allows the intervenor to correct a filing that lacks a resolution by submitting a resolution within 60 days.

- This 60-day period differs from the 30-day period granted to appellants to cure defects in their petitions under Section 1910.30(k).
- The intervenor should not be allowed to submit a resolution after the 60-day period has expired.
- Conclusion
 - The intervenor lacked valid authorization to file a Request to Intervene at the time of filing, and its Request to Intervene is invalid and unauthorized.
 - Coral Equity requests dismissal of the intervenor as a party and that all arguments, filings, or evidence from the intervenor be stricken.

Intervenor's Brief:

- The resolution does not delegate authority and merely authorizes the law firm to act as the intervenor's legal representative when directed by the board or administration. The resolution is limited in scope to property tax matters filed in specific forums and limited by tax year.
- Section 1910.70(c) of the PTAB's rules requires that a taxing body be represented by an attorney at all stages before the PTAB.
 - Authorization of counsel is mandatory, and cannot simultaneously be deemed improper delegation.
 - Requiring case-specific resolutions violates the Property Tax Code's mandate for informal PTAB procedures.
- Section 10-20 of the School Code gives school boards broad discretionary powers.
 - Boards may exercise "all other powers" not inconsistent with the School Code.
 - Resolutions authorizing intervention are within this discretion because protecting tax revenue is essential to school operation and funding. PTAB should not substitute its judgment for a school board's discretionary decision.
- Current PTAB rules and long-standing practices do not require case-specific resolutions.
 - Rule 1910.60(e) only requires a resolution authorizing the legal representative and not one for each case.
 - The PTAB has historically accepted general authorizing resolutions and recently affirmed this in other matters.
 - Changing that interpretation retroactively would be unlawful, an abrupt departure from established practice, and an ultra vires act.
- Case-specific resolutions would be impractical and contrary to statutory intent.
 - Some districts receive hundreds of PTAB notices per tax year.

- Boards typically meet monthly and cannot adopt dozens of resolutions each meeting.
- Such a requirement contradicts statutory emphasis on informal, efficient PTAB procedures.
- Taxing bodies have an obligation to protect their legal and revenue interests in appeals, which are mostly filed by taxpayers.
 - Illinois courts have recognized taxing bodies' interests in the outcome of assessment challenges.
 - Barriers to intervention are contrary to public policy and legislative intent.
- Unequal treatment and due process concerns.
 - PTAB provides taxpayers with an "Incomplete Appeal Checklist" to cure filing defects, but does not extend similar opportunities to taxing districts regarding intervention filings.
 - This creates a two-tiered system that treats similarly situated parties unequally, violating equal protection principles.
- Taxing districts have a legally recognized, direct financial interest in PTAB appeals.
 - Courts (e.g., *Madison Two Associates*) affirm that taxing districts have a direct, immediate stake in assessment determinations.
 - Imposing new intervention obstacles conflicts with strong public policy favoring their participation.
- PTAB cited case law does not support limiting intervention.
 - The cases the PTAB referenced are outdated, legally distinguishable, or based on pre-1995 School Code authority.
 - None shows that the resolution improperly delegates authority or is invalid.
 - Intervenor distinguishes cases like *Stroh*, *Prairie State College*, *Proviso Council*, and *Boiko*, demonstrating, according to the intervenor, they do not apply here.
- Conclusion
 - The school board's resolution validly authorizes its attorneys to intervene, complies with PTAB rules, and reflects long-standing practice.
 - Therefore, Coral Equity's motion should be denied.

- 08/07/2025 – PTAB accepts the appeal and notifies Cook County Board of Review (CBOR) of the appeal and provides a due date of 11/05/2025 to submit evidence or a written request for an extension of time to submit evidence regarding the appeal.
- 10/02/2025 – Cook CBOR submits a request for a 90-day extension.
- 10/07/2025 – PTAB grants Cook CBOR a final 60-day extension to submit evidence.
- 12/31/2025 – Cook CBOR submits a Motion to Dismiss.
- 01/05/2025 – PTAB notifies the appellant of the County’s Motion to Dismiss.

County’s Motion

On 12/31/2025, Cook CBOR submits a Written Request for Dismissal pursuant to 86 Ill. Adm. Code § 1910.40(b) for lack of standing, contending the appellant is neither the owner nor the taxpayer of the subject property.

- The Cook CBOR argues that only a taxpayer or owner of property may file an appeal with PTAB (86 Ill. Admin. Code §1910.10(c)).
- The Cook CBOR contends the named appellant, Webster Square Homes, is not registered with the Illinois Secretary of State as a business entity, as shown by a Secretary of State search on 12/31/2025 for “webster square” (resulting in no

entity called Webster Square Homes and depicting Webster Square Single Family Homes, LLC as involuntarily dissolved).

- The Cook CBOR argues the named appellant does not own the subject property, presenting copies of deeds depicting transfers of the subject parcels to other entities on 12/14/2022 or 12/22/2022.
- The Cook CBOR submitted copies of deeds to evidence subsequent transfers of the subject parcels (other than -052) on 05/02/2024 or 09/06/2024, which direct that subsequent tax bills be mailed to the grantee or another entity (none of which are Webster Square SFH LLC).
- The CBOR further argues that the named appellant is not the taxpayer of the subject property, presenting copies of 2024 second installment tax bills, which were mailed to Webster Square SFH LLC (parcels -044 and -050), “Sarah D Butty & Beth B” (parcel -045), 545 W Grant LLC (parcel -046), HMS Property Group (parcel -047), Grant PI 248 LLC (parcel -051), and Geneva Webster LLC (parcel -052).
- The Cook CBOR submitted copies of other PTAB decisions, dismissing appeals for lack of standing.

Appellant’s Response

On 01/21/2026, the appellant filed a response to the motion, contending as follows:

- The appellant argues Section 1910.40(b) of PTAB’s rules provides only for an objection to jurisdiction, which the appellant contends differs from standing as jurisdiction may not be waived.
- The appellant argues PTAB has jurisdiction over this appeal under Section 16-160 of the Property Tax Code.
- The appellant acknowledges that only a taxpayer or owner of property has standing to file an appeal with PTAB under Section 16-160 of the Property Tax Code and Section 1910.10(c) of PTAB’s rules.
- The appellant argues the named appellant is the taxpayer of the subject property, as shown by copies of the 2022 second installment and the 2023 first installment tax bills mailed to Webster Square SFH LLC (for all parcels other than -052, which were mailed to Geneva Webster LLC). The appellant asserts these bills have due dates that bracket the assessment date.
- The appellant further contends it is overly formalistic to require the appellant to file as Webster Square SFH, LLC (with SFH short for Single Family Homes), when Webster Square Homes is the same in form and use.
- The appellant distinguishes the prior PTAB decisions presented by the Cook CBOR.

- The appellant asserts the Cook CBOR did not challenge the appellant’s name in the board of review proceeding.
- The appellant requests denial of the motion.
- Alternatively, the appellant asks that PTAB find the use of Webster Square Homes to be a technical defect and allow the appellant’s name to be amended under Section 1910.31(a) of PTAB’s rules.

On 02/13/2026, the appellant submits a Motion to Reconsider the Decision and Withdraw the Appeal in each appeal, contending as follows:

- The subject property is within a township with triennial taxes for tax years 2022 to 2024.
- The appellant filed an appeal for the 2022 tax year (Docket No. 22-33211.001-R-1) seeking a reduction in the subject's assessment from \$40,999 to \$38,733.
- The appellant subsequently filed these appeals for the 2023 and 2024 tax years, seeking reductions to \$35,245.
- PTAB issued a decision for the 2022 tax year on 08/19/2025, reducing the subject's assessment to \$38,733, after the appellant had filed appeals for 2023 and 2024.
- The appellant argues that the 2023 and 2024 tax year appeals contain substantially different evidence from the 2022 tax year appeal, based on which the appellant requested lower assessments than in 2022.
- The appellant would have withdrawn the 2023 and 2024 tax year appeals if the appellant had known the Rollover Statute would apply.
- The appellant requests that PTAB reconsider its decisions, allow the 2023 and 2024 tax year appeals to be withdrawn, and certify the assessed values at \$37,843 (the assessment placed on the subject property by the CBOR).

- 11/25/2025 – PTAB issues a final administrative decision consistent with the parties' stipulated assessed value.

Appellant's Motions

On 02/09/2026, the appellant filed a Motion to Substitute to substitute Douglas J. LaSota as counsel. On behalf of the appellant, Attorney LaSota also filed a Motion to Reopen or Reinstate Case and for the Illinois Property Tax Appeal Board to Reissue and Re-Serve its Decision, contending as follows:

- The appellant contends a copy of the final administrative decision was sent to Attorney Shifflett's personal email address, wilvaine1@gmail.com, rather than to either of the email addresses designated in the petition or the entry of appearance.
- On information and belief, the appellant contends that PTAB's 02/08/2024 notice was also emailed to counsel's personal email address.

- The appellant argues PTAB mistakenly used Attorney Shifflett's personal email address, which had previously been used by Attorney Shifflett in an appeal concerning his personal residence in PTAB Docket No. 19-25148.
- The appellant states that in mid-January 2026, Attorney Shifflett checked the status of the appeal, learned a decision had been issued, and found the decision in his personal email.
- On 02/09/2026, the appellant filed direct appeals for the 2023 and 2024 tax years pursuant to Section 16-185 of the Property Tax Code.
- The appellant argues that Section 16-185 of the Property Tax Code provides for the designation of an email address in the pleadings for service of the final administrative decision and further provides that decisions and electronic correspondence will be sent to the individual designated by a party, subject to change, addition, or removal during the proceedings. The appellant further argues that PTAB's rules allow a decision to be made available to a party electronically and the decision is deemed to have been served when sent electronically to the email address provided in the pleadings, citing to Sections 1910.5(b)(13) & (14) and 1910.90(1)(1)(2) & (m).
- The appellant asserts that PTAB does not have a specific procedure for designating an email address for electronic correspondence.
- The appellant requests that the appeal be reopened so the decision can be re-served on the appellant's new counsel, Attorney LaSota, and the appellant may timely file direct appeals for the 2023 and 2024 tax years.

PTAB's Record History

PTAB's IT Department has advised that Attorney Shifflett was first added to the PTAB's database as an attorney on 03/28/2019, based on an Entry of Appearance in Docket No. 16-21798.001-R-1, which identified the email address, wilvaine1@gmail.com, as counsel's email address. PTAB was never notified of a change in Attorney Shifflett's email address. This appeal was initially filed by a pro se appellant and Attorney Shifflett was added to the appeal as counsel after it was accepted by PTAB. Additionally, Attorney Shifflett has not filed an appeal with PTAB using the e-filing portal, which would have automatically updated counsel's email address within PTAB's system.
