- 01/19/2026-The appellant files a petition and evidence, including an appraisal.
- 02/05/2026-PTAB accepts the appeal and notifies the BoR of the appeal with a due date of May 6, 2026, to submit evidence or request an extension of time to submit evidence.

BoR’s Request

On 04/10/2026, the BoR files a Request for Issuance of Subpoena Duces Tecum, contending as follows:

- The BoR seeks the production of the following documents from the appellant: current lease(s) on the subject property, including signed, unsigned, and proposed leases and other documents relating to proposed leases currently being negotiated; and appraisals, valuations, statements of value, and loan

applications for the subject property in the prior 3 years that are not currently in the record, including those relating to financing obtained from First Farmer’s Bank & Trust on 09/30/2024.

- The BoR argues that the requested documents reflect the subject's market value and support the subject's assessment.
- The BoR contends that a written request for the documents from the Vermilion County Supervisor of Assessments was delivered by U.S. Mail and by email to the appellant. However, the appellant has not responded to the request.
- The Request is supported by an Affidavit of Nathan A. Bryan, Vermilion County Supervisor of Assessments, stating the subpoena is “reasonably required to obtain information that cannot be obtained elsewhere by the exercise of due diligence or through requests for information, and is necessary to obtain information essential to derive an estimate of value of the real property under appeal.”
- A copy of the Request for Subpoena Duces Tecum was sent by U.S. Mail and by email to the appellant’s counsel on 04/10/2026.

Relevant Facts

- 04/09/2026-The appellants file a petition and request an extension of time to submit evidence. The petition identifies Nuclear Fuel Holding Co., Inc., % Ryan LLC, a/k/a GE-Hitachi Morris Operation, as the owner or taxpayer of the subject property, and the appellants' submission includes a certificate of service of the petition on the registered agent of the owner or taxpayer by Federal Express and by U.S. Mail on 04/09/2026.
- 04/30/2026-PTAB grants the appellants an extension of time to submit evidence with a due date of 06/29/2026.

Appellants' Motion

On 04/20/2026, the appellants submitted a Motion for Stay of Proceedings, contending as follows:

- This appeal concerns a unique property, the only licensed commercial away-from-reactor independent spent fuel storage installation in the country, and concerns complex issues.
- There are four prior tax year appeals filed by the same appellants pending before the PTAB for the subject (21-05709, 22-02867, 23-04107, and 24-03131).
- The 2021 and 2022 tax year appeals are scheduled for a consolidated hearing from June 8, 2026, to June 18, 2026. These appeals involve legal issues that may be appealed after the issuance of the PTAB's final administrative decisions.
- Resolution of the 2021 and 2022 tax year appeals would significantly streamline the evidence and hearings of the subsequent tax year appeals. The appellants filed similar motions to stay in the 2023 and 2024 tax year appeals, which were previously granted by the Board.
- The appellants request a stay of this appeal, to expire 90 days following a final resolution of the 2021 and 2022 tax year appeals, through settlement, final PTAB administrative decisions, or a final order of a court on appeal.
