- 06/08/2022-DuPage County BoR submits a proposed stipulation.
- 07/12/2022-PTAB notifies the above intervenors of DuPage County BoR’s proposed stipulation and provides a deadline of 08/11/2022 to respond that the proposed stipulation is not acceptable.

- 07/21/2022-PTAB notifies the appellant of DuPage County BoR's proposed stipulation and provides a deadline of 08/20/2022 to respond that the proposed stipulation is not acceptable.
- 08/11/2022-The intervenors accept DuPage County BoR's proposed stipulation.
- 02/21/2023-PTAB issued a final administrative decision in accordance with the proposed stipulation accepted by the intervenors. The appellant did not respond to the PTAB regarding the proposed stipulation by the established deadline.

Appellant's Motion

On 05/07/2026, the appellant submitted a Motion to Vacate PTAB Decision, as follows:

- A final administrative decision was issued on the proposed stipulation because the appellant did not timely respond.
- The appellant states the appellant did not timely respond due to the death of the appellant's grandparents in October and December 2021 and the resulting need for the appellant to care for the grandparents' daughter, who has Down syndrome.
- The appellant purchased the property in August 2021 for a price substantially less than the value reflected by the assessment.
- The appellant asks that the decision be vacated so the appeal can be decided on its merits.

- 05/12/2026-The Cook County BoR submits a signed stipulation dated to the PTAB, together with a Settlement Agreement between the appellant and the intervenor. The signed stipulation is dated 2/24/2026.
- The stipulation and settlement agreement are signed by the Appellant's attorney of record.
- The Settlement Agreement provides for the settlement of this appeal and further provides it is contingent upon and only becomes effective upon the Cook County BoR's approval.

Court Appointed Receiver's Motion

On 05/14/2026, a court appointed receiver for the subject property submitted a Motion to Strike Stipulation Filed 05/12/2026 from the Record, contending as follows:

- Matthew D. Mason, of Hilco Real Estate, LLC, was appointed as receiver on 04/26/2026 by the U. S. District Court Northern District of Illinois in *Wells Fargo Bank, N.A. as Trustee v. 181 West Madison Property LLC*, Case Number 1:26-cv-03416.
- The Order Appointing Receiver entered on 04/26/2026 is attached to the motion. Section 9(b) of the Order grants the receiver "the power to operate and manage the Property, and the ongoing business on the Property." Section

9(t) of the Order gives the receiver the ability to “appeal any past, present, or future assessments by the taxing authorities.”

- The stipulation filed on 05/12/2026 was submitted without the approval or knowledge of the receiver, who is the sole operator of the subject property pursuant to the Order, including controlling the direction of all past, present, and future tax appeals.
- The receiver requests the PTAB strike the stipulation from the record in this appeal.

1910.63 of the PTAB’s rules and/or the appellant failed to fully comply with Sections 1910.30(k) and 1910.69(a) of the Board’s rules, and the PTAB dismisses the appeal.

- 02/27/2026-The appellant files the appeal petition and requests an extension of time to submit its evidence.
- 03/12/2026-PTAB grants the appellant an extension of time to submit evidence with a due date of 06/10/2026.

Appellant's Motion

On 03/27/2026, the appellant filed a Motion to Stay Proceedings, contending as follows:

- The PTAB has discretion to grant further extensions of time to submit evidence “for good cause shown” 86 Ill. Adm. Code § 1910.30. In addition, the PTAB’s rules direct the PTAB to conduct each hearing “in a manner best calculated to conform to substantial justice.”
- Appeals for the subject property for tax years 2022 (22-02863), 2023 (23-03721), and 2024 (24-00341) are pending before the PTAB.
- A consolidated hearing of the 2022 and 2023 tax year appeals was conducted from 02/09/2026 to 02/13/2026 and post-hearing briefs were due in April 2026.
- The PTAB granted the parties’ request to stay the proceeding in the 2024 tax year appeal at its June 10, 2025 meeting.
- The outcome of the 2022 and 2023 tax year appeals will affect the 2025 tax year appeal and will impact the evidence for this appeal and it would be more efficient to conclude the 2022 and 2023 tax year appeals before proceeding with this appeal.
- Accordingly, good cause exists to extend indefinitely, or stay, the evidence filing deadlines in the 2025 appeal until 60 days after resolution of the 2022 and 2023 tax year appeals.
- The appellant requests PTAB stay this proceeding until 60 days after the tax years 2022 and 2023 tax year appeals are resolved.
