

PROPERTY TAX APPEAL BOARD'S DECISION

APPELLANT: John Johnson

The parties of record before the Property Tax Appeal Board are John Johnson, the appellant, by attorney Joseph G. Kusper with the law firm of Storino, Ramello & Durkin in Rosemont, and the Cook County Board of Review.

The subject property consists of a 19-year-old, one and one-half story, single-family dwelling of masonry construction containing 3,196 square feet of living area and located in Lyons Township, Cook County. Features of the home include three and one-half bathrooms, a partial-unfinished basement, air-conditioning, two fireplaces and a three-car attached garage.

The appellant, through counsel, submitted evidence before the Property Tax Appeal Board arguing unequal treatment in the assessment process of the improvement as the basis of the appeal. In support of this claim, the appellant submitted assessment data and descriptive information on three properties suggested as comparable to the subject. The appellant also submitted a two-page brief, photographs and Cook County Assessor's Internet Database sheets for the subject and the suggested comparables and a copy of the board of review's decision. Based on the appellant's documents, the three suggested comparables offered by the appellant consist of one-story or two-story, seven or forty-three year old, single-family dwellings of masonry or stucco construction located within several blocks of the subject. The improvements range in size from 3,194 to 6,433 square feet of living area. The comparables contain three or four and one-half bathrooms, an unfinished basement, air-conditioning, one or three fireplaces and a two-car or three-car attached garage. The improvement assessments range from \$11.09 to \$13.79 per square

foot of living area. Based on the evidence submitted, the appellant requested a reduction in the subject's improvement assessment.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the subject's total assessment of \$76,098. The subject's improvement assessment is \$50,825 or \$15.90 per square foot of living area. In support of the assessment the board submitted property characteristic printouts and descriptive data on four properties suggested as comparable to the subject. The suggested comparables are improved with one and one-half story, single-family dwellings of frame or frame and masonry construction located within eight blocks of the subject. The improvements range in size from 1,854 to 4,798 square feet of living area and range in age from 17 to 77 years. The comparables contain from one and one-half to four full bathrooms, a finished or unfinished basement, one or two fireplaces and a two-car or three-car garage. Three comparables contain air-conditioning. The improvement assessments range from \$15.96 to \$18.48 per square foot of living area. Based on the evidence presented, the board of review requested confirmation of the subject's assessment.

After reviewing the record and considering the evidence, the Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of this appeal. The appellant's argument was unequal treatment in the assessment process. The Illinois Supreme Court has held that taxpayers who object to an assessment on the basis of lack of uniformity bear the burden of proving the disparity of assessment valuations by clear and convincing evidence. Kankakee County Board of Review V. Property Tax Appeal Board, 131 Ill.2d 1 (1989). The evidence must demonstrate a consistent pattern of assessment inequities within the assessment jurisdiction. After an analysis of the assessment data, the Board finds the appellant has not overcome this burden.

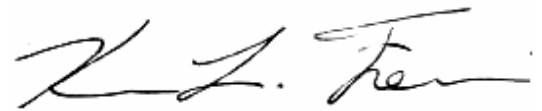
Both parties submitted a total of seven properties as suggested comparables to the subject but with many variations in living area, age and/or construction. These seven properties have improvement assessments ranging from \$11.09 to \$18.48 per square foot of living area. The subject's per square foot improvement assessment of \$15.90 falls within the range established by these properties. The Board finds of the seven properties offered for comparison by the parties, six vary substantially from the subject in living area, three vary significantly in age and six vary in type of construction. After considering adjustments and the differences in both parties' suggested comparables when compared to the subject, the Board finds the evidence submitted by both parties does not support a change in the subject's current assessment.

As a result of this analysis, the Property Tax Appeal Board finds the appellant has failed to adequately demonstrate that the subject dwelling was inequitably assessed by clear and convincing evidence and a reduction is not warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
