

PROPERTY TAX APPEAL BOARD'S DECISION

APPELLANT: Brien O'Brien

The parties of record before the Property Tax Appeal Board (PTAB) are Brien O'Brien, the appellant, by attorney Edward P. Larkin of Park Ridge, and the Cook County Board of Review (board).

The subject property consists of a seven-year-old, three-story, single-family dwelling of masonry construction containing 5,025 square feet of living area and located in North Township, Cook County. Features of the residence include four and one-half bathrooms, a full-finished basement, air-conditioning, two fireplaces and a two-car attached garage.

The appellant, through counsel, appeared before the PTAB arguing unequal treatment in the assessment process of the improvement as the basis of the appeal. In support of this claim, the appellant submitted assessment data and descriptive information on three properties suggested as comparable to the subject. The appellant also submitted a three-page brief, property characteristic printouts for the subject and the suggested comparables as well as a copy of the board of review's decision. Based on the appellant's documents, the three suggested comparables consist of three-story, single-family dwellings of masonry construction with the same neighborhood code as the subject. The improvements range in size from 5,346 to 7,448 square feet of living area. Comparable two is ten years old and comparables one and three are renovated properties. The comparables contain from three and one-half to six full bathrooms, a full-finished or unfinished basement, air-conditioning and multiple fireplaces. Two comparables contain a two-car or four-car garage. The improvement assessments range from \$23.95 to \$30.09 per square foot of living area.

At hearing, the appellant's attorney indicated that the improvement assessments of the appellant's three comparables were

reduced by the board of review. Based on the evidence submitted, the appellant requested a reduction in the subject's improvement assessment.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the subject's total assessment of \$216,182. The subject's improvement assessment is \$197,510 or \$39.31 per square foot of living area. In support of the assessment, the board submitted property characteristic printouts and descriptive data on three properties suggested as comparable to the subject. The comparables consist of three-story, four or five-year-old, single-family dwellings of masonry construction with the same neighborhood code as the subject. The improvements range in size from 4,169 to 5,261 square feet of living area. The comparables contain from four to six full bathrooms, a full-finished or unfinished basement, air-conditioning, one or three fireplaces and a two-car garage. The improvement assessments range from \$40.40 to \$53.51 per square foot of living area.

At hearing, the board's representative indicated that the board of review would rest on the written evidence submissions. Based on the evidence presented, the board of review requested confirmation of the subject's assessment.

After hearing the testimony and considering the evidence, the Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of this appeal. The appellant's argument was unequal treatment in the assessment process. The Illinois Supreme Court has held that taxpayers who object to an assessment on the basis of lack of uniformity bear the burden of proving the disparity of assessment valuations by clear and convincing evidence. Kankakee County Board of Review V. Property Tax Appeal Board, 131 Ill.2d 1 (1989). The evidence must demonstrate a consistent pattern of assessment inequities within the assessment jurisdiction. After an analysis of the assessment data, the PTAB finds the appellant has not overcome this burden.

The PTAB finds the appellant's comparable three and the board of review's comparables one and three to be the most similar properties to the subject in the record. These three properties are similar to the subject in improvement size, amenities, age and location and have improvement assessments ranging from \$27.46 to \$53.51 per square foot of living area. The subject's per square foot improvement assessment of \$39.31 falls within the range established by these properties. The Board finds the remaining comparables less similar to the subject in improvement size. After considering adjustments and the differences in both parties' suggested comparables when compared to the subject, the PTAB finds the subject's per square foot improvement assessment is supported by the most similar properties contained in the record.

As a result of this analysis, the PTAB finds the appellant has failed to adequately demonstrate that the subject dwelling was

inequitably assessed by clear and convincing evidence and a reduction is not warranted.

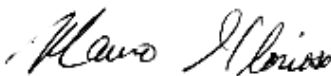

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
