## PROPERTY TAX APPEAL BOARD'S DECISION

APPELLANT: Vince & Nicole Pesch DOCKET NO.: 05-23277.001-R-1 PARCEL NO.: 14-20-207-005-0000

The parties of record before the Property Tax Appeal Board (PTAB) are Vince & Nicole Pesch, the appellants, by attorneys Leslie Hedges and Joseph Huang with the Law Offices of Terrence Kennedy, Jr. in Chicago, and the Cook County Board of Review (board).

The subject property consists of a 108-year-old, three-story, multi-family dwelling of masonry construction containing 3,810 square feet of living area and located in Lake View Township, Cook County. Features of the building include three full bathrooms, a full-unfinished basement, air-conditioning and a three-car detached garage.

The appellants, through counsel, appeared before the PTAB arquing unequal treatment in the assessment process of the improvement as the basis of the appeal. In support of this claim, the appellants submitted assessment data and descriptive information on six properties suggested as comparable to the subject. The appellants also submitted a one-page brief, photographs and Cook County Assessor's Internet Database sheets for the subject and the suggested comparables and a copy of the board of review's decision. Based on the appellants' documents, the six suggested comparables consist of two-story or three-story, multi-family dwellings of masonry construction located within 0.6 miles of the subject. Three comparables are located on the same street as the subject. The improvements range in size from 3,771 to 4,309 square feet of living area and range in age from 95 to 115 years. The comparables contain two, three or four full bathrooms. One comparable contains a full-finished basement apartment and five comparables have a full-unfinished basement. Two comparables contain a two-car garage. The improvement assessments range from \$11.87 to \$14.94 per square foot of living area. The appellants' evidence disclosed that the subject sold in April 2003 for a price of \$875,000. Based on the evidence submitted, the

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds  $\underline{a\ reduction}$  in the assessment of the property as established by the  $\underline{Cook}$  County Board of Review is warranted. The correct assessed valuation of the property is:

appellants requested a reduction in the subject's improvement assessment.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the subject's total assessment of \$73,520. The subject's improvement assessment is \$64,870 or \$17.03 per square foot of living area. In addition, the board submitted the subject's property characteristic printouts and copies of documentation from the board of review level complaint file. The board's evidence disclosed that the subject sold in April 2003 for a price of \$875,000.

At hearing, the board's representative indicated that the board of review would rest on the written evidence submissions. Based on the evidence presented, the board of review requested confirmation of the subject's assessment.

After hearing the testimony and considering the evidence, the Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of this appeal. The appellants' argument was unequal treatment in the assessment process. The Illinois Supreme Court has held that taxpayers who object to an assessment on the basis of lack of uniformity bear the burden of proving the disparity of assessment valuations by clear and convincing evidence. Kankakee County Board of Review V. Property Tax Appeal Board, 131 Ill.2d 1 (1989). The evidence must demonstrate a consistent pattern of assessment inequities within the assessment jurisdiction. After an analysis of the assessment data, the Board finds the appellants have overcome this burden.

The PTAB finds the appellants' comparables one, two and four to be the most similar properties to the subject in the record. These three properties are similar to the subject in improvement size, exterior construction and age. In addition, two of the comparables are located on the same street as the subject. The three comparables have improvement assessments ranging from \$13.12 to \$14.94 per square foot of living area. The subject's per square foot improvement assessment of \$17.03 falls above the range established by these properties. The remaining comparables are accorded less weight because they differ from the subject in improvement size. After considering adjustments and the differences in the appellants' suggested comparables when compared to the subject, the Board finds the subject's per square foot improvement assessment is not supported by the most similar properties contained in the record.

As a result of this analysis, the PTAB finds the appellants have adequately demonstrated that the subject dwelling was inequitably assessed by clear and convincing evidence and a reduction is warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing

complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
