

PROPERTY TAX APPEAL BOARD'S DECISION

APPELLANT: David Keenan

The parties of record before the Property Tax Appeal Board are David Keenan, the appellant, by attorney Mitchell L. Klein of Schiller, Klein & McElroy, P.C., Chicago, and the Cook County Board of Review.

The subject property consists of an 87-year-old, two-story, single-family dwelling of stucco construction containing 4,800 square feet of living area and located in New Trier Township, Cook County. Features of the residence include four and one-half bathrooms, a full-unfinished basement and a fireplace.

The appellant, through counsel, submitted evidence before the Property Tax Appeal Board arguing unequal treatment in the assessment process of the improvement as the basis of the appeal. In support of this claim, the appellant submitted assessment data and descriptive information on three properties suggested as comparable to the subject. The appellant also submitted a one-page brief, photographs of the subject and the suggested comparables as well as a copy of the board of review's decision. Based on the appellant's documents, the three suggested comparables consist of two-story, single-family dwellings of masonry or frame and masonry construction with the same neighborhood code as the subject. The improvements range in size from 4,103 to 4,688 square feet of living area and range in age from 69 to 101 years. The comparables contain two and one-half or four full bathrooms, a partial or full-unfinished basement and a multi-car garage. One comparable has air-conditioning and one comparable has a fireplace. The improvement assessments range from \$13.60 to \$17.99 per square foot of living area. Based on the evidence submitted, the appellant requested a reduction in the subject's improvement assessment.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds no change in the assessment of the property as established by the Cook County Board of Review is warranted. The correct assessed valuation of the property is:

LAND:	\$ 48,331
IMPR.:	\$ 95,917
TOTAL:	\$ 144,248

Subject only to the State multiplier as applicable.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the subject's total assessment of \$144,248. The subject's improvement assessment is \$95,917 or \$19.98 per square foot of living area. In support of the assessment the board submitted property characteristic printouts and descriptive data on three properties suggested as comparable to the subject. The suggested comparables are improved with two-story, 94 or 95-year-old, single-family dwellings of stucco construction with the same neighborhood code as the subject. The improvements range in size from 3,870 to 4,358 square feet of living area. The comparables contain three, three and one-half or four full bathrooms, a full-finished or unfinished basement and a fireplace. One comparable has air-conditioning and two comparables contain a two-car detached garage. The improvement assessments range from \$20.26 to \$20.50 per square foot of living area. The board's evidence disclosed that the subject sold in September 2004 for a price of \$1,450,000. Based on the evidence presented, the board of review requested confirmation of the subject's assessment.

After reviewing the record and considering the evidence, the Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of this appeal. The appellant's argument was unequal treatment in the assessment process. The Illinois Supreme Court has held that taxpayers who object to an assessment on the basis of lack of uniformity bear the burden of proving the disparity of assessment valuations by clear and convincing evidence. Kankakee County Board of Review V. Property Tax Appeal Board, 131 Ill.2d 1 (1989). The evidence must demonstrate a consistent pattern of assessment inequities within the assessment jurisdiction. After an analysis of the assessment data, the Board finds the appellant has not overcome this burden.

The Board finds the board of review's comparables to be the most similar properties to the subject in the record. These three properties are similar overall to the subject in improvement size, location, amenities, exterior construction and age and have improvement assessments ranging from \$20.26 to \$20.50 per square foot of living area. The subject's per square foot improvement assessment of \$19.98 falls below the range established by these properties. The Board finds the appellant's comparables less similar to the subject in exterior construction and/or age. After considering adjustments and the differences in both parties' suggested comparables when compared to the subject, the Board finds the subject's per square foot improvement assessment is supported by the most similar properties contained in the record.

As a result of this analysis, the Property Tax Appeal Board finds the appellant has failed to adequately demonstrate that the subject dwelling was inequitably assessed by clear and convincing evidence and a reduction is not warranted.

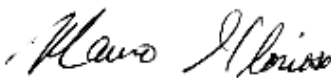

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the

session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
