



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Peter G. Crofton

The parties of record before the Property Tax Appeal Board are Peter G. Crofton, the appellant(s), by attorney Joseph G. Kusper, of Storino Ramello & Durkin of Rosemont; and the Cook County Board of Review.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds no change in the assessment of the property as established by the Cook County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$ 17,052
IMPR.: \$ 68,079
TOTAL: \$ 85,131

Subject only to the State multiplier as applicable.

ANALYSIS

The subject property consists of a 14,700 square foot parcel improved with a 49-year-old, two-story, single-family dwelling of stucco construction containing 3,311 square feet of living area and located in Lyons Township, Cook County. Features of the residence include two full bathrooms, two half-baths, a partial-unfinished basement, central air-conditioning, a fireplace and a two-car attached garage.

The appellant, through counsel, submitted evidence before the Property Tax Appeal Board arguing unequal treatment in the assessment process of the improvement as the basis of the appeal. In support of this claim, the appellant submitted assessment data and descriptive information on three properties suggested as comparable to the subject. Based on the appellant's documents, the three suggested comparables consist of two-story, single-family dwellings of stucco, frame or frame and masonry

construction located within several blocks of the subject. The improvements range in size from 2,593 to 5,104 square feet of living area and range in age from 10 to 49 years. The comparables contain from two to four and one-half bathrooms, central air-conditioning and a multi-car attached garage. One comparable contains a full-unfinished basement and two comparables have fireplaces. The improvement assessments range from \$14.17 to \$16.93 per square foot of living area. Based on the evidence submitted, the appellant requested a reduction in the subject's improvement assessment.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the subject's total assessment of \$85,131. The subject's improvement assessment is \$68,079 or \$20.56 per square foot of living area. In support of the assessment the board submitted property characteristic printouts and descriptive data on four properties suggested as comparable to the subject. The suggested comparables are improved with two-story, single-family dwellings of masonry or frame and masonry construction located within two blocks of the subject. Three comparables are located on the same street as the subject. The improvements range in size from 2,694 to 3,172 square feet of living area and range in age from 27 to 42 years. The comparables contain two and one-half or three and one-half bathrooms, a partial or full-unfinished basement, central air-conditioning, a fireplace and a two-car garage. The improvement assessments range from \$20.74 to \$22.94 per square foot of living area. Based on the evidence presented, the board of review requested confirmation of the subject's assessment.

After reviewing the record and considering the evidence, the Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of this appeal. The appellant's argument was unequal treatment in the assessment process. The Illinois Supreme Court has held that taxpayers who object to an assessment on the basis of lack of uniformity bear the burden of proving the disparity of assessment valuations by clear and convincing evidence. Kankakee County Board of Review V. Property Tax Appeal Board, 131 Ill.2d 1 (1989). The evidence must demonstrate a consistent pattern of assessment inequities within the assessment jurisdiction. After an analysis of the assessment data, the Board finds the appellant has not overcome this burden.

The Board finds the board of review's comparables one, three and four to be the most similar properties to the subject in the record. These three properties are similar to the subject in improvement size, amenities, age and design. In addition, they are located on the same street and block as the subject and have improvement assessments ranging from \$20.74 to \$22.94 per square foot of living area. The subject's per square foot improvement assessment of \$20.56 falls below the range established by these properties. The Board finds the remaining comparables less similar to the subject in improvement size, age, amenities and/or

location and accorded less weight. After considering adjustments and the differences in both parties' comparables when compared to the subject, the Board finds the subject's improvement assessment is equitable and a reduction in the subject's assessment is not warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.



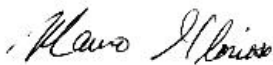

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
