The parties of record before the Property Tax Appeal Board (hereinafter PTAB) are B. J. Coyote's Grill, Inc., the appellant, by Attorney Liat R. Meisler with the law firm of Golan & Christie LLP in Chicago; and the Cook County Board of Review.

Prior to the hearing, the parties reached an agreement as to the correct assessment of the subject property. This assessment agreement was presented to and considered by the PTAB.





Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal
