

PROPERTY TAX APPEAL BOARD'S DECISION

The parties of record before the Property Tax Appeal Board (PTAB) are Jim Naum, the appellant, by attorney Lisa A. Marino of Marino and Associates of Chicago and the Cook County Board of Review (board).

The subject property consists of a 36-year-old, two-story single-family dwelling of frame and masonry construction containing 2,757 square feet of living area and located in Northfield Township, Cook County. The residence contains two and one-half bathrooms, a partial basement, air conditioning, a fireplace and a two-car garage.

The property in this appeal was the subject of an appeal before the PTAB for prior years under Docket Nos. **04-24389.001-R-1 & 05-24281.001-R-1**. In those appeals, the PTAB reached a decision based upon equity and the weight of the evidence in the record as presented by the parties to the appeal. Pursuant to the Official Rules of the Property Tax Appeal Board, evidence from both parties in support of their respective opinions of the subject's market value as of the assessment date or equity of the assessment was requested.

After reviewing the record and considering the evidence, the Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of this appeal. The Property Tax Appeal Board finds from its analysis of the record that the evidence in this appeal is substantially the same as that of the prior years. Since no new evidence was presented to warrant a change from the previous years' decisions, the Board finds that the assessment as established in the prior years' appeal is appropriate.

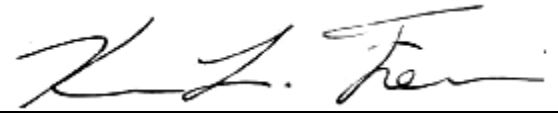

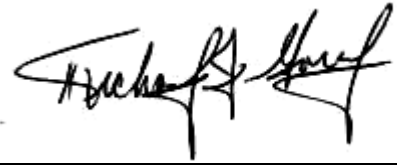

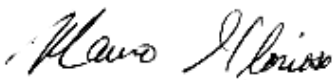

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the

subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
