

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Sanford Kahn

The parties of record before the Property Tax Appeal Board are Sanford Kahn, the appellant(s), by attorney Jerrold H. Mayster, of Mayster & Chaimson Ltd in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds <u>no change</u> in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$11,564 **IMPR.:** \$46,665 **TOTAL:** \$58,229

Subject only to the State multiplier as applicable.

ANALYSIS

The subject property consists of a 3,250 square foot parcel of land improved with a 98-year old, two-story, masonry, multifamily dwelling containing 2,288 square feet of living area, two baths, two fireplaces, and a full, unfinished basement. The appellant argued unequal treatment in the assessment process as the basis of this appeal.

In support of the equity argument, the appellant, via counsel, submitted descriptions and assessment information on a total of four properties suggested as comparable and located the within several blocks of the subject. The properties are described as two-story, frame or masonry, multi-family dwellings with two or three baths, a full basement with two finished, and, for one property, two fireplaces. The properties range: in age from 96 to 118 years; in size from 2,125 to 3,288 square feet of living area; and in improvement assessments from \$16.51 to \$17.89 per square foot of living area. The appellant also submitted a copy of the Sidwell maps for the subject and the suggested

comparables. Based on this evidence, the appellant requested a reduction in the subject's improvement assessment.

The board of review submitted its "Board of Review Notes on Appeal" wherein the subject's improvement assessment of \$46,665 or \$20.40 per square foot of living area was disclosed. In support of the subject's assessment, the board of review presented descriptions and assessment information on a total of four properties suggested as comparable and located within a quarter-mile of the subject. The properties are described as two-story, masonry, multi-family dwellings with two or two and one-half baths, and a full basement with one finished. The properties range: in age from 98 to 101 years; in size from 2,282 to 2,784 square feet of living area; and in improvement assessment from \$20.76 to \$24.11 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject's assessment.

After reviewing the record and considering the evidence, the Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of this appeal.

The appellant contends unequal treatment in the subject's improvement assessment as the basis of the appeal. Taxpayers who object to an assessment on the basis of lack of uniformity bear the burden of proving the disparity of assessment valuations by clear and convincing evidence. Kankakee County Board of Review v. Property Tax Appeal Board, 131 Ill.2d 1 (1989). After an analysis of the assessment data, the PTAB finds the appellant has not met this burden.

The parties submitted a total of eight properties suggested as comparable to the subject. The PTAB finds the board of review's comparables most similar to the subject in size, age, construction, and design. Due to their similarities to the subject, these comparables received the most weight in the PTAB's analysis. The properties are masonry, two-story, multi-family dwellings located within several blocks of the subject. The properties range: in age from 98 to 101 years; in size from 2,282 to 2,784 square feet of living area; and in improvement assessment from \$20.76 to \$24.11 per square foot of living area. In comparison, the subject's improvement assessment of \$20.40 per square foot of living area is below the range of these comparables. The remaining comparables were given less weight due to discrepancies in construction and/or size. After considering adjustments and the differences in both parties' comparables when compared to the subject, the Board finds the subject's per square foot improvement assessment is supported and a reduction in the subject's assessment is not warranted.

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing

complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
