

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Irene Lampricht, the appellant, by attorney Terrence Kennedy Jr., of Law Offices of Terrence Kennedy Jr. in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds no change in the assessment of the property as established by the Cook County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$ 7,308 **IMPR.:** \$ 34,548 **TOTAL:** \$ 41,856

Subject only to the State multiplier as applicable.

ANALYSIS

The subject property is improved with a two-story multi-family dwelling of frame construction containing 2,520 square feet of living area. The dwelling is 105 years old. Features of the home include a partial, finished basement, central air conditioning and a two-car garage.

The appellant's appeal is based on unequal treatment in the assessment process. In support of this argument, the appellant submitted information on four comparable properties that were described as one and one-half or two-story dwellings of frame or masonry construction. They range in age from 83 to 108 years old. The comparable dwellings range in size from 2,438 to 2,844 square feet of living area. Two comparables have a full or partial basement, one of which is finished, and the others have a concrete slab foundation. Three comparables have a one or two-car garage. The comparables have improvement assessments ranging from \$6.80 to \$13.26 per square foot of living area. The subject's improvement assessment is \$13.71 per square foot of living area. Based on this evidence, the appellant requested a reduction in the subject's improvement assessment.

The board of review submitted its "Board of Review Notes on Appeal" wherein the subject's final assessment was disclosed. The board of review presented descriptions and assessment information on three comparable properties consisting of two-story frame dwellings that range in age from 103 to 113 years old. The dwellings range in size from 2,194 to 2,452 square feet of living area. The comparables have full basements, two of which are finished and a two-car garage. These properties have improvement assessments ranging from \$13.86 to \$15.32 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject's assessment.

After reviewing the record and considering the evidence, the Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of this appeal. The Board further finds a reduction in the subject's assessment is not warranted.

The appellant contends unequal treatment in the subject's improvement assessment as the basis of the appeal. Taxpayers who object to an assessment on the basis of lack of uniformity bear the burden of proving the disparity of assessment valuations by clear and convincing evidence. <u>Kankakee County Board of Review v. Property Tax Appeal Board</u>, 131 Ill.2d 1 (1989). After an analysis of the assessment data, the Board finds the appellant has not met this burden.

The Board finds the appellant's comparable one differed from the subject in design and comparables three and four differed from the subject in foundation. Thus, these comparables received reduced weight in the Board's analysis. The appellant's comparable two and the board of review's comparables were similar to the subject in design, size and foundation. They were also similar to the subject in other features. Due to their similarities to the subject, these comparables received the most weight in the Board's analysis. The comparables had improvement assessments ranging from \$12.00 to \$15.32 per square foot of living area. The subject's improvement assessment of \$13.71 per square foot of living area is within the range established by the most similar comparables. After considering adjustments and the differences in both parties' comparables when compared to the subject, the Board finds the subject's improvement assessment is equitable and a reduction in the subject's assessment is not warranted.

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing Docket No: 06-28222.001-R-1

complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.
