

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Woo Gap Kim

The parties of record before the Property Tax Appeal Board are Woo Gap Kim, the appellant(s), by attorney Glenn S. Guttman, of Rieff Schramm Kanter & Guttman in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds <u>a reduction</u> in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$ 6,406 **IMPR.:** \$ 59,047 **TOTAL:** \$ 65,453

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2008 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a two-story dwelling of masonry construction with 4,183 square feet of living area per the board of review's evidence. The dwelling was constructed in 2006. Features of the home include a full basement, central air conditioning, two fireplaces, and a two-car garage. The property has a 10,010 square foot site and is located in Palatine, Palatine Township, Cook County.

The appellant contends assessment inequity as the basis of the appeal. In support of this argument, the appellant submitted information on six equity comparables. In addition, the appellant requested that the subject's size be reduced to 3,437 square feet of living area and be re-classified as a 2-78. In support, the appellant submitted a copy of the building record card, floor plan, and an affidavit by Kang Architects certifying the subject's size is 3,437 square feet of living area.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$68,649. The subject property has an improvement assessment of \$62,243 or \$14.88 per square foot of living area. In support of its contention of the correct assessment, the board of review submitted information on three equity comparables.

Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant met this burden of proof and a reduction in the subject's assessment is warranted.

The Board finds that the appellant submitted sufficient evidence to establish that the subject property contains 3,147 square feet of living area and thus, was incorrectly classified as a 2-08 property under the Cook County Real Property Assessment Classification Ordinance. According to the Assessor, a class 2-78 property is defined as a "two or more story residence, up to 62 years of age, 2,001 to 3,800 square feet." Per the evidence and affidavit submitted, the Board finds that subject contains 3,147 square feet of living area. The definition of a class 2-78 property accurately describes the subject, as the subject contains 3,147 square feet of living area.

The Board finds the best evidence of assessment equity to be appellant's comparables #4, #5, and #6 and the board of review comparable #2 and #3. These comparables had improvement assessments that ranged from \$16.85 to \$17.51 per square foot of living area. The subject's improvement assessment of \$18.11 per square foot of living area based on 3,437 square feet of living area falls above the range established by the best comparables in this record. Based on this record the Board finds the appellant did demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is justified.

complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
