

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: James R. Klemme DOCKET NO.: 09-20406.001-R-1 PARCEL NO.: 12-11-208-008-0000

The parties of record before the Property Tax Appeal Board are James R. Klemme, the appellant(s), by attorney Edward P. Larkin, of Edward P. Larkin, Attorney at Law in Des Plaines; and the Cook County Board of Review.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds <u>no change</u> in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

> LAND: \$5,582 IMPR.: \$31,279 TOTAL: \$36,861

Subject only to the State multiplier as applicable.

# Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2009 tax year. The Property Tax Appeal Board (the "Board") finds that it has jurisdiction over the parties and the subject matter of the appeal.

# Findings of Fact

The subject consists of a one-story dwelling of masonry construction with 1,421 square feet of living area. The dwelling is 50 years old. Features of the home include a full unfinished basement, central air conditioning, and a two-car garage. The property has a 8,533 square foot site, and is located in Park Ridge, Norwood Park Township, Cook County. The subject is classified as a class 2-03 property under the Cook County Real Property Assessment Classification Ordinance. Docket No: 09-20406.001-R-1

The appellant contends assessment inequity as the basis of the appeal. In support of this argument, the appellant submitted information on three equity comparables.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$36,861. The subject property has an improvement assessment of \$31,279, or \$24.62 per square foot of living area.

In support of its contention of the correct assessment, the board of review submitted information on four equity comparables.

In rebuttal, the appellant, apparently relying on the Court's holding in <u>Hoyne Sav. and Loan Ass'n v. Hare</u>, 60 Ill.2d 84 (1974), argued that the board of review reduced to the subject's assessment to \$30,194 for tax year 2011.

### Conclusion of Law

The Board gives no weight to the appellant's contention of law, raised in rebuttal, referencing <u>Hoyne</u>. In <u>Moroney & Co. v.</u> <u>Property Tax Appeal Board</u>, 2013 IL App (1st) 120493, the Court stated that the appellant's reliance on <u>Hoyne</u> "for the proposition that subsequent actions by assessing officials are fertile grounds to demonstrate a mistake in a prior year's assessments" was misplaced. <u>Moroney</u>, 2013 IL App (1st), ¶ 46. In <u>Moroney</u>, the Court wrote in pertinent part:

[I]n each of those unique cases [Hoyne and 400 Condominium Ass'n v. Tully, 79 Ill.App.3d 686 (1979)], which are confined to their facts, there were glaring errors in the tax assessments-in Hoyne, the assessment was increased on a property from \$9,510 to \$246,810 in one year even though no changes or improvements to the property had occurred (Hoyne, 60 Ill.2d at 89), and in 400 Condominium, assessments on a garage were assessed separately from the adjoining condominium in violation of the Condominium Property Act (400 Condominium, 79 Here, based upon the evidence Ill.App.3d at 691). that was submitted, there is no evidence that there calculation of was an error in the the 2005 Rather, the record shows that the 2005 assessment. assessment was properly calculated based on the market value of the property.

Id. The Board finds the appellant presented no credible evidence showing there were unusual circumstances present in this 2009 appeal relative to the establishment of the subject's assessment for tax year 2011. Therefore, the Board finds that the appellant's Hoyne argument is without merit.

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The Board finds the best evidence of assessment equity to be appellant's comparables #1 and #3 and board of review comparables #1, #2, #3, and #4. These comparables had improvement assessments that ranged from \$20.28 to \$27.88 per square foot of living area. The subject's assessment of \$24.62 per square foot of living area falls within the range established by the best comparables in this record. Based on this record, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed, and a reduction in the subject's assessment is not justified. This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.

Section 16-185 of the Property Tax Code provides in part:

Docket No: 09-20406.001-R-1

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
