

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Fernando Izaguirre DOCKET NO.: 09-21852.001-R-1 PARCEL NO.: 16-19-410-009-0000

The parties of record before the Property Tax Appeal Board are Fernando Izaguirre, the appellant(s), by attorney Brian P. Liston, of Law Offices of Liston & Tsantilis, P.C. in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds <u>no change</u> in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$ 3,685 **IMPR.:** \$ 26,484 **TOTAL:** \$ 30,169

Subject only to the State multiplier as applicable.

### Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2009 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

## Findings of Fact

The subject property consists of a two-story dwelling of masonry construction with 3,096 square feet of living area. The dwelling is 82 years old. Features of the home include a full basement and a two-car garage. The property has a 3,780 square foot site and is located in Berwyn Township, Cook County. The subject is classified as a class 2-11 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends overvaluation as the basis of the appeal. In support of this argument the appellant submitted information on six comparable sales, none of which are located in the subject's neighborhood.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$30,169. The subject's assessment reflects a market value of \$338,978 or \$109.49 per square foot of living area, including land, when applying the 2009 three year median level of assessment for class 2 property of 8.90% as determined by the Illinois Department of Revenue.

In support of its contention of the correct assessment the board of review submitted information on four suggested equity comparables, which sales data was submitted on two comparable sales located in the subject's neighborhood.

#### Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The Board finds the best evidence of market value to be the appellant's comparable #4 and the board of review's comparable sales #3 and #4. These sales occurred from August 2006 to August 2009 and sold from \$38,000 to \$402,000, or \$15.20 to \$131.54 per square foot of living area. The current assessed valuation is within the range established by these comparables. Based on this evidence the Board finds a reduction in the subject's assessment is not justified.
