

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Mohammed Motan DOCKET NO.: 09-22978.001-C-1 PARCEL NO.: 28-34-217-032-0000

The parties of record before the Property Tax Appeal Board are Mohammed Motan, the appellant(s), by attorney Arnold G. Siegel, of Siegel & Callahan, P.C. in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds <u>a reduction</u> in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND:	\$ 11,550
IMPR.:	\$ 0
TOTAL:	\$ 11,550

Subject only to the State multiplier as applicable.

## Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2009 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

## Findings of Fact

The subject property consists of a vacant commercial parcel of land on a 47,250 square foot site and is located in Country Club Hills, Bremen Township, Cook County.

The appellant's appeal is based on overvaluation. In support of this argument the appellant submitted evidence disclosing the subject property was purchased on November 10, 2008 for a price of \$115,500. In support of the sale price, the appellant submitted the settlement statement, warranty deed, and real estate contract. Based on this evidence, the appellant requested a reduction in the subject's assessment to reflect the purchase price.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$28,350. The subject's assessment reflects a market value of \$283,500 or \$6.00 per square foot of land area when using the 2009 level of assessment for class 1 properties of 10% as determined by the Cook County Classification Ordinance.

In support of its contention of the correct assessment, the board of review submitted a copy of the deed and PTAX-203 Illinois Real Estate Transfer Declaration confirming 2008 sale. The board of review requested a reduction of the land unit price to \$2.44 or an assessed value of \$11.529.

## Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist appraisal of the subject property, a recent of an sale, comparable sales or construction costs. 86 Ill.Admin.Code The Board finds the appellant met this burden of §1910.65(c). proof and a reduction in the subject's assessment is warranted.

The Board finds the best evidence of market value to be the purchase of the subject property in November 2008, for a price of \$115,500. The appellant provided evidence demonstrating the sale had the elements of an arm's length transaction. The appellant in support of the transaction, submitted a copy of the real estate contract, settlement statement, and warranty deed. The Board finds the purchase price is below the market value reflected by the assessment. The Board finds the board of review did not present any evidence to challenge the arm's length nature of the transaction or to refute the contention that the purchase price was reflective of market value. Based on this record, the Board finds the subject property had a market value of \$115,500 as of January 1, 2009. Since market value has been determined the 2009 three level of assessment for class 1 properties 10% as determined by Cook County Classification Ordinance shall apply. 86 Ill.Admin.Code §1910.50(c)(1). This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.
