

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Citizens Financial Services

The parties of record before the Property Tax Appeal Board are Citizens Financial Services, the appellant, by attorney William I. Sandrick, of Sandrick Law Firm LLC in South Holland; and the Cook County Board of Review.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds <u>no change</u> in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$ 3,685 **IMPR.:** \$ 23,093 **TOTAL:** \$ 26,778

Subject only to the State multiplier as applicable.

# Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2009 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

## Findings of Fact

The subject consists of a two-story multi-family rental dwelling of masonry construction with 2,538 square feet of living area. The dwelling is 81 years old. Features of the home include a

full finished basement and a two-car garage. The property has a 3,770 square foot site, and is located in Berwyn, Berwyn Township, Cook County. The subject is classified as a class 2-11 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends overvaluation as the basis of the appeal. In support of this argument the appellant submitted an appraisal estimating the subject property had a market value of \$170,000 as of August 21, 2009.

Under the sales comparison approach, the appraiser analyzed three suggested comparable properties. The properties ranged: in square footage of living area from 2,426 to 3,008 square feet; in age from 81 to 83 years; and in unadjusted price per square foot from \$60.51 to \$77.49 per square foot, including land. Comparables #1 and #2 were judicial sales, while comparable #3 was identified as a foreclosure sale. The appraiser included one pending foreclosure sale as further support of the market value opinion. The appraiser failed to make adjustments for conditions of sale. The appraiser valued the subject under the sales comparison approach at \$170,000 as of August 21, 2009, yet noted it was listed for sale on April 14, 2009 for \$269,900.

The board of review submitted its "Board of Review-Notes on Appeal" disclosing the total assessment for the subject of \$26,778. The subject's assessment reflects a market value of \$300,876, or \$118.55 per square foot of living area, including land, when applying the 2009 three year median level of assessment under the Cook County Real Property Assessment Classification Ordinance of 8.9% as determined by the Illinois Department of Revenue.

In support of its contention of the correct assessment, the board of review submitted information on four equity comparables.

#### Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code

 $\S1910.65(c)$ . The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The Board does not find the appraisal conclusion submitted by the appellant to be persuasive as the appraiser failed to make any adjustments for conditions of sale or location. However, the appellant's unadjusted sales comparables ranged in sale price from \$60.51 to \$77.49 per square foot, including land. The subject's assessment reflects a market value of \$118.55 per square foot of living area, including land, which is above the range of the best comparables. However, after considering adjustments and the differences in the comparables when compared to the subject, specifically for conditions of sale, the Board finds the subject's per square foot assessment is supported and a reduction in the subject's assessment is not warranted. The Board also notes that the subject property was listed for sale on April 14, 2009 for \$269,900.

Accordingly, in determining the fair market value of the subject property, the Board finds that the appellant failed to submit sufficient evidence to show the subject was overvalued. Therefore, the Board finds that the appellant has not met its burden by a preponderance of the evidence and that the subject does not warrant a reduction based upon the market data submitted into evidence.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.

#### IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.
