

## FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Witold Kania DOCKET NO.: 09-26840.001-R-1 PARCEL NO.: 16-23-416-040-0000

The parties of record before the Property Tax Appeal Board are Witold Kania, the appellant(s), by attorney Scott Shudnow, of Shudnow & Shudnow, Ltd. in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds <u>a reduction</u> in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND:	\$4,305
IMPR.:	\$1,569
TOTAL:	\$5,874

Subject only to the State multiplier as applicable.

## Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2009 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

# Findings of Fact

The subject property consists of a 3,075 square foot parcel of land improved with a four-year old, three-story, masonry, multifamily dwelling containing 3,537 square feet of building area. The property is located in West Chicago Township, Cook County. Docket No: 09-26840.001-R-1

The subject is classified as a class 2-11 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant's appeal is based on overvaluation. In support of this argument the appellant submitted evidence disclosing the subject property was purchased in November 2009 for a price of \$66,000. The appellant included colored photographs on the subject. The photographs show the subject is need of significant repair. The appellant acknowledges the subject was purchased as part of a foreclosure proceeding.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$31,257. The subject's assessment reflects a market value of \$351,202 using the Illinois Department of Revenue's 2009 threeyear median level of assessment for class 2 property of 8.90%.

In support of its contention of the correct assessment the board of review submitted evidence on three equity comparables with sales information on two comparables which sold from \$90,000 to \$475,000.

#### Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c).

The Board finds the best evidence of market value to be the sale of the subject in November 2009 for \$66,000. The Board finds the subject's condition supports this sale. Therefore, the Board finds the subject had a market value of \$66,000. Since the market value of this parcel has been established, the 2009 Illinois Department of Revenue three-year median level of assessment for Class 2 property of 8.90% will apply and a reduction is warranted. This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.

Section 16-185 of the Property Tax Code provides in part:

Docket No: 09-26840.001-R-1

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.
