

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Nancy Zadek Cohrs DOCKET NO.: 09-27264.001-R-1 PARCEL NO.: 05-08-302-017-0000

The parties of record before the Property Tax Appeal Board are Nancy Zadek Cohrs, the appellant(s), by attorney Donald T. Rubin, of Rubin & Norris in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds <u>a reduction</u> in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$ 61,310 **IMPR.:** \$ 107,790 **TOTAL:** \$ 169,100

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2009 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of two improvements. Improvement #1 is a two-story dwelling with 4,508 square feet of living area of masonry construction. It was constructed in 1924. Features of the home include a full finished basement, central conditioning and a fireplace. The property has a 39,555 square foot site and is located in New Trier Township, Cook County. The subject is owner-occupied and is classified as a class 2-06 property under the Cook County Real Property Assessment Classification Ordinance. story, 1,113 square foot, four-car garage with a large recreation room, exercise area, and bath located on the second floor. Improvement #2 is classified as a class 2-03 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends overvaluation as the basis of the appeal. In support of this argument the appellant submitted an appraisal estimating the subject property had a market value of \$1,900,000 as of January 1, 2009. The appraisal's valuation includes both of the subject improvements. The Board notes that the appraiser adjusted the comparables upward by \$50,000 to account for subject Improvement #2.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for Improvement #1 of \$159,518. This assessment reflects a market value of \$1,792,337 when applying the 2009 three year average median level of assessment for class 2 property under the Cook County Real Property Assessment Classification Ordinance of 8.90% as determined by the Illinois Department of Revenue. Improvement #2's assessment of \$30,977 reflects a market value of \$348,056 when applying the 2009 three year average median level of assessment for class 2 property under the Cook County Real Property Assessment Classification Ordinance of 8.90% as determined by the Illinois Department of Revenue.

In support of its contention of the correct assessment the board of review submitted descriptions and assessment information for three properties suggested as comparable to Improvement #1. The board of review also submitted descriptions and assessment information for three properties suggested as comparable to Improvement #2.

Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant met this burden of proof and a reduction in the subject's assessment is warranted.

The Board finds the best evidence of market value to be the appraisal submitted by the appellant. The subject's assessment reflects a market value above the best evidence of market value in the record. The Board finds the subject property had a market value of \$1,900,000 as of the assessment date at issue. Since market value has been established the 2009 three year average median level of assessment for class 2 property of 8.90% as determined by the Illinois Department of Revenue shall apply. (86 Ill.Admin.Code \$1910.50(c)(2)).

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing

complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
