

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Sandra Shelley, the appellant, by attorney Edward P. Larkin, of Edward P. Larkin, Attorney at Law in Des Plaines; and the Cook County Board of Review.

Based on the facts and exhibits presented, the Property Tax Appeal Board hereby finds <u>no change</u> in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$ 5,280 **IMPR.:** \$ 52,589 **TOTAL:** \$ 57,869

Subject only to the State multiplier as applicable.

#### Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2009 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

### Findings of Fact

The subject property is 43 years old, and consists of a two-story dwelling of frame and masonry construction containing 5,143 square feet of living area. Features of the home include a full basement. The subject property has a 10,560 square foot

site, is located in Proviso Township, Cook County and is classified as a Class 2 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity and a contention of law as the bases of the appeal. The appellant did not submit equity comparables. However, the appellant did append to its petition a legal brief and a print-out from the Cook County Assessor website with 2011 assessment data. The appellant argued that the decisions in <a href="Hoyne Savings & Loan Association v.Hare">Hoyne Savings & Loan Association v.Hare</a>, 60 Ill.2d 84, 322 N.E.2d 833 (1974) and <a href="The 400">The 400</a> Condominium Association, et al., v. <a href="Tully">Tully</a>, 79 Ill.App.3d 686, 398 N.E.2d 951 (1st Dist. 1979), require that the assessment of \$57,869 for 2009 must be reduced to the assessment of \$40,401 set by the board of review for 2011.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$57,869. The subject property has an improvement assessment of \$52,589 or \$10.23 per square foot of living area. In support of its contention of the correct assessment the board of review submitted information on four suggested equity comparables. It also appended to its Notes on Appeal a legal brief, wherein it argued that the appellant's reliance on  $\underline{\text{Hoyne}}$  and  $\underline{\text{400}}$  Condominium is unfounded.

The appellant argued in its rebuttal brief that  $\underline{\text{Hoyne}}$  does not limit a reduction in one year to a prior general triennial assessment period or any single prior year.

## Conclusion of Law

The taxpayer contends assessment inequity and a contention of law as the bases of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The Board finds that there is no merit to the appellant's argument that  $\underline{\text{Hoyne}}$  and  $\underline{400}$  Condominium stand for the proposition that an assessment reduction in a subsequent year requires an assessment reduction in the tax year at issue absent a glaring error in calculation. The Supreme Court in  $\underline{\text{Hoyne}}$  observed that that case presented unusual circumstances coupled with a grossly excessive assessment increase from \$9,510 in 1970 to \$246,810 in 1971. Consequently, it remanded the case for the lower court to ascertain the correct assessed valuation.  $\underline{\text{Hoyne}}$ , 60 Ill.2d at 89-90, 322 N.E.2d at 836-37.

The Appellate Court in the recent case of Moroney v. Illinois Property Tax Appeal Board, 2013 Ill.App. (1st) 120493, 2 N.E. 3d 552, distinguished Hoyne and 400 Condonimium as confined to their unique facts. The Court rejected that appellant's argument that those prior cases stood for the proposition that "subsequent actions by assessing officials are fertile grounds to demonstrate a mistake in prior year's assessments." Moroney, 2013 Ill.App. 120493 at ¶46, 2 N.E.3d at 530. There was no evidence in Moroney that there was any error in the calculation of the taxpayer's 2005 assessment. Moreover, as the Appellate Court observed, "just because factors warranting a reduction existed in 2006, does not mean they existed in 2005, or any other year for that matter (which is why property taxes are assessed every year)." Id.

Based on this record the Board finds that the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed. The Board further finds that the subject's assessment is supported by the board of review's comparables. Therefore, the Board holds that a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code.

#### IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for the subsequent year directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
